## **106. Transformation of Safeguarding: Children's Services Response to the Ofsted Announced Inspection of Safeguarding and Looked After Children's Services**

106.1 The Board received Report SCP/56/10 setting out Children's response to the Ofsted announced inspection of safeguarding and looked after children services. The report highlighted Ofsted's conclusions for Safeguarding and Looked after Children and quoted sections of the report. The Board noted that Children's Services had immediately revised their existing Action Plan in order to fully respond to all of the recommendations in the Inspection Report, which was set out at Appendix 2 to SCP/56/10.

106.2 Carol advised the Board that Elizabeth Raikes, Councillor Tolchard and herself had met with three officials from DfE to discuss the outcome of the inspection and the measures which the Council would be subject to. Carol explained that this statutory intervention ranged from being issued with a notice to improve to a dedicated intervention team working within the social care teams. It was expected that the Council would receive its notification within the next couple of weeks.

## **107. Review of Children's Trust Arrangements: Responses and Next Steps.**

- 107.1 The Board received Report SCP/57/10 which explained that since the recent changes in Government, a number of changes to statutory partnership arrangements had happened. It was noted that the requirement to have a Children's Trust Board was to be removed as well as the duty to produce a children and young people's plan, together with the duty for schools to co-operate in Children's Trust arrangements. The Report set out the nine results of review questionnaire sent to 60 professionals, comprising members of Trust Boards and Partnership Forum.
- 107.2 The findings from this review would be put forward to the Torbay Strategic Partnership to enable them to plan for effective partnerships across Torbay and to make sure that partnership resources are targeted most effectively where they are needed.
