Decision

 - (a) agree terms and complete an assignment of the Agreement for Lease of Unit 2 Riviera Park to the Primary Care Trust or a surrender of the Agreement for Lease of Unit 2, Riviera Park to the proposed landlord; and
 - (b) agree terms and enter into any required agreement with the proposed landlord of Unit 2, Riviera Park to enable the above assignment to proceed or surrender that agreement so that the landlord can lease Unit 2, Riviera Park direct to the Primary Care Trust; and
- (ii) That the Director of Law and Support, in consultation with the Director of Finance, be given authority to agree terms and complete a lease for Unit 3, Riviera Park, for a term of 20 years.

Reason for Decision

To resolve the accommodation needs of the proposed Torbay Care NHS Trust for its headquarters and office accommodation. To provide an alternative location for the Decriminalised Parking Enforcement Service at reduced cost with an earlier and more certain date of occupation.
