3. In respect of the loan to Parkwood Leisure, we wish to understand how the investment will be spent or whether it will be used to pay for work already completed? Will it for example be used in respect of the swimming pool, changing rooms and sports hall? Or will it be used for updating the all-weather outside facility to ensure current sports pitches are compliant (e.g. for rugby and hockey)?
