Licensing Act 2003 - underage test purchase of alcohol

On the 12th June 2015, two underage volunteers acting on behalf of Torbay Council Trading Standards visited Off Licence TQ Ltd, 15 Lucius St., Torquay and bought two bottles of cider. They were served by Mr. David Jeffries who did not ask them for any Identification.

As you will know this is a criminal offence under the above named legislation and as the owner of the business you can be held liable whether or not any proceedings are brought against individual staff members.

I would therefore like you to attend a tape-recorded interview at 2.30 p.m. on Wednesday 15th July at the Connections Office, Castle Circus, Torquay. The interview would be conducted in accordance with the Police and Criminal Evidence Act 1984.and a transcript would be included in a report submitted to our legal department for their consideration. From the evidence presented they will decide on the most appropriate action to take.

Please confirm whether or not you wish to attend by contacting me either by email, by return of post or by telephone quoting the above reference number. You may wish to seek legal advice first or alternatively have a legal representative with you at the interview. If you decide not to attend the interview a report will be submitted without the benefit of your comments.

Licensing Act 2003 - sale of alcohol to a person under the age of 18

Without Prejudice

You will recall that on the 12th June 2015 an underage volunteer working on behalf of Torbay Council's Trading Standards Department was served alcohol at Off Licence TQ Ltd, by manager Dave Jeffries. This is a criminal offence of strict liability and as a Director of the company and the holder of the premises licence you are responsible for the actions of your staff and for the promotion of the four licensing objectives.

There are a number of ways in which such matters may be dealt with, including a caution, a criminal prosecution or a review of your premises licence. However in this instance, and after careful consideration, Torbay Council has decided that you be invited to seek a Minor Variation to your Premises Licence by adding the 2 conditions detailed below.

The advantage of applying for a Minor Variation yourself is that the outcome of your application is likely to be more certain, in so much that others will not raise an objection or propose additional conditions or restrictions and there being no subsequent need for a Licensing Committee Hearing.

The proposed conditions are as follows:

1. A company approved by Torbay Council's Trading Standards Department shall be engaged by the Premises Licence Holder to carry out a test purchase of alcohol at Off Licence TQ Ltd on 3 occasions over a period of 12 months. If the Premises fail a test purchase within that 12 month period, the Premises Licence Holder shall engage the services of that company for an additional 12 months to carry out 3 further test purchases. If all 3 test purchases are successful within the first 12 month period, this condition shall cease thereafter.

2. The Premises Licence Holder shall notify Torbay Council's Trading Standards Department of the result of each test purchase within 5 working days of the test purchase taking place.

If Torbay Council does not receive a Minor Variation application to include these conditions by the 11th September 2015, it shall reserve the right to consider what further action will be appropriate to ensure the promotion of the Licensing Objectives are upheld at your premises.

Please note that it is in your best interests and your responsibility to ensure that any staff you employ to sell alcohol are fully trained to deal with customers who appear to be under the legal age to purchase alcohol.

To apply for a minor variation, please go to the Torbay Council website <u>www.torbay.gov.uk</u>. Click 'L' for 'Licensing' followed by 'Alcohol and Entertainment' – 'Premises License and Variation' – 'Minor Variation' – 'Minor Variation to a Premises Licence'.

<u>The Tobacco Products (Manufacture, Presentation and Sale) (Safety) Regulations 2002</u> <u>Consumer Protection Ac t 1987</u>

Licensing Act 2003 section144 - keeping of smuggled goods

On the 20th October I visited Off License TQ acting on information that illegal tobacco was sold at the shop. I spoke to the shop assistant Piotr Dryja and explained the reason for our visit. The shop was searched using a trained sniffer dog who located nine 50g packs of Golden Virginia hand-rolling tobacco and 6 packs of 20 L&M cigarettes in the small room behind the counter. The statutory health warnings were not in English and therefore cannot be legally sold or supplied in the UK. The tobacco, which has an estimated retail value of £330, was subsequently seized pending further investigation.

In addition the keeping of goods imported without payment of duty is also an offence under the above named legislation.

I am therefore inviting you to attend a tape-recorded interview at 2.00 p.m. on Wednesday 3rd December at the Connections Office, Castle Circus, Torquay. The interview would be conducted in accordance with the Police and Criminal Evidence Act 1984.and a transcript would be included in a report submitted to our legal department for their consideration. From the evidence presented they will decide on the most appropriate action to take.

Please confirm whether or not you wish to attend by contacting me either by email, by return of post or by telephone quoting the above reference number. You may wish to seek legal advice first or alternatively have a legal representative with you at the interview. If you decide not to attend the interview a report will be submitted without the benefit of your comments.

I am writing to you following my visit to your premises which took place on the 24th May 2016.

During my visit I discussed the premises licence conditions with you and went through all of the conditions on the premises licence. All of the conditions are being adhered to apart from one which was pointed out to you.

The condition in question is as follows:-

Annexe 2

The Protection of children from harm

4) A register shall be kept up to date, to identify any persons refused alcohol or tobacco.

In relation to the identified breach on your premises licence, I would take this opportunity to remind you that failure to comply with the terms and conditions of a premises licence constitutes an offence under Section 136 of the Licensing Act 2003 and a person found guilty of such an offence is liable to a term of imprisonment not exceeding 6 months, an unlimited fine, or to both.

I have now enclosed a refusals register for completion and any time that a person is refused alcohol or tobacco for being underage, this register should be completed. This can also be used when you refuse street drinkers.

Also during my visit we discussed your proposed variation application and the new condition to be inserted under 'Public Safety' regarding the Regulatory Reform (Fire Safety) Order 2005. It was then identified that your premises has not undertaken a fire risk assessment, however you believed that the regular maintenance of the fire extinguishers by Firewatch covered this. As discussed during my visit, I would recommend that you contact Devon & Somerset Fire & Rescue Service immediately to gain professional advice on what steps need to be undertaken. They can be contacted on 01803 653700.

I have also enclosed a Premises Age Verification Policy which should be signed by all staff working on your premises after watching the No Proof No Sale Video. A copy of this should be kept on the premises for inspecting by the Police or the Local Authority at any time. If you employ new

I am the above named and am a Police Community Support Officer 30688 currently based at Torquay
police station.
This statement is in relation to issues effecting THE GREEK ORTHODOX CHURCH OF SAINT
ANDREW, which I will refer to as 'ST ANDREW'S CHURCH' for the purpose of this statement. ST
ANDREW'S CHURCH is within my beat area of TORRE & UPTON of which I have been patrolling since
JUNE 2015.
ST ANDREW'S CHURCH is a designated public place which prevents the consumption of alcoholic
beverages within its grounds which has been in place for a period of time. Despite this I often receive
complaints from local residents and members of public concerning individuals and groups of people
consuming alcohol within the grounds, some of which have reported been verbally abused upon
challenging the individuals concerned. ST ANDREW'S CHURCH is also affected by individuals using
drugs in the grounds. In addition to litter created by empty alcohol vessels being discarded, drug
paraphernalia is often left behind which presents an issue to the safety of those in the area.
As a result of the above mentioned issues, I find myself regularly in ST ANDREW'S CHURCH either on
patrol or sent to attend in relation to a police log, or a report from a passing member of the public,
primarily concerning persons consuming alcoholic beverages in the grounds of the church. The majority
of incidents are resolved by requesting individuals concerned to dispose of their alcoholic containers and
to leave the area with suitable words of advice being issued. There is however repeat individuals who
have been informed multiple times that the area prohibits the consumption of alcoholic beverages but,
elect to return time and time again to consume alcohol.
I mostly come across individuals consuming what I would refer to as cheap looking, high alcohol content

I mostly come across individuals consuming what I would refer to as cheap looking, high alcohol content percentage cans. Most recently I recall a large can that is black and red in colour possibly with the letter 'K' on, I cannot confirm the brand.

In last the twelve (12) months there has been approximately twenty (20) police logs created due to calls from members of the public regarding concerns related to ST ANDREW'S CHURCH and its vicinity relating to issues as described.

I write to you in your capacity of Premises Licence Holder of the above premises, which has the benefit of Premises Licence Number PL0969 issued by Torbay Council.

The below matter has been brought to my attention:

Following a report of the use of a stolen credit card at your premises, PCSO 30237 Victoria Graham attended your premises on 27, 28 and 29 July 2016 in order to collect CCTV footage in relation to this matter. During one of her visits it was ascertained that your CCTV system does not record to disc and she therefore provided a memory stick to assist your staff. After repeated visits, she requested that the CCTV be burnt off by Sunday 31 July 2016 however when she attended on this date the footage had still not been burnt off and she was advised that the manager was the only person capable of doing so but that she was not working on that date. Throughout this time PCSO Graham was conscious that your CCTV would only retain the footage for a limited period of time and was concerned that the footage may be lost.

On Monday 1 August 2016 Mrs Julie Smart, my Police Licensing Officer, received a report from PCSO Graham outlining the above. As a result of this she attempted to contact your DPS, Miss Iwona Mankowska by telephone and tried 3 different telephone numbers before eventually being able to leave a voice message requesting Iwona to contact her as a matter of urgency.

Shortly after leaving this message, Mrs Smart received 4 missed calls from Iwona and a text message indicating that the CCTV was now ready for collection. Mrs Smart



informs me that the text message was received from telephone number 07889 544725 so she will ensure that she uses this number in the future, unless she is advised by yourself or Miss Mankowska of a more preferable alternative contact number.

In relation to CCTV, condition 1 under the heading the Prevention of Crime and Disorder on your Premises Licence, states:

"CCTV shall be fitted for sale of alcohol; records will be kept for 14 days with free access for police".

As the provision of CCTV is a requirement of your licence I would be grateful if, in the future, you could ensure that any CCTV requested by officers is burnt off at the earliest opportunity, ie within 7 days, and that my officers are contacted and advised when it is ready for collection. This course of action should prevent my officers wasting valuable time in repeatedly attending your premises.

I also request that you obtain a memory stick and keep it at your premises for future use in such circumstances.

You may also wish to consider providing training to another member of staff to ensure that there is always someone on duty who can burn footage off. However, I appreciate that it may be preferable for only one person to have access to this facility and if CCTV is provided within a reasonable time period I do not foresee any issues with this.

To assist you in the provision of CCTV, I have attached a CCTV Request Record sheet that you may find useful.

I am writing to you in your capacity of Premises Licence Holders of the above named premises, which has the benefit of Premises Licence Number PL0969 issued by Torbay Council.

At 11.30 am on Wednesday 5 July 2017 my Police Licensing Officer, Mrs Julie Smart, attended your premises in the company of Mrs Mandy Guy, Senior Licensing Enforcement Officer of Torbay Council. Whilst at the premises they discussed with Miss Iwona Mankowska, your Designated Premises Supervisor, the supply of alcohol to known street drinkers who consume alcohol on the bench at the end of Lucius Street or in St Andrews Church Yard. I can advise you that the police have received 33 calls regarding issues with street drinkers within the church yard since 1 April 2017 and therefore it is important that we try to address this matter.

Miss Mankowska and other members of staff at the premises were adamant that they do not sell alcohol to persons who are drunk, and do all that they possibly can to ensure that your customers do not cause problems by drinking alcohol on the bench.

Whilst in your premises Mrs Smart and Mrs Guy noted that large quantities of beers/ciders/lagers are available for sale in cans and it was obvious that single cans are being sold, with the abv of these ranging from 4.0% up to 7.6%.

Mrs Smart and Mrs Guy carried out an inspection of your premises in accordance with the Premises Licence and they identified that the name of the DPS was not displayed on the window, no refusals book was in place and when questioned regarding the times of deliveries to your premises Miss Mankowska indicated that some deliveries take place at 10.00 pm at the latest.

I would take the opportunity to remind you of the below conditions contained within your Premises Licence:

Annexe 2 Conditions Consistent with the Operating Schedule, General:

1. A sign stating the DPS shall be displayed on the window.

The Prevention of Public Nuisance:

1. All deliveries and disposal shall be carried out in the daytime hours.

The Protection of Children from Harm:

 A register shall be kept up to date, to identify persons refused alcohol or tobacco.

I would also remind you that failing to comply with the conditions of a Premises Licence constitutes an offence under Section 136 of the Licensing Act 2003, and a person found guilty of such an offence is liable to an unlimited fine, 6 months' imprisonment, or to both.

Whilst Mrs Smart and Mrs Guy were listening to Miss Mankowska, Mrs Smart noticed a male wearing a blue top and cap approach the counter with a single can of alcohol. A male member of staff called Pete served this male and Mrs Smart heard Pete say to him "Hi Kev, you are not going to drink that on the bench are you?" The male replied "No I don't drink there now, I have my own special place I go to". The male then left the shop with the can of alcohol.

Shortly after leaving your premises I can advise you that Mrs Smart and Mrs Guy attended St Andrews Church Yard where they noted that the bin immediately inside the entrance contained a large number of empty cans labelled Perla Mocna, with an abv of 7.6%. They also noticed 2 empty cans of Fosters lager situated near a grave stone. Whilst they were stood talking in the grave yard Mrs Smart noticed a male stand up from behind a grave stone. This male was the male wearing the blue T-shirt who had purchased a single can of alcohol from your premises. This male scrunched up a can in his hand and walked out of the church yard and it was apparent that this male had consumed the can of alcohol whilst concealed behind a grave stone.

Photographs taken by Mrs Smart within your premises show that you stock Perla Mocna, which is a Polish brand that is not available in other off licence premises in the Belgrave Road/Lucius Street area.

Mrs Smart advises me that during her discussions with Miss Mankowska she indicated that if she was given the details of the individuals who are causing problems, or their photographs, she would ensure that they are not served in the premises in the future. Unfortunately, having given this matter some consideration, I can advise you that the police cannot provide you with that information as it would breach Data Protection legislation. However, Mrs Smart has informed Miss Mankowska of the above male and I hope that you will now consider taking positive action in respect of this individual by identifying him from your CCTV system.

I would take this opportunity to advise you of paragraph 3.1, b) (viii) within the Torbay Council Licensing Statement of Principles 2016 to 2021 in relation to measures to reduce the risk of crime and disorder caused by street drinkers, or those who are or appear to be alcohol dependent, which states:

... This may be particularly relevant to premises that are permitted to provide sales of alcohol for consumption off the premises, which are located in areas where concerns about street drinkers have been identified by Responsible Authorities or within the area defined in the Cumulative Impact Policy. Such premises may be required not to stock or sell high strengths or types of cheap ciders, beers or lagers or to sell single unit items, ie cans that are split from an original multi pack or other such packaging.

As a result of the above visit, it is apparent that some of the alcohol being consumed by the street drinkers is coming from your premises and in an attempt to reduce their access to such alcohol, I request that you cease the sale of single cans of alcohol immediately. Should further concerns regarding the supply of high strength products from your premises come to my attention I will consider applying for a Review of your Premises Licence seeking a condition prohibiting the sale of beer/lager/cider with an abv of more than 6%, but I hope that this will not be necessary.

I appreciate that these individuals are also obtaining alcohol from other outlets within the area, as Miss Mankowska reported to Mrs Smart on 10 July 2017 that she saw a male drinking from a can on the bench during the early hours of that morning, before Off Licence TQ Ltd had opened. Please be assured that should evidence of other premises selling alcohol to these individuals come to our attention, we will take positive action in relation to those premises.

As Premises Licence Holders I would remind you that it is your responsibility to ensure that your premises is run in accordance with the conditions of your Premises Licence,

in a manner that promotes the Licensing Objectives and within the confines of the law at all times.

A copy of this letter has been forwarded to the Torbay Council Licensing Team for their information.

I refer to our application for the Review of the Premises Licence in respect of the above named premises.

In advance of the hearing on Thursday 31 May 2018 I would like to provide you with the following additional information in relation to this premises:

1) On 10 April 2018 my Licensing Department received an application to vary the DPS at Off Licence TQ Ltd to Mr Karol Lapa. The last date for consultation was 24 April 2018. At 1242 hours on 16 April 2018, Sgt Mike Norsworthy, Licensing Sergeant for Devon, contacted Mr Lapa and discussed the matter with him. At that time he stated that he was working at Travelodge and Off Licence TQ Ltd. Sgt Norsworthy asked him how much time he would be spending at Off Licence TQ Ltd and Mr Lapa advised him that the majority of his working week would be spent there. Sgt Norsworthy advises me that he told Mr Lapa that in light of the serious concerns in respect of the management of this premises, he would not be satisfied if the DPS was only at the premises on an ad hoc basis. Based on the information provided, the police did not make representation and the application was subsequently granted.

2) On 21 May 2018 my Licensing Department received an application to appoint Mr Karol Lapa as the DPS at Travelodge, Newton Road, Torquay, the last date for consultation in respect of this matter is Thursday 31 May 2018. Mrs Smart Contact the police

has spoken to Mr Lapa and he has indicated that he has been helping Ms Mankowksa introduce new policies and improve the management of her business 'during his spare time'. However he is actually employed at Travelodge for between 30-40 hours per week and therefore Travelodge must be his priority. Mr Lapa further indicated that ideally he wished to be DPS at both premises for at least the summer period to ensure that staff at Oif Licence TQ Ltd are able to run it in accordance with his policies and in a mariner which does not impact on the licensing objectives. However, he further advised Mrs. Smart that if he could only be DPS at one premises, he would neve to remove himself from DPS at Off Licence TQ Ltd.

I do not consider it appropriate that the DPS of Off Licence TQ I to is employed elsewhere and only physically at this premises during his spare time. Moreover has advised Mr Lapa of my concerns and informed him that I shall make a decision as to whether to object to him being DPS at Travelodge immediately following the Review hearing, once a decision has been made regarding Off Licence TQ Ltd's future. Mrs Smart will notify him accordingly.

- 3) A check on the Companies House website reveals that on 5 April 2018 Ms Iwona Elzbieta Mankowska resigned from the roles of director and secretary of Off Licence TQ Ltd and she also relinquished her position as a person with significant control of the company.
- 4) The check on the Companies House website further reveals that on 5 April 2018 Mr Piotr Marcin Dryja was appointed as sole director of Off Licence TQ Ltd and he now has significant influence or control of the company. Mrs Smart has advised me that Mr Dryja is the male she knows as Pete, who sold a single can of alcohol to a male who subsequently consumed this within the cemetary of St Andrews Church, St Efrides Road, Torquay on Wednesday 5 July 2017 (referred to in letter from the police dated 21/07/17). Furthermore Mr Dryja is the partner of Ms Mankowska.

From the above information it appears that Ms Mankowska is attempting to distance herself from the management of this premises. However I have concerns about the long term management of this premises, particularly should Mr Lapa cease to be DPS. In addition, please find attached to this letter a document showing the logs recorded at St Andrews Church, St Efrides Road, Torquay for 2018.
