	<p>In Glasgow individuals, localities and families are targeted with specific interventions which is proving cost effective and demonstrating good outcomes.</p> <ul style="list-style-type: none"> <li>• SCT will be trialling a project looking at a particular area identified through Paignton and Brixham tasking that has been causing ongoing multi-agency issues requiring a longer term approach to address. Our outcomes for this are around reducing dependency on services and reducing cost on the public purse.</li> <li>• Research is currently being undertaken to identify links between families and the issues and agencies currently involved in this area. Systems and processes need to be put in place before residents are approached but there is some historic and current FIP involvement with good relationships that can be built on. There is a multi-agency meeting regarding the area on 13.07.11.</li> <li>• With regards to the tasking process KM is looking at case management systems and processes with RW's team while Tara Fowler is looking at a vulnerability matrix. Links are in place with TDA and other employment agencies around ETE issues. <b>FM will speak with KM regarding adult social care links.</b></li> <li>• Discussion was had around sports being useful diversionary activities for YP. GO mentioned that the Council have been asked to consider extending sports leases which may lead to greater capacity for clubs to engage youngsters.
