MEETING AT TORQUAY POLICE STATION RE MAMBO 8 DECEMBER 2011 AT 1500 HRS

Inspector LEISK outlined the reason why the above named had been requested to attend the meeting, due to the large number of crimes linked to the premises since April 2011. He said that an undercover police operation had taken place in early 2011 which had gone some way to alleviate the concerns of the police, but since that time crime levels had remained high. He also stated that in relation to licensed premises, Mambo had more crimes linked to them than any other licensed premises in the whole Devon and Cornwall Force area. He stated that due to financial cut backs, the police are not in a position to tolerate this number of crimes, and more responsibility by the premises to reduce this number is required. It was also pointed out that the police receive statistical data from Torbay Hospital concerning A & E attendances, and Mambo is frequently mentioned within this data.

Sgt BELL then gave an overview of the number and type of crimes that the police had been investigating. There are 10 allegations of assault/heavy-handed ejections by door stewards, 20 assaults (customer on customer) and 23 thefts, mainly of handbags or mobile phones.

It was acknowledged that Mambo is a very busy premises, which is open until the early hours every night of the week and therefore the police would expect a higher number of incidents than other premises. The layout of the premises was discussed and suggestions put forward to improve customer flow/supervision. Nathan indicated that the premises are hoping to level out the floor area and remove a banister on the first floor, sometime at the beginning of 2012.

Lengthy discussions followed re crime prevention/reduction matters and drink promotions. Mandy GUY raised concerns re noise issues and information she had received regarding staff receiving bonuses or pay cuts based on volume of sales – this was denied by Julie EYRE.

Julie SMART will provide Julie EYRE with a breakdown of all crimes in due course, particularly in relation to the allegations against doorstaff, in order that she can liaise with Aaron MOORE concerning this. Aaron indicated that he will not tolerate the misuse of force by door stewards and will take any action necessary.

Inspector LEISK said that he wished to review the situation with Mambo in 3 months, when he will compare the number of crimes (December 2011 to March 2012) to that covering the same period last year (December 2010 to March 2011).

Inspector LEISK concluded the meeting by stating that this was an opportunity for Mambo to examine their operation and assist the police in improving the situation. Julie EYRE indicated that she is concerned that her premises are causing concern for the police and that she and her staff will endeavour to improve the situation.

INCIDENT. HE ALSO SHOWED ME CCTV FOOTAGE OF THE AGGRIEVED PERSON BEING EJECTED

CCTV viewed by officers. Aggrieved is seen to refuse to leave and be uncooperative in his ejection. Part of the ejection down the stairwell is not covered by CCTV. Neil Stanlake requested an additional camera be installed to cover this area. This complaint has been classed as a lawful ejection, however it still appears that excessive force was used.

MEETING AT MAMBO WITH JULIE EYRE, SHARON RODGER AND NATHAN TOWERSEY AT 1100 HRS ON MONDAY 27 FEBRUARY 2012.

Attended premises to discuss the list of 'Allegations against door stewards' that I had prepared following the meeting held at Torquay Police Station on 8 December 2011. Sharon Rodgers handed to me a document she had prepared, entitled 'Incidents reported from police matching with Mambo'. I looked at the first couple of entries on this document and they did not see to tie in with the dates of incidents I had prepared so it was agreed that I would compare both documents, undertake further research and then liaise with Sharon re my findings.

Discussion re number of complaints of assault by door stewards for Mambo's compared to other premises in Torquay. I stated that there are far more of these in relation to Mambo, and a discussion following over possible reasons for this.

Discussion re variation of layout of premises on 1st Floor which should assist with customer flow and supervision of premises.

Discussión re staff changes as Gary Simpson has now left Mambo's, and Nathan has been re-instated as DPS.

Discussion re application in respect of Trents. Date of hearing has been set as 15 March 2012. Julie EYRE stated that in relation to my proposed conditions, the only one that she has issues with is that any person involved in the sale/supply of alcohol must complete BIIA Level 1 training course. I told her that this course is easy to arrange, the trainer can attend the premises and train all staff in one session taking approximately 2-3 hours. Rob FORD, the trainer, has in the past received Government funding and these courses have been free, however, the cost of the course is in the region of £20-£30. Julie stated that they have a high turnover of bar staff, and we discussed writing into staff contracts that if they leave the company within a certain time period they have to pay the course fee back. I told her that in Scotland training such as this is compulsory, and it has been rumoured that at some point it may be brought in in England. This condition has been imposed on several licences in Torbay, and it goes a long way to demonstrate that bar staff are aware of their responsibilities with regard to serving drunks and underage persons.

I am responsible for the delivery of Local Policing across Torbay, including The Evening and Night Time Economy. I have been engaged in policing Torquay's Evening and Night Time Economy since 1995 and am experienced in public order policing. I have been asked to comment on my concerns in relation to the operation of the Cafe Mambo licenses premises, situated on The Strand in Torquay. |
| Between 1st April 2011 and 27 th February 2012, there have been 71 offences linked to Cafe |
| Mambo. Most of these offences are committed between midnight and 0400 hours.

There were 54 incidents where the police were called to Cafe Mambo in the period 1st April 2011 to 27th February 2012.

Contrasting this with other popular Night Time Economy venues; the Green Ginger, The Venue and Bohemia there were 16, 21 and 25 incidents reported to the Police, respectively.

The breakdown of these Incident reports, or logs, is on the following nights of the week;

Monday - 11 incidents

Thursday – 11 incidents

Tuesday - 10 incidents

Saturday – 7 incidents

Wednesday – 6 offences

Friday - 6 offences

Sunday - 3 offences

There is a peak in incident reporting between 0200 hours and 0400 hours.

The general dynamic in Torbay is that all other nights other than Saturday have reported significantly reduced footfall. This has been impacted since 2008 as a result of the bleak financial outlook affecting the economy. People appear to be saving their money and visiting the harbourside on a Saturday evening only. Friday nights in particular have seen significantly reduced numbers of revellers on Torquay Harbourside.

My particular concerns in relation to Cafe Mambo are the type of customer that a seven day late night venue attracts. Most working people are saving to go out on a Saturday night. Save for the incidents at Cafe Mambo, there is virtually no reported Night Time Ecomony issues on nights other than a Saturday. Many of the persons involved in incidents at the premises are well known to the police with previous convictions.

The incidents and crimes I have detailed are in my view only part of the picture. Many other incidents have occurred at Taxi ranks and in the surrounding streets which we cannot

definately link to the premises, although it is the only one operating in the area at the time of occurrence.

There have been more reported thefts in Cafe Mambo (38 offences) than any other venue put together. I simply do not subscribe to the view that because Cafe Mambo have a larger footfall, than other venues, this is a predictable position.

We can see from nights of the week where incidents and crime are reported that we do not experience a significant peak on a Saturday night, which one could attribute to increased volume of customers.

As a result of these concerns, I called a meeting between the Police and Lifestyle Enterprises at Torquay Police Station on 8th December 2012.

At this meeting I outlined my position and explained that we would review the position in three months time, with all options including a review being considered.

Since that meeting on 8th December, a further 31 crimes have been reported at the premises and a further 10 incidents have been reported.

Cafe Mambo is having a significant impact on Crime and Disorder in the Cumulative Impact Zone around Torquay harbourside. As stated earlier, if it was not for this premises, we would be experiencing significantly reduced numbers of crimes and incidents on other days of the week except for Saturdays.

Even accepting that Cafe Mambo is the busiest venue in Torbay in terms of footfall, the crimes and incidents are as a direct result of the premises being open until 0300 every night of the week.

would not impact on the licensing objectives and indeed as it was a 'move' of premises, no further licence was to be granted in that area. Subsequently at a Licensing Hearing held on 14 April 2011, the Licensing Committee resolved that a departure from their policy was proportionate having regard to the oral representation from the police and given that the tenants agreed to surrender the Premises Licence at Trents. The Premises Licence at Trents was eventually surrendered on 28 September 2011.

I consider that the granting of a new Premises Licence in respect of Trents will add to the problems of crime and disorder, and public nuisance within the harbourside area as it will allow another establishment to offer similar facilities already on offer within that area, and close to other risk factors such as takeaways and taxi ranks.

As can be seen by the list of closing times within the harbourside area, this application will allow customers to remain on the premises until 4.30 am on Wednesdays through to Sundays, when there are already two other premises on the harbourside which close at 4.30 am and 5.00 am on Fridays/Saturdays. An additional premises closing at this time will not assist in furthering the licensing objectives and will lead to an increase the number of persons queuing at takeaways and waiting around for taxi's, thereby increasing the likelihood of crime/disorder/anti-social behaviour and nuisance in the area.

The applicants in respect of this application, Lifestyle Enterprises (UK) Ltd, are the current Premises Licence Holders of three licensed premises within the harbourside area. These being The Apple and Parrot/Tiffany's, 17 The Strand, Torquay, Tiger Bills and Fast Eddies, Queens Hotel, Victoria Parade, Torquay, and Mambo/The Beach Hut, 7 The Strand, Torquay.

Tiger Bills and Fast Eddies is a food led establishment, and the Apple and Parrot/Tiffany's is a bar offering various forms of entertainment, including lap-dancing. The police do not experience high levels of crime and disorder at these two premises, however the same cannot be said in respect of Mambo, which is located approximately 150 metres from Trents.

In December 2011 the police had serious concerns about the high numbers of crimes and incidents linked to Mambo, and Lifestyle Enterprises (UK) Ltd were asked to attend Torquay Police Station at the request of Inspector Leisk in order that to

At this meeting they were informed that the police wished to see a reduction in crimes and incidents at their premises over the forthcoming three month period, or further action would be considered.

This situation is still being monitored by the police and further discussions with Mambo will be held in due course. However, the statistics provided by our Research Department at Headquarters and the statement provided by Inspector Leisk show that since December 2011 there has been no significant improvement in the number of crimes and incidents linked to Mambo.

Furthermore, with regard to the time limit aspect of this application, ie that the licence will only run from 1 April 2012 until 31 October 2012, the police are concerned that should the premises impact on crime and disorder, normal avenues of recourse for the police, such as a Review of the Premises Licence, will not be a viable course of action due to the relevant time constraints involved in the application procedure. Therefore the only form of action available to the police would be the closure of the premises by use of Section 161 of the Licensing Act 2003 which can only be used if there is, or is likely imminently to be, disorder on or in the vicinity of the premises, and closure is necessary in the interests of public safety. In conclusion, due to the very real concerns the police have in respect of the management and operation of Mambo, and the impact this premises has on the levels of crime and disorder, I do not think that they should be granted a Premises Licence in respect of Trents.






