1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a new Premises Licence.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 The matters raised relate to the Licensing Objectives "The Prevention of Crime and Disorder", "The Prevention of Public Nuisance" "Public Safety" and "The Protection of Children from Harm".
- 1.4 The matter must be considered on its merits having received details of the issues arising either at a hearing or by written Representation if all parties have agreed that a hearing is not necessary. A decision must be made, having considered the Representations, either:-

(a) to grant the licence subject to

(i) such conditions as are consistent with the submitted operating Schedule modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and
(ii) any condition which must under Section 19, 20 or 21 be included in the licence:

(Such conditions may differ in respect of different parts of the Premises and/or different activities).

(b) to exclude from the scope of the licence any of the licensable activities to which the application relates;

- (c) to refuse to specify a person in the licence as the Premises Supervisor;
- (d) to reject the application.
- 1.5 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Applicant and Interested Parties following the determination of the matter.

2. Introduction

2.1 An application has been made under Section 17 of the Act for a Premises Licence to permit licensable activities at the Premise detailed above. Details of the relevant pages of the application are shown in Appendix 1.

A brief description of the application, as follows:

The sale of Alcohol off the Premises from 0900 until 2200 seven days a week.

To be open to the public from 09.00 until 2200 seven days a week.

A copy of the plan of the Premises is shown as Appendix 2.

2.2 The Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 17(5) but is unable to issue the Licence, as relevant Representations have been received from four Interested Parties. The Licensing Authority is also satisfied that the Representations have been received within the appropriate time scale, have not been subsequently withdrawn and are not vexatious or frivolous.

We have received four Representations from Interested Parties in relation to the Licensing Objectives "The Prevention of Crime and Disorder", "The Prevention of Public Nuisance" "Public Safety" and "The Protection of Children from Harm". Theses are shown as Appendix 3.

There have been no additional Representations received from any other Interested Party or any Responsible Authority.

- 2.3 The Authority is required to conduct a hearing by the provisions of Section 18(3) unless all parties agree that this is not necessary.
- 2.4 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.5 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.
- 2.6 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 2(1) of Schedule 5 to :-
 - (a) The holder of the licence against any decision
 - (i) to impose conditions on the licence, or
 - (ii) to take any step to exclude a licensable activity or refuse to specify a person as Premises Supervisor.
 - (b) Any person who made a relevant Representation who desires to contend
 - (i) that the licence ought not to have been granted, or
 - (ii) that, on granting the licence, the Licensing Authority ought to have

imposed different or additional conditions, or taken any step to exclude a licensable activity or refuse to specify person as Premises Supervisor.

- 2.7 Following such Appeal, the Magistrates' Court may:-
 - (a) dismiss the appeal,

(b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or

(c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,

and may make such order as to costs as it thinks fit.



Dear Steve,

I have been contacted by some constituents regarding the proposal to grant a licence to Bargain Booze at Foxhole Road, Paignton.

I must say that I do share their concerns that not only is it unnecessary to have another licensed premises where there are already at least 5 within a 1 mile radius, but my biggest concern is the close proximity to the newly refurbished play area. Bargain Booze actively advertise that they sell "hundreds of discounted lines across alcohol categories" and to have this type of premises opposite a play area that is well used by local children normalises alcohol as if it were part of everyday behaviour. This is unacceptable and potentially damaging to children. I would like to emphasise the danger to children from exposure to alcohol related anti social behaviour as it is a well known fact that children may ask adults to purchase alcohol for their consumption.

I believe that when Bargain Booze was previously trading there were many occasions of anti social behaviour and youths used to congregate outside the premises and their behaviour was often intimidating towards local residents, since Bargain Booze closed these incidents have ceased.

Please can you confirm that my objections have been registered by replying to my Constituency Office at Station Road, Totnes, TQ9 5HW.

Dear Shaun,

Thank you for the your reply.

Here are my objections as per your request.

1. The prevention of crime and disorder:

The local PCSO and police have cut crime including Anti social behaviour on the Foxhole estate. Whilst Bargain booze plus was open both rose again which included Anti social behaviour with kids under 18 hanging around the shops swearing, drinking and verbally abusing members of the public. There was also a a robbery at knife point on Foxhole news. It also promotes and encourages Drink driving This has stopped since bargain booze shut/went bankrupt in Dec 2012/Jan 2013.

2. Public safety,

The increase in the volume of traffic caused by people going to Bargain Booze caused problems to the public who could not park outside the shops and in some cases their own homes opposite. It is to be pointed out that this traffic was caused by friends going to the store as the only people that used it.

3. Prevention of public nuisance.

The noise from people and children caused by the increase in traffic and public to the area is a nuisance at 2300hrs / 10 pm people and children are trying to sleep and people arguing and car doors banging is and was unacceptable. This coupled with teenagers and kids sitting on the park walls and in the park at hours day and night is a public nuisance.

4. The protection of children from harm.

Bargain Booze is located directly opposite a public childrens park that was designed for young children and parents to sit and play. Not only does it advertise and promote drinking to children it also sets a bad example ad also allows parents that are not responsible to wonder over (a distance of 15 meters) buy and then drink alcohol in the park leaving empty bottles and cans leads to children getting hurt.

As i said the other day i can not work out why the Foxhole estate needs 3 licensed premises all with in 50 metres of each other and a further 4 within a mile of it. This is more than any area including Torquay town centre and i would welcome a face to face meeting on Foxhole to enable you to see the close proximities and especially how close it is to the childrens park and the harm it will cause.

I hope this is satisfactory.

On one occasion I did make a complaint at the time and I believe the police or PSCSO did attend.

as said there is a young children's park now directly opposite Bargin Booze and it is well used. I myself have 3 children 2 are primary school age. I do not want them going over the park to find broken bottles and to be harassed by groups of teenagers who are drinking.

Prior to the new park my son's would use the area for their scooters but had to stop due to bulling, foul language and broken glass from these youths and this was during the day time.

Since Bargin Booze has ceased trading we have not had any antisocial behaviour issues over at the shops.

I do not see the need for yet another licensed premise where there are already 6 within a 1 mile radius.

Hi Shaun,

I afraid I do not have dates but I can give instances that would meet some if not all of the licenses' objectives.

1. My son, who was 6 years old at the time, went across to the paved area opposite Bargin Booze with my 14 year old daughter to play on their scooters and run around. Within 5 minuets they were back, My children told me that "the group of teenagers" meaning the group that normally hang around Bargin Booze and the shops, "were calling" ames and throwing cans at us". I remember commenting tha would be going out to the church youth club soon so it must have been a Thursday. This happened around 3 times in the space of a month so my children stopped playing over there.

This incident covers number 2, 3 & 4 of the licensing objectives. 2, Public safety – 3 Prevention of public Nuisance, - 4 protection of children from harm.

2. On a separate occasion my daughter, then 14 years old, went to ride her bike over the paved area opposite the shops on Foxhole Road. She came back in tears because teenagers as young as 12 years old were over there drinking from cans they had just bought from Bargin Booze (she said they were alcohol but I didn't go and look for myself. She had just seen one of the lads go into Bargin Booze and came out with 2 lots of cans which he then passed around his mates and they sat drinking on the walls of the paved area). They had started to call her fat and fatty and laugh and torment her because she wasn't very good at riding her bike. To this day she has not ridden her bike again and has only just started to take her brothers over to the new children's pavement games that have been set up.

Again this incident covers several of the licensing objectives: Public Safety - Prevention of public nuisance and protection of children from harm. Along with, prevention of crime, if the cans were indeed alcohol.

3. I myself witnessed a young lad go into Bargin Booze and come out with what looked like larger cans (they were not the small energy drink sized cans, or coke sized cans they were big and green like Carlsberg cans). I watched, as I sat in my car, the lad hand out these cans to his friends all of whom were congregated around the door of Bargin Booze most of whom looked under 18 years old including the lad that had just made the purchase. I tried to taker pictures with my mobile phone but they were too far away to pick up. The time was 5.30pm as I was about to collect my children from after school club and nursery. Following the incidents above I called the police non emergency number to report what I had just seen. I believe the community constable attended and moved them on.

This covers objective 1 prevention of crime and disorder.

4. One afternoon after school I was sat in my front garden with my children, 14 years, 6 years & 3 years. They were playing nicely when we heard a lot of screaming, shouting and foul language come from the direction of the shops. A group of above 7 boys and 3 girls were hanging around Bargin Booze and the green in front of the shops. Their ages ranged from 7 years to 18 years, some of them I recognized as part of the usual group that hang around Bargin booze. They were throwing there drinks over each other running in front of cars and around the car park of the shops screaming and shouting and swearing at each other. This lasted for about ½ and hour before I had to take my children inside to prevent them from picking up the language they were using.

Groups of youths were always hanging around Bargin Booze and the shops at all hours. Living opposite the shops we were subjected to foul language, shouting and screaming at all hours and a lot of unsociable behaviour. Since Bargin Booze has closed there have been no incidents of anti social behaviour, no groups of youths at all hanging around. Both the Co-op and Foxy's drinks will not stand for groups hanging around and move them on immediately they become aware.

There has now been a new young children's park built on the pavement and green opposite the shops, at great expense and it is well used by primary school age children, mine included. I have real concerns that should yet



another license be granted for alcohol the children will be in danger of harm from older youths, subjected to bulling and foul language as before. There is no need for a 3rd licensed premise within the Foxhole Road shops area.

I believe the licensing committee and council have a duty of care to prevent a public nuisance, promote public safety and protect the local children from harm including harm from builing. I would hate to see the lovely new park become vandalized and not used due to fear of older children builing. We all had these concerns before but we were not listened to and our fears became reality whilst Bargin Booze was trading, but we have had NO trouble since it ceased trading.
