### 41. Election of Chairman/woman

Councillor Manning was elected as Chairman for the meeting.

#### 42. Minutes

The Minutes of the meeting of the Sub-Committees held on 17 September 2015, 22 October 2015, 10 December 2015 and 18 February 2016 were confirmed as a correct record and signed by the Chairman.

### 43. Review of Torbay Council Driver's Licence

Members considered a report concerning a Torbay Council Licensed Driver and whether she remained a 'fit and proper person' to hold a Torbay Council Driver's Licence. At the hearing Members of the Licensing Sub-Committee heard submissions from the Senior Licensing Officer and the Respondent, Mrs Nicola Lyness.

#### Decision:

- (i) that Mrs Nicola Lyness' Torbay Council driver's licence be suspended for a period of three months, in accordance with Section 61(1)(b) of the Local Government (Miscellaneous) Provision Act 1976, and that this suspension shall be with immediate effect, in accordance with Section 61(2B) of the Local Government (Miscellaneous Provisions) Act 1976, as it appeared to Members on hearing the evidence before them that it is appropriate to do so in the interests of public safety; and
- (ii) during the period of suspension, Mrs Lyness be required to undertake and provide written evidence to the Licensing Authority of successfully completing a Driver Standard Agency Taxi Assessment Test (DSATAT), as set out at page 11, paragraph 5.10 and 5.11 of the Licensing Authority's Hackney Carriage (Taxi) and Private Hire Policy, May 2013. Failure to successfully complete the course within the said time, will result in revocation of any existing driver's licence held by Mrs Lyness and that she be prohibited from applying for a new drivers licence until such time that written evidence is provided to the Licensing Authority of the DSATAT course being successfully completed by her.

#### Reason for Decision

Having carefully considered all the written and oral Representations, Members resolved to suspend Mrs Lyness' Driver's Licence, as they could not be satisfied that she remained a 'fit and proper person' to hold such a licence.

In coming to that decision, Members considered having been charged with the responsibility to determine the driver's licence, whether they would allow their son or daughter, spouse or partner, mother or father, grandson or granddaughter or any other person to whom they care or any other vulnerable person known to them to get into the vehicle with Mrs Lyness alone. An unequivocal and unanimous answer to this question by Members', was no.

In determining that Mrs Lyness does not remain a 'fit and proper person' to be a driver licensed by Torbay Council, Members had due regard to their duty to protect the public and on the evidence before them, Mrs Lyness had conducted herself in a manner that was unacceptable and fell below the standard expected by them of a driver licensed by Torbay Council.

In noting Mrs Lyness's submissions and demeanor at the hearing, it appeared to Members that Mrs Lyness did not, as a licensed driver which carries a higher expectation of competency, accept the seriousness of the offences and showed little, if any remorse. Members were also concerned at the number and nature of the licensing endorsements gathered by her over a two year period and in particular, that two incidents were committed on the same day during April 2014 and that on some occasions, the offences were committed whilst she was transporting a passenger. This ultimately resulted in a driving disqualification being imposed by Bodmin Magistrates' Court on the 10<sup>th</sup> February 2016.

Members gave careful consideration to the revocation of Mrs Lyness driver's licence but resolved that having a period of suspension to reflect on the seriousness of her driving misdemeanours and the successful completion of the DSATAT, that their concerns would be alleviated.

### 44. Review of Torbay Council Driver's Licence

Members considered a report concerning a Torbay Council Licensed Driver and whether he remained a 'fit and proper person' to hold a Torbay Council Driver's Licence. At the hearing Members of the Licensing Sub-Committee heard submissions from the Senior Licensing Officer and the Respondent, Mr Michael Dewick.

### Decision:

That Mr Michael Dewick be issued with a formal warning in respect of his conduct which amounted to a conviction for an offence under the Crime and Disorder Act 1998 Section 31(1)(b) for racially/religiously aggravated intentional harassment/alarm/distress.

### Reason for Decision:

Having carefully considered all the written and oral representations, Members resolved that a formal warning was appropriate and proportionate in the circumstances before them.

In coming to that decision, Members had regard to the seriousness of the offence, which occurred whilst he was on duty and in the earshot of other taxi drivers and members of the public and resolved that it fell below the standard reasonably expected by them of a driver licensed by Torbay Council. However, Members weighed this against the apparent submissions of remorse and the excellent record held by the Licensing Authority, in that there had been no cause for concern or complaints made in respect of Mr Dewick during the significant time he had been licensed by the Authority.

### 1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a Variation to a Premises Licence.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 The matters raised relate to the Licensing Objectives "The Prevention of Crime and Disorder", "The Prevention of Public Nuisance", "Public Safety" and the Protection of Children from Harm".
- 1.4 The matter must be considered on its own merits having received details of the issues arising either at a hearing or by written Representations if all parties have agreed that a hearing is not necessary. Having regard to the Representations and issues arising, a decision must be made to take such steps as are necessary for the promotion of the licensing objectives. These are either:-
  - (a) to modify the conditions of the licence, or
  - (b) reject the application in whole or in part.

For this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

1.5 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Interested Parties and Responsible Authorities at the determination of the matter.

### 2. Introduction

2.1 An application has been made under Section 34 of the Act for a Variation to a Premises Licence. Details of the application are shown in Appendix 1. Only the relevant pages of the application are shown.

A brief description of the proposed Variation is as follows:-

To extend the Sale of Alcohol on Friday and Saturday from 10.00 until 02.30. This is an additional 1.30 hours at the end of the evening. The existing licence allows the Sale of Alcohol both on and off the Premises from 10.00 until 01.00 Friday and Saturday, from 10.00 until midnight Monday to Thursday and from 11.00 until midnight on Sunday.

To extend the opening hours on Friday and Saturday from 10.00 until 03.00 to maintain the 30 minutes drinking up time. The opening hours are presently Friday and Saturday 10.00 until 01.30, Monday to Thursday 10.00 until 00.30 and from 11.00 until 00.30 on Sunday.

To extend Live Music, recorded Music and Performance of Dance on a Friday and Saturday from 10.00 until 01.00. This is an additional 30 minutes at the end of the evening. The existing licence allows for these activities from 10.00 until 00.30 Friday and Saturday, from 10.00 until 23.30 Monday to Thursday and from 11.00 until 23.30 on Sunday.

No additional conditions have been proposed in the operating schedule and there has been no request to amend or remove any of the existing conditions.

- 2.2 A copy of the current premises licence showing the licensable activities, timings and conditions is shown at Appendix 2 of this report.
- 2.3 Torbay Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 35(1) but is unable to issue the variation to the Premises Licence, as relevant Representations have been received from Responsible Authorities and Interested Parties. The Licensing Authority is also satisfied that the Representations were received within the appropriate time-scale, have not been subsequently withdrawn and are not vexatious or frivolous.

We have received a Representation from the Police in relation to the Licensing Objectives "The Prevention of Crime and Disorder", "The Prevention of Public Nuisance" and the Protection of Children from Harm". This is shown in 3 parts as Appendix 3 (written representation), Appendix 4 (history of the premises) and Appendix 5 (logs and crimes) of this report.

We have received a Representation from Public Protection in relation to the Licensing Objective "The Prevention of Public Nuisance". This is shown as Appendix 6 of this report.

We have received 3 Representations from Interested Parties in relation to the Licensing Objectives "The Prevention on of Crime and Disorder", "The Prevention of Public Nuisance" and "Public Safety". These are shown as Appendix 7 of this report.

- There have been no Representations received from any other Responsible Authority or any other Interested Party.
- 2.4 The Authority is required to conduct a hearing by the provisions of Section 35(3) unless all parties agree that this is not necessary.
- 2.5 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.6 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.
- 2.7 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 4(2) of Schedule 5 to :-
  - (a) The applicant for the variation of the licence against any decision to modify the conditions
  - (b) Any person who made a relevant representation in relation to the application who desires to contend
    - (i) that any variation made ought not to have been made, or
    - (ii) that, when varying the licence, the Licensing Authority ought to have modified the conditions of the licence or ought to have modified them in a different way.
- 2.8 Following such Appeal, the Magistrates' Court may:-
  - (a) dismiss the appeal,
  - (b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or
  - (c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,
  - and may make such order as to costs as it thinks fit.

#### **ANNEXE 1**

#### MANDATORY CONDITION: WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

- 1) No supply of alcohol may be made under the premises licence:-
  - (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3) (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:-
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:

     (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
     (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4) The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5) (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.
- 6) The responsible person must ensure that:-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is

available to customers in the following measures:-

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

#### Minimum Drinks Pricing

- 1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2) For the purposes of the condition set out in paragraph 1
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
  - (b) "permitted price" is the price found by applying the formula P = D + (DxV)

Where:-

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence:-
  - (i) The holder of the premises licence
  - (ii) The designated premises supervisor (if any) in respect of such a licence, or
  - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3) Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### MANDATORY CONDITION: DOOR SUPERVISION

- 1) Where one or more individuals are carrying out security activities, each individual must be licensed by the Security Industry Authority.
- 2) But nothing in the aforementioned conditions requires such a condition to be imposed in respect of a) and b) and (b)(i) and (b)(ii)
  - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), are exempt.
  - (b) In respect of premises in relation to-

- (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
- (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- 3) For the purposes of the aforementioned conditions:-
  - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

#### **ANNEXE 2**

### CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

### Additional Conditions transferred from Public Entertainment Licence

 This licence shall apply only to those parts of the premises named below and the maximum number of persons to be permitted within those areas shall not exceed the figure stated:-

Ground Floor Bar Area - 170

### Restrictions transferred from the On Licence

The restrictions related to permitted hours do not prohibit:

- (a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
- (d) consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (f) the sale of alcohol to a trader or club for the purpose of the trade or club.
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there; or
- (i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of alcohol so supplied, if the liquor is supplied at the expense of the employer or of the person carrying on or in charge of the business on the premises.

#### Credit Sales

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied:

- (a) with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal;
- (b) for consumption by a person residing in the premises or his guest and paid for together with his accommodation:
- (c) to a canteen or mess.

#### General

- 1. There shall be a 30 minute "drinking up" time which will allow appropriate dispersal, use of lavatories etc.
- The licensee shall reserve the right to move the fire appliances, AWP machines, cigarette machines and/or any other similar objects temporarily in a fixed location which may impact on the ability of individuals on the premises to use exits or escape routes without impediment.
- There shall be a display of appropriate posters supplied by the Licensing Authority.

#### The Prevention of Crime and Disorder

- 1. All alcohol and soft drinks shall be decanted and served in toughened glass.
- 2. All interior trading areas shall be visible to staff from behind the bar servery.
- The licensee/staff shall monitor customer behaviour especially during busy periods.
- 4. There shall be a burgiar alarm system in place.
- Drug prevention measures shall be employed and signs displayed.
- 6. Door staff shall be managed by the Designated Premises Supervisor/appointed person and to be in the possession of radios whilst on duty at the premises.
- 7. When in use door supervisors shall determine which customers are permitted entry to the premises and refuse entry to those not considered to be suitable.
- An incident book shall be kept and all instances of public disorder will be recorded within it.
- Crime prevention posters shall be displayed on the premises.
- A banning policy shall be in place.
- No drunkenness or anti-social behaviour shall be tolerated on the premises.
- 12. A CCTV system of an evidential standard shall be installed to the satisfaction of the police. The system will cover the bar, lobby, entrance/exit and the outside area. The system shall be in operation at all times the premises are open to the public. All recordings shall be available for a minimum of 14 days. The Designated Premises Supervisor and/or manager will be able to operate the system. Copies of the recordings will be made available to the Licensing Authority and Responsible Authorities upon request and provided within a reasonable time. Should the system be inoperable this will be recorded in the incident book and repaired as soon as is reasonably practicable.

#### **Public Safety**

- 1. All fire fighting equipment shall be serviced annually by ACE Fire Equipment (UK) Limited.
- There shall be current gas and electric certificates in place.
- The pub shall promote a licensed taxi service to facilitate its customers making onward journeys.

There shall be lockable/closed windows.

- The fabric of the building shall retain sound.
- 3. There shall be a managed customer departure at busy times.

#### The Protection of Children from Harm

- AWP's and cigarette machines shall be positioned in sight of the bar counter.
- No unaccompanied children shall be allowed on the premises.
- 3. No children shall be allowed on the premises after 21.00.
- 4. There shall be no striptease and no nudity.

### **ANNEXE 3**

### CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY

### The Prevention of Crime and Disorder

- On every occasion that the premises sells alcohol after midnight and then closes after 00.30, SIA door staff shall be employed from 10.00pm until closing.
- On every occasion that the premises extends its hours of operation for sales of alcohol after midnight and closure to the public after 00.30hrs, from 9.00pm of that operational day, all drinks shall be served in toughened or strengthened glasses and no drinks shall be served in glass bottles from which it is intended or likely that a person shall drink.
- 3. On every operational day when door supervision is required, then those SIA door supervisors on front of house duties shall wear high visibility clothing for the entirety of their duty.
- 4. There shall be no entry or new entry to the premises after 00.30 and re-entry after this time shall be subject to a managed supervision system as indicated by the applicant, in particular hand stamping or something similar.

#### The Prevention of Public Nuisance

- Noise or vibration shall not emanate from the premises such as to cause persons in the neighbourhood to be unreasonably disturbed. Noise should not be audible within any noise sensitive premises with windows open for normal ventilation especially after 11pm. The criteria applied, from boundary to nearest residential property are;
  - (I) Before 11pm Noise emanating from the premises shall not be clearly distinguishable above other noise.

    (ii) After 11pm Noise emanating from the premises shall not be distinguishable above background levels of noise.
  - (iii) The Local Authority shall reserve the right in cases of tonal noise and where premises are attached to others (i.e. semi's and terraced properties) to make further assessments from within the residential property.
- Doors and windows shall be kept shut during regulated entertainment to reduce noise breakout. A management scheme shall be in place to ensure this situation remains.
- The volume of amplified sound used in connection with the entertainment provided shall at all times be under the control of the licensee/management.
- During amplified music and entertainment the door lobbies shall be effectively used throughout the time of entertainment to prevent noise breakout.
- Amplified live music and entertainment until 00.30 hours shall be limited to Friday and Saturday.
- Amplified live music and entertainment until 23.30 hours shall be limited to not more than three evenings per week (Sunday-Thursday).

### The Protection of Children from Harm

1. All cigarette vending machines must be sited to ensure they are under direct supervision of the staff at all times.


- All Amusement with prizes machines must be sited to ensure they are under direct supervision of the staff at all times.
- 3. A management system shall be introduced to ensure that staff are aware of the legal requirements relating to underage sales and in particular the prevention of sales from cigarette vending machines to children under sixteen and the prevention from use of AWP machines by those under eighteen.
- Age identification shall be sought from any person appearing to be under the age of 18 years.
- 5. Staff shall receive training age identification related to the sale of alcohol.






The Bolton Hotel, New Road, Brixham, TQ5 8LT

I refer to an application for the Variation of a Premises Licence in respect of the above named premises, submitted by TLT Solicitors on behalf of the applicant, Punch Taverns plc.

For your information, the Bolton Hotel currently has the benefit of Premises Licence Number PL0445 issued by Torbay Council.

The Bolton Hotel is situated at a busy junction within Brixham Town Centre. The surrounding area consists of a mixture of business and residential properties. The premises is currently licensed for the sale of alcohol until midnight on Mondays to Thursdays and 1.00 am on Fridays and Saturdays. The premises must close 30 minutes after the last sale of alcohol. The applicant is seeking within this variation application to extend the sale of alcohol by an additional 1 ½ hrs on Friday and Saturday nights until 2.30 am the following day, with the premises closing 30 minutes thereafter, ie 3.00 am. The premises has a capacity of 170 persons.

The Bolton Hotel is situated a short distance away from Jackz Bar, Parkham Road, Brixham. Jackz Bar is licensed for the sale of alcohol until 2.00 am every day of the week, closing at 3.00 am. At the current time Jackz Bar and the Bolton Hotel are the only premises in Brixham Town Centre with Premises Licences authorising the sale of alcohol after midnight.

The Covernment Standard Stock code: SF615 The police have examined the application and consider that the applicant has not given sufficient consideration to the Torbay Council Licensing Statement of Principles 2016-2021 as the proposed operating schedule is lacking in detail. As you will see from the boxes contained on Page M of the application form, the applicants have not outlined any additional measures they intend to take to ensure the Licensing Objectives are met. It is therefore apparent that they have not identified any additional risks associated with their proposed operation and they do not consider that allowing persons to consume alcohol for an additional 1 ½ hrs within their premises, prior to leaving at 3.00 am, will impact in any way on the Licensing Objectives.

I now outline below a number of matters contained within the current Premises Licence that the police consider are not acceptable for a premises now seeking a licence authorising the sale of alcohol until 2.30 am on Fridays and Saturdays:

- 1. Condition 5 under the heading The Prevention of Crime and Disorder on Page 7 refers to drug prevention matters. The Torbay Council Licensing Statement of Principles 2016 (page 14) recommends that premises have a written Drugs Policy. What does the premises intend to do in respect of illegal drugs and psychoactive substances?
- 2. Condition 1 under the heading the Prevention of Crime and Disorder on page 8 of the application refers to the employment of SIA door stewards. This condition states that they shall be employed from 10.00 pm until closing time. What will the ratio of door stewards to customers be? Will a female steward be employed? Have the applicants considered the layout of the premises when determining how many stewards will be employed? Will a Door Steward Register be maintained? Page 38 of the Licensing Statement of Principles deals with this matter.
- 3. Conditions 2 and 3 under the heading the Protection of Children from harm on page 8 of the licence relate to no unaccompanied children being allowed on the premises and no children allowed on the premises after 2100 hrs. Under the Licensing Act 2003, children are those persons under the age of 16 years. Whilst the police are satisfied with these conditions, what measures does the applicant propose to take in respect of 16 and 17 year olds? Are they to be allowed entry to the premises throughout licensing hours and how will they ensure that are not sold or supplied alcohol?
- 4. Condition 5 under the heading the Protection of Children from Harm on page 9 of the application, refers to staff training in relation to age related sales. Will all staff involved in the sale of alcohol be required to hold the BIIAB Level 1 Award in Responsible Alcohol Retailing as indicated within the Licensing Statement of Principles (page 17)? What training records does the premises management hold in relation to staff training?

- 5. Conditions 4 and 5 under the heading Protection of Children from harm on page 9 of the licence relate to age related sales. The Torbay Council Licensing Statement of Principles 2016 (page 21) recommends the adoption of a Challenge 25 Policy. The police do not consider that conditions 4 and 5 on the licence are adequate for a premises selling alcohol until 2.30 am.
- 6. What training will be provided to staff so that they understand the requirements of both the Premises Licence and the broad provisions of the Licensing Act 2003? Again, will they be required to hold the BIIAB Level 1 Award in Responsible Alcohol Retailing?
- 7. Condition 3 under the heading The Prevention of Public Nuisance on page 8 of the licence states "there shall be a managed customer departure at busy times". What exactly does this mean? Does the premises have a written Dispersal Policy and if so what does it state?
- 8. Neither the application or the Premises Licence give any information in relation to smokers. What is the premises policy in relation to smokers? Where will they be located and how will they be managed?

In Part 3 of the application, within the box where the applicant gives a brief description of the nature of the proposed variation, I would refer you to the final sentence "All other licensable hours, activities, including the currently permitted times for the upstairs area of the premises, and conditions are to remain unchanged." I am not aware that the 'upstairs area' of the Bolton Hotel is included within the Premises Licence, perhaps the applicants could provide some clarification in respect of this.

In respect of the current management of the premises, Mr Stephen Close has been the Designated Premises Supervisor of the Bolton Hotel since June 2015 and since that time the police have been satisfied with Mr Close's management of the premises.

For your information, the Premises Licence Holder, Punch Taverns plc, do not have a role in the day to day management of the premises. In fact Punch Taverns plc have appointed a holding company known as Pub Solutions to manage this premises, and it appears to be Pub Solutions who are responsible for selecting managers for the premises. Pub Solutions also have no involvement in the day to day management of the premises but in the past a representative of this company has been present at meetings to discuss police concerns or particular incidents.

Since 2007 there have been 8 variations of DPS at the Bolton Hotel and it does not appear that Punch Taverns plc and/or Pub Solutions can find a suitable DPS who is committed to spending a long period of time at the premises. It is the opinion of the police that some of the previous DPS's at this premises have not been suitable to

manage the premises and the police have had many meetings at the premises in the last 10 years in an effort to improve the management of the premises. Due to this the police have concerns that should this application be granted, Mr Close may leave the premises and we may continue to see a regular change of DPS which will have serious implications on the management of the premises, leading to adverse effects on the Licensing Objectives. I have attached a sheet outlining the numerous changes of DPS at the premises for your information.

At the present time in Brixham Town Centre, the majority of licensed premises close 00.30 am on Friday and Saturday nights (see sheet attached). The Bolton Hotel can currently close at 1.30 am on Fridays and Saturdays and Jackz Bar can close at 3.00 am. This provides a staggered dispersal from licensed premises at closing time. Should this application be granted, customers will leave the Bolton Hotel at the same time as those leaving Jackz Bar, which could result in approximately 300 persons out on the street. This will undoubtedly have an impact on noise nuisance, anti social behaviour and disorder within the area and as police resources during the early hours of the morning are already stretched, I have serious concerns about the management of these individuals which must be the responsibility of the premises. Should you be minded to grant this application, I would request that door stewards remain on duty at the Bolton Hotel until all persons have left the area, but I would point out that even if door stewards are on duty this is unlikely to prevent incidents and noise issues from occurring.

Also attached for your information are copies of Forms L10 received by the Licensing Department since July 2013, together with details of crimes and logs at the Bolton Hotel and in the surrounding roads. Please note that in respect of New Road, Fore Street and Bolton Street, we have been unable to break this information down to the immediate vicinity of the Bolton Hotel. However it is my opinion that these roads are dispersal routes from the town centre and therefore customers leaving the Bolton Hotel will use these routes to go home.

I would refer you to the below paragraph which is contained within page 40 of the Licensing Statement of Principles:

'There will be an assumption however that Licensed Premises in residential areas, or where there is proximity to residential properties, will only be allowed to undertake Licensable Activities until 11pm unless detailed consideration and mitigation measures have been proposed to address those concerns. A simple application with no supporting material can be expected to be refused, where relevant representations have been received.'

Although this premises currently operates until 1.30 am on Friday and Saturday nights, they are now seeking to extend their hours until 3.00 am on these nights, which carries a significant risk of impacting on the Licensing Objectives the Prevention of Crime and Disorder and the Prevention of Public Nuisance. As the premises are situated in an area consisting of both business and residential properties and the applicant has not given any consideration to the increased risk or proposed any mitigation measures, the police consider that this paragraph is applicable.

In conclusion, the police object to this application on the grounds that the granting of it will impact on the existing levels of crime and disorder and public nuisance both at the premises and in the area and, as the applicant has not identified any additional measures they propose to implement to ensure that the premises can satisfactorily meet the Licensing Objectives, the police respectfully request that the Licensing Authority refuse this application.

There is security at the pub at the weekends but they show no interest and tend to spend most of the evening stood on the front door surely such a big pub should have more than two security staff? - 1. I wish to object to the above named application as I do not believe the application promotes the licensing objective 'Prevention of Public Nuisance'.
- 2. The Bolton Hotel is situated at the junction of Bolton Street and New Road, Brixham. Please see appendix 1.
- The surrounding area can be described as mixed use. Bolton Street and New road largely comprise of buildings occupied by business on the ground floor with over living accommodation on the floors above. Elevated above the Bolton Hotel, are streets which are predominately residential accommodation.
- 4. Appendix 1 figure 2 shows not the nearest residential accommodation but the two areas of high density residential zones.
- 5. The Bolton hotel is owned by Punch Taverns and Pub solutions act as an agent to install tenants to run the premises whom apply to be the DPS whilst Punch retains the licence. In this circumstance the DPS is not just the person who authorises the sale of alcohol but is an individual who manages the pub for personal gain.

- 6. A representation received by an interested party describes the area like a 'bowl' which a fairly accurate simile. The Bolton hotel sits at the confluence of two former river beds. As a consequence the premises are situated at the lowest point relative to the surrounding area which is flanked by former water cut cliffs. Residential properties are built on these cliff elevated above the Bolton Hotel. Appendix 1 fig 3 illustrates the area around the Bolton Hotel. In terms of noise, sound emanating from the Bolton will propagate away the premises and whilst the some sound will be absorbed by the building most will be reflected off producing prominent reflections. The majority of sound waves will diffract around the cliff exposing the house situated on top exposing them noise that may be consider unacceptable.
- 7. Fig 4 seeks to demonstrates how a given noise source will attenuate over a known distance. The red circles have been plotted 10m apart. Assuming live music inside the pub is playing at 95dB(A), the diagram demonstrates after an initial loss of 24dB(A) due absorption of the building for every doubling of the distance from the premises there is approximately a 3dB(A) attenuation. At a distance of 70m noise has reduced to 54dB(A). At times the applicant seeks to have regulated entertainment the backgrounds noise in the area surrounding the Bolton Hotel would expected to be around 45dB(A). Regulated entertainment at 70m from the premises would therefore be nearly 10dB(A) above background levels and at this level music would be audible. Numerous other factors need to be taken into account to quantify the likelihood of noise complaints occurring but the figures shows there is sufficient risk of noise complaints. The Council has received 7 separate noise complaints since 2007 (see appendix 2, Fig 1) further einforces future complaints are likely. The applicant needs to careful consider how they intend to manage noise breakout.
- 8. Historically voices from patrons have formed part of noise complaints from this premises, specifically from patrons using the beer garden and smoking on the street. One evening in September 2013 this effect was observed from Saxon heights a block of flats some 50m away where voices from patrons using the beer garden could clearly be heard and formed part of a compliant received by the Council at the time. Advice was given to the DPS regarding controlling patrons using the beer garden late night.

I raise this concerns as the applicant needs to carefully consider how noise from customers will be managed if the proposed variation is granted as applied.

9. Applicants are encouraged to consult with all responsible authorities prior to submitting an application:-

'In order to reduce the risk of relevant representations and the cost and delay of a contested hearing, applicants are strongly recommended to consult with the relevant Responsible Authority...'

### Licensing Statement of Principles, Torbay Council, 2016-21, s3 p14

Unfortunately the applicant has chosen to disregard this advice leaving little option but to submit this representation. I raise some doubt whether the applicant considered at all the Licensing Statement of Principles when making their application.

10. Torbay Councils Licensing Policy leans towards refusing an application beyond 11pm in a residential area unless remedial measures can be demonstrated:-

'There will be an assumption however that Licensed Premises in residential areas, or where there is proximity to residential properties, will only be allowed to undertake Licensable Activities until 11pm unless detailed consideration and mitigation measures have been proposed to address those concerns. A simple application with no supporting material can be expected to be refused, where relevant representations have been received.'

### Licensing Statement of Principles, Torbay Council, 2011, p37-38

Though this premises already operates beyond 11:00pm, this does not exempt them from the policy if they chose to further extend operating hours. The surrounding environs contain a significant enough density of residential accommodation for this requirement to apply and the applicant should consider what is required from them when making an application. I have found no evidence in this application that the applicant has considered further mitigations measures.

11. The license holder intends to finish live music and recorded music at 1:00am but intends to remain open to the public until 3:00am. It is pleasing the applicant recognises live music and recorded music may not be workable until 3:00am but I consider it unrealistic a premises will remain open to the public on a Friday and Saturday night without any regulated entertainment between 1:00am – 3:00am. 'Background Music' is not licensable but the concept is rarely understood by licensees. Though the licensing Act 2005 offers no definition the following two separate definition may offer committee members some guidance:-

'music of any kind that is played while some other activity is going on, so that people do not actively attend to it'

Or

'music that is intended as a background to an event, production or venue. It aims to be unobtrusive so not to distract or divert the attention of the visitor or viewer'

Does the applicant understand the distinction or has an error been made in the application? As the applicant did not consult prior to submitting this application these questions can no satisfactorily be answered.

- 12. Part M of the application offers applicants an opportunity to state additional steps they intend to take to promote the licensing objectives. The applicant has not offered any further steps or amended any existing conditions. In relation to live music which the applicant wishes to extend until 1:00am on Friday and Saturdays this is not possible because a conditions which they do not wish to change states:-
  - 5. Amplified live music and entertainment until 00.30 hours shall be limited to Friday and Saturday.
  - 6. Amplified live music and entertainment until 23.30 hours shall be limited to not more than three evenings per week (Sunday-Thursday).

This contradiction has perhaps been overlooked by the applicant but again as no prior consultation took place before the application was submitted I cannot be sure of the applicant's intentions. Again this demonstrates the application been poorly considered.

13. Conditions 1 under Annex 3, The prevention of Crime and Disorder requires:

'On every occasion that the premises sells alcohol after midnight and then closes after 00.30, SIA door staff shall be employed from 10.00pm until closing.'

Though led by colleagues in Police Licensing on the suitability of these conditions should the application be accepted I would expect the applicant to consider or as a minimum standard demonstrate they have reviewed who they intend to use SIA

door staff. Door Staff play a pivotal but much underappreciated role in managing and controlling noise nuisance. How many door staff will employed? What time will they finish? What will be expected from them? The application does not address this concerns.

14. Conditions 2 under Annex 3, The prevention of Public Nuisance requires:-

'Doors and windows shall be kept shut during regulated entertainment to reduce noise breakout. A management scheme shall be in place to ensure this situation remains.'

The applicant wishes to extend the hours of regulated entertainment therefore I would expect the applicant to provide supporting evidence of how this condition will be complied with.

15. Conditions 2 under Annex 3 requires:-

'The volume of amplified sound used in connection with the entertainment provided shall at all times be under the control of the licensee/management.'

Whilst this condition may have been suggested at a previous hearing it is no longer relevant given the history of noise complaints at these premises since the condition was imposed on the license. To comply with this conditions requires over reliance on a individual judgment, whose opinion might be bias, misinformed or misguided. The installation of effective noise limiters will eliminate the uncertainty of manager control.

16. Part 3 of the application ask applicants to state the nature of the proposed variation, the applicant has written:-

'All other licensable hours, activities, including the currently permitted times for the upstairs area of the premises, and conditions are to remain the same'

The 'upstairs' area is not currently licensed by Torbay Council and to my knowledge the upstairs area comprises of living accommodation. This appears to be another error in a poorly throughout application.

- 17. There are no existing conditions nor has the applicant suggested any further conditions to manage noise from customers. Will the beer garden remain open until 3:00am? Will numbers be limited to reduce noise breakout? Will smokers be allowed to smoke on the street and how will they be monitored and managed? No though has either been given to how dispersion of customers at 3:00am will be managed. A simple sign advising people to be respectful of neigbours at the exits is not enough. People in the street if associated with a given premises are still the responsibility of the premises, a concept rarely understood by licencees
- 18. As this variation is for the life of the licence if accepted I would like to draw the committees attention to the concerns of how this premises is managed. The proposed variation if accepted gives me cause for concern as these changes will be for the life of the premises. Punch Taverns struggles to retain managers appointed by Pub Solutions. Since 2007 8 separate managers (who also act as the DPS) have managed the Bolton Hotel (please see appendix 2).

The longest a manager has worked at the premises is 27 months with the mean being 11.5 months over a 9 year period. Whilst the Council has not officially received a complaint about the management of the current DPS, the high turnover of managers does not instill confidence future managers will runs the premises in a manner that promotes the licensing objectives. A number of previous managers undermined the licensing objections resulting in numerous interventions from Officers of the Council and Devon and Cornwall Police.

### Conclusion and Recommendations

- 19. The applicant has failed to submit a variation application that has considered Torbay Council Licensing Statement of Principles consequently if granted as applied for will undermine the licensing Objectives 'The Prevention of Public Nuisance' and 'Prevention of Crime and Disorder'.
- 20. The lack of prior consultation coupled with the consistent and significant errors and omissions in the applications leads to me believe neither the applicant nor its agents and managers in place have taken the consequences of the proposed variation seriously.
- 21. I therefore respectively ask members of the licensing sub-committee to refuse outright the variation application as applied for on the grounds the application will undermine the licensing objectives 'The Prevention of Public Nuisance' and 'Prevention of Crime and Disorder'.




Fig 3-3D Street view demonstrating elevation of surrounding environment, the Bolton Hotel sits in a former river bed.





Fig 4 – Noise attenuation distance map

To The licensing authority of Torbay council,

I have been the License holder and DPS for JACKZ Bar for 18 years now, I take my roll at JACKZ very seriously and work all of the late shifts that my establishment are open till 3am, mainly to ensure public safety and to make sure we are not annoying our neighbours with loud unnecessary noise whether it be due to music or customers as they leave , this is the difference between myself and The Bolton Hotel, I have something to loose should I not follow all the licensing regulations - I could loose my business, my income, my livelihood, The Bolton Hotel however is owned by Punch Taverns a large Brewery, they do not run the pubthemselves, they have tenants or leaseholders, however this is not the case with The Bolton they have been trying to get somebody to buy the lease since 2010, (I know about this as I also have a leased pub from Punch Taverns called The Skipper Inn) I have been asked by Punch on numerous occasions to take on The Bolton but due to its reputation and clientele that it attracts have always declined. The Bolton for the last six years has been in the hands of a holding company "Pub Solutions" which run pubs on the

behalf of The Brewer -, in this case Punch until somebody comes along and wishes to buy the lease.

Pub Solutions put there managers in these pubs to run for them, they have nothing to loose, if they don't fit or they have a problem with them or licensing has a problem with them, they put somebody new in there. There has been 7 DPS in the last 6 years . In 2012 Gara The DPS was glassed in there and his offender a female was sent to prison the next DPS was removed there were various stories but you are not normally given 24hours to get out for something minor. In 2013 Ms Bases became DPS at the Bolton, that was the beginning of a nightmare 2 years, she was violent towards other customers in other pubs, the police were informed of violent behaviour both physical and verbal to members of the public, I myself had to bar her for attacking my customers. The latest DPS Mr Com, I haven't had a problem with him but how long is he going to be there? Does he work in his pub, is he there every closing time? No , he likes to go out weekends to and enjoy himself - He could also leave at any time, when we had problems with Ms Battern, I and lots of other licensees and members of the public contacted "Pub Solutions" by letter, email and telephone, nobody received a reply or even an acknowledgement, this is hardly showing responsibility is it. I myself as a Punch leaseholder spoke on various occasions to my and the Boltons Business Relations Manager to try and sort out the problems occurring in this pub, nothing ever changed.

### PUBLIC SAFETY

To have the same closing time as JACKZ Bar would be an absolute catastrophe waiting to happen, at the moment The

Bolton is open till 1.30am, which means that there clientele have dispersed (up to 170 people) by the time that I close my premises between 2am -3am, should we close at the same time that would be near to 300 people being on Bolton Cross at the same time, this is going to be a massive public safety issue and noise will be practically impossible to control. There has never needed to be a huge amount of police presence in Brixham at this time of night as we have always made sure our doorman have waited for our customers to disperse and should there be any problems to resolve them quickly and effectively, this would not be possible should the numbers treble.

### **NOISE ISSUES**

For the last 7 years there have been lots of noise issues with myself and The Bolton, music being the main problem, we have a lot of residents behind us on a complex called Saxon Heights, I worked together with the council and put in secondary glazing and made sure all doors and windows were closed and I went on to install air conditioning. The Bolton just opened all there Windows and doors to let air in in the summer, so we still had noise complaints, so I gave up and stopped having DJ s and any other kind of amplified music, so there was no way it could be me, when the previous DPS went so did the noise complaints. The new DPS Mr like myself just had background music apart from the occasional Friday and Saturdays, I still get the neighbours phone up asking if it's me but because it stops at midnight they do tolerate it to a certain extent, Do we really need live music and Djs to be playing till 1am again to start the noise complaints all over again?

## CRIME AND DISORDER

Over the last few years there has been crime and disorder outside and inside the Bolton Hotel where the police have had to attend on various occasions, they have 2 doorman, consisting of 1 young girl and one doorman in his late 50s and that's it for 170 people, there has been a considerable amount of fights outside and inside the pub, where ambulances have been called and this is within normal trading hours, are the police going to be able to be present all weekend at closing time, especially in the summer periods when Torquay and Paignton are busy? Should they have to be really?

I hope my points will be taken seriously and that you do not think I'm worried about it having an impact on my trade, that is definantly not the case as I would seriously could say that at least half the trade from The Bolton are barred from my premises and actually a lot of premises in town.

Application for extended hours at Bolton Hotel, New Road, Brixham by Punch Tayerns. (SRU/226898 ?)

I wish to register my concern and opposition to the application for extended hours at the above premises. I live a little way up the road, perhaps 200 yards, and am concerned that the extra drinking hours will bring rowdiness and antisocial behaviour.

The Hotel is situated in the heart of the town and is surrounded by residential premises in a "bowl" situation. When, long ago, the Parkham Hotel, New Road, (now Saxon Heights) had a late night licence, the fall out was dreadful. We live opposite the exit and were subjected to antisocial behaviour in our door way. Noise from drunken people leaving was audible all the way up and down the road and nothing was ever done about it, apart from an occasional policeman's presence which did little to the sound levels of raised voices.

I fear this will again happen just down the road if the Bolton Hotel has an extended licence, plus the sound of late night music as their windows and doors are often open. As this is restricted to earlier hours at the moment it doesn't give me much bother but I know it does to others living nearer.
