Summary and context for Adult Social Care:

- The commissioning of Adult Social Care by Torbay Council from the TSDHCT (former care trust) has been agreed for 2013/14 by approval at full council in February the Annual Strategic Agreement which set out outcomes and performance to be achieved within the allocated budget and the roles and responsibilities for the financial year of commissioners and providers.
- This is set within the context of TSDHCT being in the process of acquisition by another Foundation Trust. The council has a working party which relates to an overarching project board which will steer the project of acquisition. This includes a further presentation on the overall transformation and business case to all elected members on 10 April 12. Although there is some delay in parts of the process it is hoped that the overall timetable can still be adhered to.
- The Council is still committed to integrated health and care and there are a number of processes and which are being reshaped to drive the needed innovation locally to develop the system for future needs.
- The council has set the fees for care homes locally by an all council decision on February 13. We continue to work with care homes on the implementation of that decision.
- There is an opportunity to work with the voluntary sector on combating isolation as experienced by older people that is currently being explored.
- The health and care 'system' hosted a select committee visit in the bay which explored issues of the health and care bill, and leaders are also exploring how Torbay may become a pilot for innovation as part of the development of 10 national pilots as determined by the minister Norman Lamb MP.
