3. Consultations

Torbay LAF commented on the following national and regional issues:

- The Future of the Public Forest Estate in England, with the LAF playing a leading role in the regional response thanks to Bob Harvey's concerted efforts
- Torbay Green Infrastructure Plan
- Role of the England Access Forum

4. Training

A successful LAF training day was held on 21 March 2011 at Occombe Farm, organised by Natural England and Hilary Winter. A member of the Dartmoor LAF also joined us for the day.

5. Regional meetings

LAF member Bob Harvey attended a regional meeting of LAF Chairs with Natural England's Regional Manager.

6. Support

The LAF supported a bid by Torbay Coast and Countryside Trust for a Woodland Improvement Grant from the Forestry Commission that would create improved access routes through Scadson Woods. The bid was successful.

7. Rights of Way Improvement Plan

The LAF continues to monitor the ROWIP, receive reports from the Rights of Way team and to advise Torbay Council on priorities for the future. The LAF sought assurances from the Council that the role of PROW Officer was being maintained in the Council's new structure and was pleased to receive these.

8. Advice

Various issues affecting rights of way and open spaces in Torbay were commented upon by the LAF including:

- Footpath diversion adjacent to Astra-Zeneca, Brixham
- Installation of cattle grids at Berry Head, Brixham
- Circular walking routes promoted as part of the new Geopark Trail Guide
- Impact of the Churston developments on PROW
