Question (3) by Councillor O'Dwyer to the to the Cabinet Member for Infrastructure, Environment and Culture (Councillor Morey)	Is the Council in breach of the Equalities Act, given there are some unpassable and inaccessible public pavements for elderly or disabled residents across the bay, when it is reasonable and reasonably easy to provide alternative options of widening said pavements or for example removing offending obstacles. What are the requirements of the Acts in this respect regarding public spaces and highways?
Councillor Morey	Under the Equality Act public authorities, including highways authorities, are required to have due regard to the need to eliminate discrimination, and to achieve equality of opportunity between disabled and non-disabled people in the exercise of a public function. As a consequence there is a duty to make reasonable adjustments including changing practices, policies and procedures which have a discriminating effect. At present that authority has a specific budget for disabled access, however, this is generally used for drop curb crossings that assist the mobility impaired or those with mobility scooters, and people with pushchairs/ prams, etc. The current budgetary situation restricts the wholesale widening of all footways and in some cases there is insufficient road space to allow this, especially in the older areas of the bay. However capital and Section 106 funding does allow some improvement works where appropriate. We also take advantage of any scheme to provide better facilities and to reduce the amount of on-street clutter, i.e. remove unwanted signs and sign poles, or relocate signs on to street lighting columns, removing associated poles to widen the available width of footway areas. I would be happy to discuss specific examples where access is considered to be restricted and then explore with the relevant officers the scope to improve the situation, in addition to the ongoing activities highlighted above.

Question (5) by Councillor Chris Lewis to the Cabinet Member for Infrastructure, Environment and Culture (Councillor Morey)	The proposed Torquay Road zebra crossing opposite Preston Conservative Club and Pembroke Surgery is important to residents and vital for safety reasons. At Council on 18 July 2019 the Interim Director of Place in consultation with the Cabinet Member for Infrastructure, Environment and Culture were requested to consider a relevant business case for a pedestrian crossing on Torquay Road, Preston within 3 months. Can the Portfolio Holder for Infrastructure, Environment and Culture please provide an update on the proposed pedestrian crossing?	
Councillor Morey	I am very pleased to announce that the capital funding has now been approved for this new signalised pedestrian crossing, the implementation of which was requested by the community and supported by the local ward members. It is envisaged that the new crossing will be in place before next summer.	

Third Round

Question (6) by Councillor O'Dwyer to the Cabinet Member for Economic Regeneration, Tourism and Housing (Councillor Long)	The wholly owned housing companies were agreed in principle to be transferred in December 2018 to the TDA and building progressed at speed with the grant of funding, can you provide an urgent response on their progress and the current status of the new registered housing provider? What planning permissions have now been granted, what land has been transferred to them so far and for what consideration. A Chief Executive decision titled 'Allocation of Affordable Housing Budget' published on 7 December 2017, provides up to £100,000 from the Council's Affordable Housing budget to the Housing Company to fund the necessary works to obtain planning permissions on sites at Totnes Road and Redwell Lane, I believe only one of these sites was progressed to a full planning application and according to Companies House the Housing Companies
	themselves never spent any money. Could you advise the Council as to the current position with regards to this £100,000 allocation?
Councillor Long	Further to the report on housing presented to Council in July
	2019, TDA are currently working on a submission to achieve Registered Provider status. In line with the July report TDA will bring forward detailed business cases to enable the loans for housing developments to be drawn down. The operating agreement has been agreed between the parties and the loan agreement is currently being finalised. These documents will be presented to the TDA Board for consideration at its meeting on 6 November 2019

	With regards to the second element of your question. Council has previously approved the transfer of three sites to the TDA at nil consideration apart from nomination rights (on basis that it is no longer proposed to transfer Redwell Lane). Totnes Road has a planning permission. St Kildas has had a pre application submission and further design work is currently being carried out. Torre Marine has a permission from the previous owner but a new permission is required. Following consideration of the Operating Agreement and the Loan Agreement by the TDA Board, this will allow the Operating Agreement to be signed, and the Working Capital Loan to be drawn down in order to fund the required works to progress all three sites. In answer to the final element of your question. The £100,000 approved by Council is part of the Council's capital plan. To date less than £5,000 has been spent but this funding was allocated to the Councils Housing Company, <u>not</u> TDA. However £102,000 has been spent or committed by TDA on these sites. The signing of the operating agreement and the draw down of the Working Capital Loan will allow the further work required to deliver the sites to be undertaken.

PATH is at the heart of our support network for homeless and most vulnerable and have been for nearly 4 years. If no accommodation
Tourism and Housing (Councillor Long)	is found for them to continue their amazing work after 23 November they will be forced to close and the people they are helping will be forced to fend for themselves without the support of PATH.
