#### **Care Quality Commission**

The Care Quality Commission has now published its report entitled' Monitoring the use of the Mental Capacity Act Deprivation of Liberty Safeguards in 2013/14'.

#### The report says:

- a) There will be a greater emphasis placed upon the implementation of the Mental Capacity Act and the Deprivation of Liberty Safeguards within standards and the inspection process.
- b) Providers are required by law to notify CQC of applications submitted to deprive a person of their liberty and the outcome of the application (Regulation 18).
- c) Providers are required to notify the Coroner, where a person, who has been subject to a granted Standard Authorisation, dies. The new forms, accessible via the link above, incorporate a specific form to support this process.





## Palliative Care in Care Homes

Funding secured for end of life care project Congratulations to the Palliative and End of Life Care team (led by Carol Gray, strategic lead, and Louise Davies, care home facilitator), who have secured funding of £5,000 from the Queen's Nursing Institute and the Burdett Trust for their pilot project aimed at improving the standards of end of life care for residents in care homes.

The pilot is in response to the recent publication of the "One chance to get it right" document from the Leadership Alliance for the care of dying people, NHS England (2014) where recommendations are made to deliver training for care staff involved in caring for people at end of life. The project will comprise of the delivery of an end of life care programme for care staff who are involved in caring for people at end of life.

The course content will encompass all aspects of end of life care delivery concentrating on the 5 priorities for care for the dying person, which are Recognize; Communicate; Involve; Support; Plan and Do.

Research suggests that there are several factors which contribute to sub optimal care being delivered in care homes, the single most important factor being inadequate training of staff at all levels. Following the delivery of this program it is hoped there is evidence of an improvement to the standards of end of life care offered to residents in care homes; therefore, positively contributing to the overall experience for residents during their end of life journey.

# **Nurses in Social Care Conference 25 February**

Nurses play an increasingly critical role in adult social care, yet recruitment, skills and integration can be challenging for employers from across the country and the situation in the South West is no exception. The day was developed in conjunction with partners including the Association of Directors of Adult Services, the Care Quality Commission and Skills for Health and consisted of guest speakers from Health Education South West and the Registered Nursing Homes Association.

It will include Financial guidance, including a pathway to access the spectrum of financial support, with a script to use to confidently relay this information. For example, to be more confident in how and when to support people to seek information from the Citizens' Advice Bureau, Age UK, the Government's Money Advice Service, Independent Financial Advice or Registered Independent Financial Advice.

"I have fought the corner for primary care as best as I have been able and used my role to reinforce the need to invest, expand and find better models for the future. I am sure that my successor will do the same.

Sam was awarded a CBE in the Queen's Birthday Honours last summer. Before working as a GP in Brixham, she was an anaesthetist in London acute trusts. She was also named as one of the Top 50 most inspirational women in healthcare by the Health Service Journal.

#### **Volunteer success for DASH**

The Biscuit Club, set up by DASH (District of Ashburton Surgery Helpline), introduces families to an elderly person, encouraging conversation between the generations and helping to combat isolation. Following a winter recruitment campaign, the Biscuit Club had 14 families offering to take part in the scheme and with recruitment still running, more are expected to follow. It has also had a number of people volunteer their services to help local elderly people with various tasks, such as shopping and dog-walking. The Biscuit Club was featured on BBC Devon on Saturday 7 February, so that is expected to raise more interest.

This is a fantastic result for the local community and is exactly what we want to be seeing in our plans for looking after people's wellbeing and making sure they are not lonely or isolated, with the associated negative impact on health.

DASH is now looking at getting local practices to help with referrals to the Biscuit Club so that those who would benefit most from these social visits can get access to the service. More information of how the club works is here.
