I refer to an application made by the above premises to Vary the Designated Premises Supervisor into the name of Zhong LIU.

The nominated DPS, Mr LIU, although the holder of a current Personal Licence (number 367679 issued by Rhondda Cynon Taf CBC), has been seen at the premises regarding the requirements of the premises licence and the licensing laws in general, by Julie Smart, one of my Licensing Officers.

Mr LIU was only able to converse with my officer through a male interpreter who was present at the time and it was clear that Mr LIU had difficulties understanding and speaking English without the assistance of an interpreter. It is clearly evident that Mr LIU had little or no command of the English language. Therefore the view of the police is that he would not be able to adequately carry out the duties of a Designated Premises Supervisor and because of this, there is a likelihood that this would undermine the Licensing Objectives.

Based on these facts, the police object to the application to Vary the DPS under Section 37(5) of the Licensing Act 2003.
