I refer to an application made by Tracey Wilcox and Tomas Cornaglia Solas for the Transfer of the Premises Licence (Licence No 670) in respect of the above named premises into their joint names, received by the police on 1 September, 2008.

The police consider that the granting of this application would undermine the crime prevention objective on the grounds that the Torbay Council Licensing Committee, sitting on 4 September 2008, decided to revoke the Premises Licence following representations from the police.

The reasons for this decision included the fact that Tracey Wilcox had demonstrated her lack of ability to uphold the four licensing objectives, and the committee could not be satisfied that she understands her responsibilities as Premises Licence Holder, following numerous beaches of the conditions of the licence.

The police would like to make it clear that at this stage we know nothing to the detriment of Tomas Cornaglia Solas, and therefore have no grounds for an objection on his part.
