## **REVIEW OF CEMETERIES**

### Decision Taker

The Executive at its meeting held on 13th September 2005.

### Decision

- (i) That the Council supports Torbay Coast and Countryside Trust in their development of a green burial site within the confines of the new Conqueror Wood;
- (ii) that the Assistant Director (Environmental Health and Consumer Protection) be requested to approach Teignbridge District Council to ascertain whether they would be interested in entering into a partnership arrangement for future burials;
- (iii) that the Department for Environment, Food and Rural Affairs be advised that this Council intends to install appropriate mercury abatement equipment to the cremators by 2012 in order to reduce mercury emissions by 50%;
- (iv) that the Assistant Director (Environmental Health and Consumer Protection) be authorised to invite tenders from management companies to enter into a partnership agreement with the Council for the management and maintenance of the cemeteries and crematorium;
- (v) that a clause be included in the partnership agreement to ensure that fees and charges may not be increased without the prior approval of the Council;
- (vi) that the management company be encouraged to provide a wider range of memorials to give people more choice in the way in which they can remember their friends and relatives;
- (vii) that two representatives from the Cemeteries Review Panel be nominated to serve on the tender evaluation panel; and
- (viii) that consideration in relation to the possible development of a new cemetery site be deferred for further investigation within a period of not more than 12 months.

#### Reason for Decision

To respond to the request of the Overview and Scrutiny Board.

#### Information

The Cemeteries Review Panel undertook a review of cemeteries to ensure that Torbay Council had in place appropriate measures to secure future service delivery in relation to cemeteries and crematorium, which would reflect the needs of the local people of Torbay.

It examined the provision currently operated and maintained by the Council and sought the views of local people on the type of burial and memorial facilities and the location of such facilities they would like to be provided.

The Panel undertook consultation to ascertain the views of the public, funeral directors, memorial masons and faith groups in relation to the current service provision and their suggestions about how the Council could improve the service.

### CONTRACT - PROVISION OF TEMPORARY ACCOMMODATION AT LINTON HOTEL, ELMSLEIGH ROAD, PAIGNTON

### Decision Take

The Executive at its meeting held on 13th September 2005.

### Decision

- (i) That a block contract for temporary accommodation for ten homeless households be granted to the proprietors of the Linton Hotel, 7 Elmsleigh Road, Paignton, such contract to stipulate that the accommodation would be for families with children and that the use of the premises would be for a trial period of one year;
- (ii) that the Assistant Director (Housing) be requested to meet with the Executive Member for Housing and Leisure on a quarterly basis to provide him with a monitoring report in relation to the use of the accommodation;
- (iii) that an officer be nominated to engage with the local community and to communicate his/her findings to each of the meetings referred to in (ii) above;
- (iv) that a communications exercise be held at the earliest opportunity to ensure that the local community are fully aware of the Council's decision; and
- (v) that the Strategic Director for Community, in consultation with the Executive Member for Housing and Leisure, be authorised to approve the transfer of any similar spot purchase contracts to block contracts, where it is deemed appropriate.

#### Reason for Decision

To convert provision from spot purchase to a block contract, where the Council becomes the lessee, allowing higher levels of Housing Benefit subsidy to subsidise the provision and to allow the Council to negotiate more cost effective contracts with service providers.

#### **Information**

Report 282/2005 requested Members to give consideration to the provision of temporary accommodation for ten homeless households at the Linton Hotel, 7 Elmsleigh Road, Paignton.

#### Alternative Options considered and rejected at the time of the decision

To continue to spot purchase at higher cost and risk a continued breach of the Office of the Deputy Prime Minister requirement that homeless families do not stay in Bed and Breakfast accommodation for longer than six weeks.

## SOUTH WEST REGIONAL SPATIAL STRATEGY – TORBAY COUNCIL'S FIRST DETAILED PROPOSALS

## **Decision Taker**

### Decision
