Torbay already has one of the best results in the region for smoking cessation amongst manual groups and services have been actively placed in areas of greatest prevalence, e.g. the high street Stop Smoking shop. GP surgeries have been set targets for smoking quitters which are calculated on the basis of practice population prevalence and higher awards are achievable in high prevalence surgeries. Results shown below prove that proportionally, more successful quitters per 100,000 population are being seen through the service from one of our target communities.

Results show that greater proportions of mothers from target wards continue to smoke during pregnancy. Whilst we offer a universal service to all expectant mothers, we do target a number of interventions at particular venues and target audiences. The Family PartnershipTeam has been trained to provide full support to quit for the most vulnerable women (and partners) with carbon monoxide monitors to check unborn. Education sessions are given by the Care Trust team at Stonecourt, Stoneway and young parents training (through Paignton children's centre). Looking at maternity datasets for April to December 2009 we have been able to calculate the proportions of mothers who were smoking at booking in but successfully quit during their pregnancies. Results are still poorer in our target wards (see proxy data above).

It is unlikely that the national requirement for a halving of the 1998 Teenage Conception Rate by 2010 is achievable for Torbay. We have seen a continual increase in our rate and exceed the UK average. In 2008 the overall Torbay rate was 64.9 per 1,000 compared to 40.4 nationally. Ward level data is not yet available for 2008.

This is a complex issue with solutions required from a variety of strands. Within the health strand, the focus is on sexual health services and the supply of free condoms through our C-Card scheme is suggested as a measure of progress.

Targeting to hotspot areas has been a feature of service development in relation to sexual health for some time and continues to be a key principle for action on **teenage conceptions**. Additional young people focused contraceptive/ sexual health services have been added in central Torquay and Paignton and there is now a specific young persons clinic in each of the three towns including a Saturday drop-in in Torquay. The Health Wize shop has been opened on the high street in Torquay and is the first venue in the South West to receive 'You're Welcome' accreditation. Positive feedback has been received from the National Support Team in relation to improvements made in sexual medicine provision and the rate of Chlamydia screening in Torbay is one of the best in the South West. South Devon college has appointed a youth worker through dedicated funding from SHA and the team leader for the Sexual Health Outreach team has commenced. PSHE Advisor post taking forward a strong delivery of SRE by schools with a focus on schools identified by Teenage Conception data analysis. Triple P programmes are in place for targeted parents. One of the short term measures of progress on this topic is our condom distribution scheme. This was introduced in January 2008 and now has almost 1,000 clients registered who can pick up condoms from 52 venues across Torbay. Analysis of the registered clients as a proportion of the 15-19 population shows higher rates in target wards.

The rate of admissions for alcohol related illness has been rising steadily over the last few years. For Torbay overall, reduced inequality will be evident when this continued rate of increase is halted and declines. Around 10% of the gap in Life Expectancy for men in Torbay can be directly attributed to liver disease. Substantial increases in the **Alcohol** service have been funded by the Care Trust over the last three years and include a primary care alcohol service, hospital based workers, alcohol screening, early interventions and community detoxification. A specific worker for young people has been appointed and there are peer support groups. A targeted alcohol worker is working with GP practices and an assertive outreach worker is providing additional support for vulnerable individuals who disengage from alcohol treatment. Provisional data for 2008/09 shows that the rate of admissions has slowed considerably and the Care Trust has exceeded the target set by the Strategic Health Authority.

Within the Night time economy (NTE) of Torbay the following mechanisms have been put into place:

- The strength of the NET team has been increased to 1 Sergeant and 10 Police Constables.
- More intrusive and robust monitoring of problem licensed premises has been implemented including the roll out of a new police proforma in order to gain intelligence from individuals who have been arrested for violent crime to build a picture of where and how much they have been drinking in order to enable close monitoring of problem premises.
- Ongoing training for door stewards in conflict resolution. It is also intended to roll this out to volunteers within the NTE area such as street pastors and bus volunteers.
- Ongoing use of Knife arch and metal detector wands within the NTE.
- Street pastors have now been introduced in Paignton and their numbers have been increased in Torquay.
- The use of other Police powers such as Sec 27 notices issued when a potential problem person or group is identified. The individuals can be issued a notice to leave the area for a period of up to 48hrs, a very useful tool in early intervention.
- Increased use of Nite-net radios to prevent individuals from entering premises who have already caused or may cause a problem creating a one team culture with all radio carriers around the area.
- Ongoing Operation Croft which sees the use of passive drugs dogs and a drugs itemiser within the NTE area.
- Various improvements have been made to design out crime such as the erection of new lamp posts and the removal of shrubbery which has had the effect of reducing crime and disorder while increasing visibility for CCTV operators. Further improvements to lighting are being evaluated.

Over the last couple of months The Street Team has been working within the Foxhole, Paignton area on a Friday evening between 1900–2200hrs. We set up the Boxer at the side of a large grass area, which then enables us to set up the football equipment. During the session we engage with approx 30-35 young people from the immediate area with ages ranging from 12-17 years old. Football is having the biggest effect on the young people with games of up to 22 youths male and female engaging in the activity during the evening. The rest of the young people are either watching the game, on the Boxer or involved in film making projects led by the YCAP workers. Recent Statistics have shown a large reduction in ASB and underage drinking within the area on a Friday evening.

Inside out

The health and well-being pilot Inside Out was launched on 1st October 2008. The aim of the service is to promote the emotional well-being of offenders who are currently under the supervision of DCPA. The service is jointly commissioned by Supporting People and Probation (and the DAASHt will contribute to the cost from April 2010) and is delivered by Rethink, the annual cost of the service is £60,000.

The service offers a twelve week structured intervention to look at an individual's well-being. The service is designed to work with people around both their emotional and healthy well-being, assisting them to replace poorer lifestyle choices with healthier, more sustainable options. The service also provides more detailed support in relation to tenancy sustainment, finance, benefit and debt and counselling support as required. Some of this work is provided through sub-contracting arrangements with the Cool House for the provision of counselling services to clients (26 referrals made), as well as with Homemaker South West (24 referrals made) who provide a debt counselling service.

The service has also addressed a significant range of support needs related to substance misuse, with 33 of the 45 people supported experiencing significant drug and/or alcohol problems. The service has assisted individuals to identify problematic drug and alcohol issues and to seek more specialist support, whilst also supporting people during and after specialist treatment.

Current funding commitments suggest that delivery of the service will be extended until January 2011.

The service has worked with 45 people during the 12 month pilot.

The service is valued by clients who have used the service and by offender managers. Anecdotal feedback suggests that the opportunity for counselling, or the one-to-one work provided by Inside Out is often the first opportunity clients have had to feel listened to. Clients have made positive steps in a number of areas, including engaging with drug and alcohol treatment, ETE, through engaging with the support available to them from Inside Out.

Of the 29 clients who had completed with Inside Out, 27 had not had re-offended. This is a re-offending rate of 6.8% which is significantly lower than the current rate of re-offending in Torbay which is 9.10%.

- Classified as an 'area of deprivation', many environmental and social issues are evident in Hele. An existing project to tackle a
 number of these issues is currently being delivered. One aim of that project is to bring together statutory agencies and partners to

deliver targeted services in the community. As the national clean up charity Keep Britain Tidy has selected Torbay as a pilot area and provided the Council with free training and materials to deliver the 'Tidy Business Awards', it has been agreed at a local level that this work should be delivered in Hele, to compliment the existing project. Historically high profile environmental clean up projects in Torbay have been targeted at 'highly visible' areas to both residents and visitors such as town centres and beaches. By focusing the Tidy Business Awards pilot within an area of deprivation, it will attempt to 'close the gap' by refocusing resources in area with a greater need, with the expected outcome of empowering the community (i.e. businesses) to sustain an improvement in local environmental quality.

• Environmental quality in the area of Hele, Torquay is a problem. Hele is an area which is heavily littered and this litter is present on not only the public highway, but also on private land (including gardens). A diverse range of businesses are located in Hele including the offices of the local newspaper. Those businesses include a frozen food supermarket, newsagents, chip shop and garage. Many items sold from these businesses become litter in the area. On the periphery of Hele is a large fast food restaurant and drive-thru, which again contributes to litter in and around the area. Schools and Colleges in the area also compound the issue due to 'youth litter' and this will be addressed with one school as part of this project/pilot. In addition to littering, local environmental quality relates to other environmental crimes such as graffiti and fly-posting. The Tidy Business Awards encourage businesses to tackle these issues by ensuring that environmental crimes are dealt with promptly to discourage further defacement of the environment.

.From the NI report produced by the School Food Trust, Torbay primary schools had a 30.8% take up. The information was collected from 29 of 35 schools (82.9% coverage). The 35 schools included 32 primary and 3 special schools.

In Torbay for secondary schools there was a 45.9% take up. The information was collected from 5 of 8 schools (62.5% coverage).

Pricing structure within the central contract with Eden

A major drawback on a growth of the service for the paying customer will be the cost of the meal. Advice received and experience from other LAs is that once the £2 barrier is crossed the paid meal-take up decreases. The current cost of a primary meal in Torbay is £1.90 for a 2 course lunch. The paid meal is subsidised by the free meal costing the schools in the central contract £3.35 per meal. This was a deliberate policy decision to underwrite the service with a higher FSM price and to keep the cost of a paid meal below £2. Increase in meal price is likely to remain a barrier to further growth. In the central contract Eden have a marketing strategy delivered through a range of initiative which is aimed at increasing uptake of paid and free meals.

Working with Eden on marketing/ promotional activities

The range of marketing activities currently being employed by Eden Foodservice to improve uptake includes:

the production of a full colour menu available to each parent in every school

being present at school open days and similar events eg the recent Cockington and Brixham C of E primary openings of new buildings involving the press with the Mayor taking a meal at Galmpton in September

actively encouraging schools and caterers to request Heart Radio to visit their schools on their current tours to schools each Wednesday to look at lunch services

promotional initiatives such as competitions to win calculators and design a Christmas card

attendance on school council and SNAGs (School Nutrition Action Group),

the offer of free tasters, inviting parents in to see what is on offer and general encouragement at the counter.

Improving meal production methods and choice

"Zip and Steam"

A new initiative that has just been introduced at Sacred Heart primary is what Eden refer to as their "Zip and Steam" system. This is for servery schools that do not have kitchens on site and where meals are packed and delivered in. There can be quality issues in transporting food. Hopefully vegetables that are not overcooked, that look and smell attractive are more likely to be eaten and so will add

to pupils 5 a day intake. Eden purchased a commercial microwave for Sacred Heart and now frozen or fresh vegetables are transported in and then cooked on site. Early signs are that this is proving beneficial. The decision was made to roll this out to 3 other schools so Warberry, Priory and St Margaret Clitherow schools now also have microwaves and the system has been introduced and is being well received.

The current contract menu being offered is a 3 choice, 2 course meal and Eden nutritionally analyse this to ensure that it meets the nutritional standards and they assure us that their menu exceeds the same. This gives the authority, schools and parents alike the assurance that every child who takes a school meal will be given a healthy and nutritionally balanced meal whilst at school. This approach is core to the "Every Child Matters" agenda

Torbay Healthy Schools programme calls for schools to develop a whole school food policy which involves parents and pupils and to offer lunch services that meets the nutritional standards for school lunches. Moderation visits on 10% of successful schools is implemented to ensure consistency. General guidance on healthy packed lunches is given although there are no legal powers available. Schools are no longer able to offer crisps, chocolate or fizzy drinks to pupils as either part of school lunches or food other than lunches (eg food available by vending in secondary schools, breakfast clubs, tuck sales, etc). Schools have additionally had to change the products offered to pupils in order to obtain healthy schools status.

Free School Meal Entitlement

One of the important pieces of work is to try to ensure that all parents/guardians of children who are entitled to claim a FSM know that they have this entitlement. To try to ensure that registration for FSM is as comprehensive as possible officers from Connections and CS have agreed that:

All residents who contact Connections will be made aware of their FSM entitlement based on benefits information given Residents will have the form filled out as part of their interview and signed if personal callers or sent via post if telephone callers School Meals administration will verify entitlement via DCSF website.

Letter confirming entitlement will be sent to parent and school.

Renewal will be automatic unless a parent informs the School Meals section their circumstances have changed Renewal will be every 12 months and renewal information will be included in the annual benefits notification letter. Connections to send a complete list of benefits claimants to School Meals Section to cross reference against those registered for FSM. Any parent not registered but entitled will be sent a letter and form encouraging them to register for FSM entitlement.

School Food Trust/Football League promotion

The aim of the project is to increase school meal take up in the South West as this is recognised as an area with lower take up than

national average by using a marketing campaign to engage pupils with a theme they are familiar with this being football.

The Football League Trust are running the project on behalf of the School Food Trust in ten of our primary schools for six weeks commencing in January. The schools taking part needed to be engaged with the project and be willing to participate. They also need to complete weekly totals of their school meal take up and be willing for some media attention.

The approach will be a low impact method to establish the link between the football club and the participating schools. This takes the form of an interactive competition between the schools linking football with school meals. Prizes and football tickets will be available as well as a visit to the stadium for one class from each school.

We have so far had results from 5 of the 6 weeks. This shows that in week 5, 9 of the 10 schools had a free meal uptake of over 77% (77% to 95%). Cockington had an uptake of 72%. For 8 schools the overall total meal uptake based on roll (minus nursery numbers) is above 38% being between 38.3% (Kings Ash) and 60% (Watcombe). The other 2 schools have uptakes of less than our National Indicator NI 052 return being 18.9 % (Eden Park) and 28.6% (St Marychurch).

FSM entitlement pilot

An expression of interest has been lodged with the DCSF for a universal free meal provision for pupils at six primary schools, Cockington, Ellacombe, Upton, Barton, Watcombe and King's Ash. This would give all pupils in these schools free school meals from September 2010 to July 2011. The outcome of the expression of interest and whether Torbay are requested to move to a full bid is awaited.

School Lunch grant

The School Lunch Grant is a 3 year grant for schools to subsidise their school meal prices or costs of their school meal services. A proposal for 2010/2011 is that £7,500 of this grant is used for promotional activities across targeted schools for example, bring your parents to lunch, cookery demonstrations, feed the family for a fiver and promotional lunch days where meals are £1 or free.

- Torbay has high rates of self employment and business start up. This is likely related to the sectoral base with tourism and retail being dominant. A challenge is to reduce the failure rates of businesses and to broaden the sectoral base so that sectors including business services, technology, creative industries etc.
- Torbay has secured prioritisation in the EU Competitiveness funding programme which runs till 2013 for support to business creation. Activity supported through the programme is expected to have a bias towards the most disadvantaged areas of the Bay.
- Torbay has led the establishment of the Torbay & Sth Devon Employment and Skills Board. This brings together commissioners, providers and end users (businesses) of skills and will ensure that skills requirements and provision is better matched.
