Consultation on Outdoor Education, and the Youth Service, including the Duke of Edinburgh's Award Scheme, indicated that a change in management would provide an improved service.

Further consideration would be given to the management of the Early Years and Childcare service as part of the overall strategy for the development of a Children's Service and Children's Trust.
