2.	Welcome		Action
	KM welcomed everyone to the meeting.	Dogo 112	

3.	Minutes of the Last Meeting	Action	
	Everyone agreed that the minutes were an accurate record of the last meeting.		

4.	Matters Arising	Action
(a)	Town Dock V Pontoon - KM confirmed that the Harbour Committee has approved the purchase of a new pontoon for V Pontoon. This will cost between £160k - £200k. The plan is to install the new pontoon at the end of the summer to minimise the disruption to berth holders. ME commented that he has been down onto the pontoons this morning and it looks like further damage has occurred.	
(b)	Beacon Quay Toilets Refurbishment – Works are underway at present. KM advised that there has been an issue with a leak in the car park that may delay the completion of the works but the plan is to have the toilets open by the Easter holidays.	
(c)	Marine Conservation Zones (MCZs) – KM has been lobbying on this issue and has contacted local MP's. A proposal is expected from Defra to extend the area of the existing MCZ to protect the sub-tidal mud on the bed of the Bay. Such a conservation measure would most likely lead to a ban on ships anchoring in the area. KM is concerned because there are clear and significant economic benefit that result from vessels anchoring in the Bay. Economic impact data has been sent to Defra, local MP's, the BPA and the British Chamber of Shipping. CR commented that she believes there is not enough environmental evidence/data to support the protection of sub-tidal mud. MS asked whether this would stop vessels from anchoring in an emergency and KM confirmed that no details are available concerning the potential management measures but the Secretary of State's Representative (SOSREP) would be able to overrule in any event.	
(d)	Security Cameras - KM advised that this topic had been discussed at the Torquay Harbour users meeting that was held in December. No progression has been made further due to the uncertain future of Torbay Council's corporate CCTV network. A request from harbour users was made for CCTV to be introduced at the Inner Harbour entrance gate and along South Pier. KM advised that with the go ahead of the Pavilion Development scheme it is likely that further CCTV cameras will be introduced around the inner harbour areas by various new businesses. MS asked if it would be possible for the Harbour Authority to make a decision to invest in CCTV without Torbay Council and KM advised that it would be better to wait for Torbay Council to make decision. ME commented that he is concerned that if delay till after the summer this could be seen to be ignoring the requests of stakeholders and may mean another year without change. ME asked KM if he could chase Torbay Council further to make a decision. KM agreed. MR commented on the camera issue and raised his concerns over the threat over terrorism. KM advised that he has not received any requests to increase security. MSm commented that the marina is heavily covered with cameras and they have staff on site 24 hours a day.	КМ
	Other matters arising but not on the agenda -	
	DB asked if there would be any impact on the Inner Harbour with the Pavilion redevelopment scheme going ahead. Particularly in respect of the walls and the water levels. KM commented that these matters were covered by a planning condition and the developer will be required to ensure the walls are safeguarded against damage. DB asked if an environmental risk assessment would be carried out due to the risk to navigation. KM advised that surveys are normally carried out before and after a large development. DB said that the Inner Harbour is in flood zone 3. KM commented that the Environment Agency are a statutory consultee under the planning application process.	
	NB advised the Forum that the Harbour Authority reserve fund has been secured and they will not now be taken to support the Council's corporate deficit. KM thanked NB & VE for their support. Page 113	

5.	Capital Works	Action
a)	Princess Pier - Most of the work has now been completed and the capital funding has been spent on the underwater scour damage and seaward steps infilling.	
b)	Haldon Pier - A dive survey was recently carried out to investigate the current extent of the underwater damage. The evidence found will be put into a report and used by the TDA to support future funding applications to the Environment Agency. DB asked whether more rock armouring could help with the problems. KM explained that the main areas of concern were now on the inside wall at bed level.	

6.	Maritime Events 2017	Action
	KM asked SP to provide an update on Maritime Events for 2017. SP issued a copy of latest schedule and he explained that it would shortly be uploaded onto the harbour website. The Harbour Authority will increasingly be promoting events via social media going forward. Tor Bay Harbour website is currently being redesigned and there will be an updated events page. SP asked that if anyone is aware of any events not on the list to let him know as soon as possible so that it can be added to the latest list. SP ran through the main events for the year.	All to note
	MR advised that the Normandy Veterans would like to carry out their service on 6 th June, which will be a more low-key service than previously. NA confirmed that she and the Mayor are involved. MR asked that the event be added to the events list. KM confirmed he is happy with the service taking place on Beacon Quay but we need to know the size of the event to ensure the right level of staffing, etc. MR will confirm with Tony Ryder and the Mayor. 7.	Harbour Light Restaurant	Action
	KM advised that the TDA would be presenting a report to the Harbour Committee on 20 th March with proposals for the Harbour Light Restaurant at Paignton harbour. A structural survey has been carried out and architects have looked at the existing layout and are aware of flood risks. A restaurant will continue to be located on first level and on ground floor level, the proposal will be for shop units and a cafe. KM advised that under the new proposal the existing stores and boat booking board sites would be at risk. KM invited everyone who may be interested to attend the Committee meeting.	All to note
	TE asked what the intentions are towards the existing tenants would they be asked to leave. KM confirmed that the existing tenants would be compensated as tenancy agreements would end. However, existing tenants could tender for the new units. Discussions will be carried out with the existing tenants. TE commented that Paignton is a unique Harbour and it cannot be compared to Torquay and Brixham. Paignton harbour can be improved but not completely changed. KM advised the Forum that there are other plans for the future of the harbour including a large redevelopment of the south side of the harbour. The TDA are leading on this issue and will be contacting stakeholders soon but this is not for determination by the Harbour Committee on 20 th March. TE commented that there would be opposition received for the Harbour Light scheme. KM encouraged Paignton harbour users to attend the Harbour Committee meeting on 20 th March. KM advised that these redevelopment proposals are contained within the Tor Bay Harbour Port Masterplan. KM confirmed that if the Harbour Committee gives their agreement for the proposals, they would then be taken to full Council and/or the Mayor for a decision. NB confirmed that he agrees with the redevelopment.	All to note

	The Asset Management Plan 2017/18 will be presented to the Harbour Committee on 20 th March. There was very little change from the 2016/17 Plan.	
	KM advised the Forum that he had met with the Royal Torbay Yacht Club to discuss their existing premises. They currently occupy premises on Beacon Hill and are looking to relocate onto the quayside because their existing Clubhouse is not sustainable. The Club have previously spoken with CR about locating near to Living Coasts but this was not possible.	
	The meeting with the Club also involved Planning officers and KM circulated a concept plan for everyone to look at. The idea would be to build on a platform in the space between the existing D-Day ramps on Beacon Quay. They would look to redevelop their current site to secure funding for the new site. KM advised that this proposal would impact on the Harvester with some of their views being impeded. In addition, it would be necessary to move the Town Dock access bridge. KM asked for comments on the plan from the Forum. KM advised that the views expressed by Historic England would be critical. NB commented that he believes we should encourage development for the quayside. KM advised that he had agreed to pass on RTYC proposals to the Forum but the Club should continue to work through the Planning issues, especially the matter of the Grade II* listed slipways. It was pointed out that there would be an issue with flood zone 3 if the bar were located at quay level.	All to note

11. Review of Operational Moorings Policy – proposal to remove 12 metre boats and moorings on the Town Dock

KM advised that the Policy is reviewed each year. Currently the Town Dock is experiencing problems with damage and this is happening in areas where the larger boats are berthed. KM advised that he is considering the possibility of limiting the maximum size of vessels on the Town Dock to 10 metres. ME asked what the loss of income for this would be and KM advised that this has not been looked at yet but he will be looking at this and comparing the lost income against the cost of repairs. ME advised that if the Town Dock visitors and wave screen pontoon is repaired then this may resolve this issue. DB asked would this affect visiting vessels. KM advised that this possible change would be for annual customers who use finger pontoons. Nothing will be changed in this year's policy but it may be changed for next year depending if further damage is sustained.

KM advised that he is now aware of a number of websites where you can rent a berth for the night. Sub-letting is not permitted and this practice poses a security problem with access codes for facilities as well as safety issues. The current policy advises you cannot live on board your vessel and cannot sublet your vessel/mooring. KM will be making it clear in the Moorings Policy that customers cannot rent their boat for the night to subsidise harbour dues. KM read out the proposed amendment to the policy. MS asked how this affects sailing vessels such as Pilgrim or charter vessels and KM advised he is aware that difference exists with these vessels if they are taking passengers to sea.

12. Direct Debit Admin Charge

KM advised that the change to a banded administration charge has caused some disquiet among certain customers this year. When the option to pay by direct debit was first introduced this included a 2.5% charge to pay over 9 monthly instalments. Torbay Council finance team had various issues with this and asked for a different method to be used. This year a tiered charge was introduced and a number of complaints were received from customers who believed it was not fair. KM said that he would seek to change the system for next year after discussions with NB & VE. KM advised that if customers are unhappy with this change for the current year then they should cancel the direct debit option and pay in full. TE commented that the system is unfair and he would welcome a return to the percentage method. KM advised that a different system would be introduced for next year.
