Cabinet also agreed that authority would be delegated to the Assistant Director of Planning, Housing and Climate Change, in consultation with the Cabinet Member for Economic Regeneration, Tourism and Housing, to agree the final details of the Housing Strategy Delivery Plan, including in-year adjustments to help progress housing delivery. Furthermore, it was agreed that the Housing Strategy Delivery Plan will be formally reviewed on an annual basis, through an appropriate level of consultation, with updates agreed and a refreshed version published as necessary. Although the current Housing Strategy Delivery Plan makes some reference to health it is not specific refer to ill health prevention. The Assistant Director of Planning, Housing and Climate Change, along with the Cabinet Member for Economic Regeneration, Tourism and Housing, would welcome specific feedback from the Anti-Poverty Task and Finish Group, regarding any additional actions, to add to the Delivery Plan, that would support ill health prevention.</li> <li>ii) It is vital that we ensure that Public Health funding is continued and as a Cabinet we continue to lobby government on this matter. Whilst appropriate funding is required, we should not ignore the important work of Public Health England's health improvement and prevention arm.
