26.3% of residents in Tormohun have a disability which is higher than Torbay's average (23.8%).

People with disabilities may be disproportionately affected by any loss of banking facilities as they may be less likely to use the internet and/or online banking and thus are more likely to rely on in store banking. Negotiations with a building society which sits within the CPO area are progressing to find an alternative location in the town centre. Adverse impacts are not anticipated as banking facilities will remain.

Any possible loss of supermarkets may disproportionately impact people on lower incomes and those with disabilities. Evidence has shown that people with disabilities are more likely to experience financial insecurity and thus are likely to be more reliant on affordable and accessible supermarkets. There are several other grocery stores locally which will limit the impact of any supermarkets closing within the CPO area.

Accessible public transport, car parks and buildings are key to ensuring that the proposals are accessible to enable access to the town centre and participation in public life for people with disabilities.
