9. Election of Chairman/woman

Councillor Ellery was elected as Chairman for the meeting.

10. Minutes

The Minutes of the meetings of the Sub-Committee held on 1 December 2022 and 5 January 2023 were confirmed as a correct record and signed by the Chairman.

11. Consideration of the fit and proper status of the holder of a Dual Hackney Carriage and Private Hire Drivers' Licence

Members considered a report on the fit and proper status of the holder of a Torbay Council issued dual Hackney Carriage and Private Hire driver's licence.

The Licensing Officer presented the report that set out information that had been received from Devon and Cornwall Police that a dual Hackney Carriage and Private Driver's Licence holder had been arrested on suspicion of assault occasioning actual bodily harm against his ex-partner. The dual Hackney Carriage and Private Driver's Licence holder had failed to meet specific requirements as set out in the current Taxi Policy 2022, by virtue of having failed to inform Torbay Council of his arrest. Further to this the dual Hackney Carriage and Private Driver's Licence holder has now pleaded guilty to the charge of assault occasioning actual bodily harm in the Magistrates' Court and was awaiting sentencing.

Decision

That Mr Frost be formally warned in writing and that this warning shall remain in situ for a period of 18 months and that should any further issues of concern arise within that 18 month period which requires Mr Frost to appear again before a Licensing Committee, Members of that Committee shall be made aware of this written warning; and

That Mr Frost read and familiarises himself with the contents of Torbay Council's Hackney Carriage (Taxi) and Private Hire Policy, as issued to him and that he keeps a

copy of the said Policy in the licensed vehicle at all times when on duty as a licensed driver for future reference.

Reason for Decision:

In coming to that decision, Members carefully considered having been charged with the responsibility to determine the drivers' licence, whether they would allow their son or daughter, spouse or partner, mother or father, grandson or granddaughter or any other person to whom they care or any other vulnerable person known to them to get into a vehicle with Mr Frost alone. An unequivocal and unanimous answer by Members to this question was 'yes'.

Members take a dim view of actual bodily harm to any person however, in this instance Members noted the circumstances surrounding the incident itself, which occurred whilst Mr Frost was off duty, and which led to the injuries being sustained, the genuine remorse demonstrated by Mr Frost, and the lapse in time since the offence taking place during which there had been no incidents of concern, or substantiated complaints received around his conduct or behaviour.

Members were however concerned that Mr Frost had not fully complied with the requirements of Torbay Council's Hackney Carriage (Taxi) and Private Hire Policy, in not notifying the licensing department of his arrest, citing his inexperience as a Torbay Council driver as the reason for this, though accepted his explanation for failing to advise of the outcome of his Court hearing, which was in fact adjourned to a later date.

In concluding, Members all agreed that they found the Respondent to be credible and was believable in his account, that this was an isolated incident, and that Mr Frost posed no risk to public safety.

1. Key points and Summary

- 1.1 To consider and determine an application for a new Premises Licence, in respect of the Premise detailed above.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 The matters raised relate to the Licensing Objectives the "Prevention of Public Nuisance", the "Prevention of Crime and Disorder" and the "Promotion of Public Safety".
- 1.4 The matter must be considered on its merits, having received details of the issues arising either at a hearing or by written Representation. A decision must be made, having considered the Representations, either:-
 - (a) to grant the licence subject to
 - (i) such conditions as are consistent with the submitted operating Schedule modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and
 - (ii) any condition which must under Section 19, 20 or 21 be included in the licence;
 - (Such conditions may differ in respect of different parts of the Premises and/or different activities).
 - (b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
 - (c) to refuse to specify a person in the licence as the Premises Supervisor;
 - (d) to reject the application.

1.5 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Applicant, Responsible Authorities and all Interested Parties, following the determination of the matter.

2. Application

2.1 An application has been made under Section 17 of the Act for a Premises Licence to permit licensable activities at the Premise detailed above. Details of the relevant pages of the application are shown in Appendix 1.

A brief description of the application, is as follows:-

The sale by retail of alcohol for consumption both on and off the premises from 1000 hrs to 2400 hrs Monday to Sunday.

Performance of live music indoors from 1000 hrs to 2400 hrs Monday to Sunday.

Playing of recorded music indoors from 1000 hrs to 2400 hrs Monday to Sunday.

Premises opening hours from 1000 hrs until 0030 hrs Monday to Sunday.

The Applicant has given the following description of the premises: -

"Public House".

The plan accompanying the application is shown in Appendix 2.

2.2 The Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 17(5) but is unable to issue the Licence, as relevant Representations have been received. The Licensing Authority is also satisfied that the Representations have been received within the appropriate time scale and have not been subsequently withdrawn.

We have received 1 neutral Representation from a Responsible Authority. This is from the Torbay Council's Public Protection Officer, in relation to the Licensing Objective, the "Prevention of Public Nuisance". This is shown in Appendix 3.

We have received 5 Representations from Interested Parties in relation to the Prevention of Crime and Disorder, the Prevention of Public Nuisance and the Promotion of Public Safety. These are shown in Appendix 4.

No Representations have been received from any other Responsible Authority or any other Interested Party, other than that mentioned above.

- 2.3 The Authority is required to conduct a hearing under the provisions of Section 18(3) unless all parties agree that this is not necessary.
- 2.4 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representation and the procedure to be followed at the hearing.
- 2.5 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.

- 2.6 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 2(1) of Schedule 5 to :-
 - (a) The holder of the licence against any decision
 - (i) to impose conditions on the licence, or
 - (ii) to take any step to exclude a licensable activity or refuse to specify a person as Premises Supervisor.
 - (b) Any person who made a relevant Representation who desires to contend
 - (i) that the licence ought not to have been granted, or
 - (ii) that, on granting the licence, the Licensing Authority ought to have imposed different or additional conditions or taken any step to exclude a licensable activity or refuse to specify person as Premises Supervisor.
- 2.7 Following such Appeal, the Magistrates' Court may:-
 - (a) dismiss the appeal,
 - (b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or
 - (c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,
 - and may make such order as to costs as it thinks fit.

d) The prevention of public nuisance

Children below 14 shall be excluded from the premises in the interest of protecting children from harm.

Children aged 14 - 15 must be accompanied by a responsible person of eighteen years or older.


A sign shall be positioned near the entrance to the premises indicating that no person under the age of 14 will be allowed on the premises and that children aged 14 - 15 must be a premised by a responsible adult.

Photographic ID must be produced when an individual is suspected of being under the age of 18.

Noise or vibration shall not emanate from the premises such as to cause persons in the neighbourhood to be unreasonably disturbed. In general terms, noise from the premises should not be audible within any noise sensitive premises (e.g. dwelling) with windows open for normal ventilation especially after 23.00 hrs. This shall be assessed from the boundary to the nearest residential properties, on all sides of the licensed premises. The criteria that shall be applied are:- (i) After 23.00 hrs - Noise emanating from the premises shall not be distinguishable above background levels of noise. (ii) The local authority shall reserve the right in cases of tonal noise and where premises are attached to others (i.e. semi's and terraced properties), to make further assessments from within the residential property. To reduce noise breakout, doors and windows facing onto any noise sensitive premises (e.g. dwelling) shall be kept shut during entertainment. A management scheme shall be in place to ensure this situation remains. The placing of refuse, such as bottles, into receptacles outside the premises shall take place at times that will prevent disturbance to nearby properties. The handling of beer kegs, bottles and other similar items shall not take place in the late evening, at night and during the early morning, when the noise generated could cause a nuisance particularly outside buildings. Cooking, noxious or persistent smells from the premises shall not cause a nuisance to nearby properties and the premises must be properly vented.

John Bull – Application for a Premises Licence

I make this representation, as the **Responsible Authority for Public Nuisance**. It is made to aid the committee in making a decision on the knowledge that other representations have been made. It is not made to support or object to the application but to provide clarity for the committee members.

Background

Gosschalks have made an application on behalf of the prospective Premises Licence holders, for a Premises Licence that is very similar to one that lapsed in November 2022. The only change being the extension of Live Music from 2330 to 2400.

I have reviewed our database with regard to past noise complaints, and historically there are a number of complaints but none since 2014.

Exemptions within the Licensing Act 2003 mean that any Live or Recorded Music before 11pm can take place irrespective of any time limitations or conditions. This is not the case after 11pm and adequate conditions are offered to manage the potential for nuisance. [Conditions and restrictions to Live and Recorded Music before 11pm can only be added after a Review.]

The Licensing Statement of Principles, Appendix 2 on page 42 of the Policy says.

9. There will be an assumption however, that licensed premises in residential areas, or where there is close proximity to residential properties or hospitality services, will only be allowed to undertake licensable activities until 11pm, unless detailed consideration and mitigation measures have been proposed to address those concerns. A simple application with no supporting material can be expected to be refused, where relevant Representations have been received.

Conclusions

It is quite clear that the premises has the potential to cause nuisance both due to the historic information and it being in a residential area, however with careful management this can potentially be mitigated.

If committee were minded to restrict music times or require some additional safeguards, then the following changes or condition could be added for reassurance purposes.

To restrict Live Music to 1130pm in line with the previously held Premises Licence.

Or/and

'A Noise Management Plan is written and agreed with the officer responsible for Public Nuisance with the Community Safety department at the Local Authority before Live or Recorded Music is played after 11pm.'

The pub users are still standing outside shouting very late at night. The people in my household work very early hours and I strongly object to being kept awake by loud music and pub users. 2. Recorded Music from 10:00 until Midnight is unacceptable for exactly the same reasons as above. Even when the pub has closed. People do not go home straight away. They stand outside shouting etc until the early hours of the morning. 3. My car has been damaged by drunk pub goers while under the previous owners, including other households in this street (I have had to stand outside my house to watch and make sure my car is not damaged again. 4. Please see below my objection to the licensing application for the John Bull pub if this can be put on file please.

Torbay Statement of Principles indicates that for premises situated in a residential area where representations are made in respect of activities that may lead to public nuisance issues, the Licensing Authority can restrict that activity, ie live music, to no later than 11.00 pm if the applicant has not included sufficient measures within the application to mitigate the concern.

In light of the above key principle, I would like to share the following facts, concerns and experiences.

The John Bull pub is located in a residential area that means that any anti social behaviour emanating from the premises, very easily has an impact on neighbours who are very close to this licensed premises. While my family have lived the John Bull for almost 30 years, it has mostly been well run. However, in more recent years, we have found that the clientele can be more rowdy. In the last 12 months we have faced unacceptable levels of noise from the premises during the summer when the front door can be propped open when live music is occurring. We have also seen on a couple of occasions, fights occurring outside the John Bull with residents fearing for the wellbeing of their cars that was damaged in a fight once. My mother in law suffers from and her bedroom is facing the pub. On a few occasions late night noise beyond 11pm has woken her and led to a disturbed nights sleep for her as she becomes upset and confused. We regularly suffer from car doors being slammed and shouting from patrons as they leave the premises. This can particularly be the case on an evening when live music is played and would strongly recommend that the licensing authority gives serious consideration to applying the council's policy of no live music after 11pm in this residential location as dwellings are very closely located to the pub.

I am forwarding this email to raise objections, on behalf of my wife and myself, to the above application.

is a small and quiet cul-de-sac. In the time that my wife and myself have lived in the various owners and landlords of the John Bull Public House have generally been sensitive to being located in a residential area. Live music has normally been restricted to a Saturday evening, normally finishing by the current Live Music licence time of 11.30 PM. The external noise levels are greater when external doors are left open, particularly in the Summer months.

The application for extending the Live music licence from 11.30 PM to Midnight 12 PM, Monday to Sunday, would not be appropriate in this quiet residential area. Live music after 11.30 PM would have a major impact on the residents of particularly the elderly and young children. It would also impact on many other residential roads and properties in the Chatto Road area. Live Music up to midnight may be appropriate for Public Houses and Night Clubs in Town Centre locations but certainly not in a residential area such as the one in which the John Bull Public House is situated. This could have a major effect on the wellbeing and health of many people who could struggle to get to sleep

due to the noise pollution, particularly when external doors are left open.
