Having carefully considered all the written and oral Representations put before the Sub-Committee, Members resolved this ground to be established following the number of warning letters that had been issued from the Principal Safety and Licensing Officer (dated 16 January 2009, 3 April 2009, 4 December 2009 and 31 August 2010) and the Licensing Support Officer (dated 3 November 2010 and 4 March 2011) raising awareness of the concerns of public safety by drivers parking illegally in Torquay.

Members noted Mr Stone's written admission, as dated 8 March 2011 in that he had parked not in accordance with the Road Traffic Orders or Byelaw 8. In addition Members noted that Mr Stone had not followed the direction, as specified in the Hackney Carriage and Private Hire Drivers Handbook, point 19 of Section 1 Part B.

In concluding Members were satisfied that Mr Stone had been given sufficient warnings but despite this, had parked illegally on 29 October 2010 and again on the 18 February 2011.

Members felt that the suspension was a proportionate and necessary response to the breach of the Road Traffic Orders and Byelaw 8 in an attempt to ensure public safety.

Mr Zarezadeh confirmed that he had received these warning letters and had received the Hackney Carriage and Private Hire Drivers Handbook which states at point 19 of Section 1, Part B that:

'The number of vehicles stationed at any rank must not exceed the number for which the rank is appointed at any time. If a rank is full at time of a vehicles' arrival at a rank then the driver must proceed to the next available rank.'

Members noted Mr Zarezadeh's oral admission that he had parked not in accordance with the Road Traffic Orders or Byelaw 8 and that he had not followed the direction, as specified in the Hackney Carriage and Private Hire Drivers Handbook

In concluding Members were satisfied that Mr Zarezadeh had been given sufficient warnings but despite this, had parked illegally on 18 and 22 October 2010, on 19 February 2011 whereby of particular concern, his actions on this day caused an obstruction to the highway and as such, delayed a Police vehicle on an emergency call, as stated in the witness statement of Mr Steve Cox dated 7 April and again parked illegally on the 10 March 2011.

Members felt that the suspension was a proportionate and necessary response to the breach of the Road Traffic Orders and Byelaw 8 in an attempt to ensure public safety.

Decision and reason for decision:

Having carefully considered all the oral and written representations, Members take seriously the concerns raised in respect of public nuisance and as such have resolved, as a necessary and proportionate response that the licence conditions be modified as follows:

- i) that no bottles are to be emptied after 22:00 hours and not before 09:00 hours Monday to Sunday;
- that on every occasion the Premises sells alcohol after midnight and remains open after 00:30 hours, door staff will, between 23:00 hours and closing time, monitor patrons in the immediate vicinity of the Premises and take all reasonable steps to ensure that patrons leaving the Premises do so quietly so as not to disturb nearby residents;
- that point 1 of Annex 3 The Prevention of Crime and Disorder be amended to read 'that there shall be no entry/re entry after 02:00 hours and from that time until closing time, at least one SIA Door Steward shall be positioned outside the main entrance of the Premises in the alleyway; and
- iv) that 'the Premises Licence Holder shall take all reasonable steps to ensure that staff leaving the premises do so quietly so as not to disturb nearby residents'.

Following the modification of these conditions Members are satisfied that this should address the concerns raised by the Interested Party and that failure to do so may result in this Premises Licence being subject to a further Review to ensure the Licensing Objectives are promoted.

Members noted Mr Shazad Ramzan had advised the Licensing Department that he was not able to attend the Hearing, and as such agreed that the Hearing would go ahead in his absence.

Senior Licensing Offcier The Senior Licensing Officer outlined the Council's case, as set out in Report 96/2011.

Decision:

That Mr Shazad Ramzan's Hackney Carriage Driver's Licence be suspended for a period of seven days on the ground of 'any reasonable cause', as in accordance with Section 61 (1)(b) of the Local Government (Miscellaneous Provisions) Act 1976.

Reason for decision:

Having carefully considered all the written and oral Representations put before the Sub-Committee, Members resolved this ground to be established following the number of warning letters that had been issued from the Principal Safety and Licensing Officer (dated 16 January 2009, 3 April 2009, 4 December 2009 and 31 August 2010) and the Licensing Support Officer (dated 20 October 2010 and 4 February 2011) raising awareness of the concerns of public safety by drivers parking illegally in Torquay. Members were satisfied that Mr Ramzan would have received all the warning letters and that he would also have been issued with a Hackney Carriage Driver's Handbook and therefore should be aware of point 19 that states:

'The number of vehicles stationed at any rank must not exceed the number for which the rank is appointed at any time. If a rank is full at time of a vehicles' arrival at a rank then the driver must proceed to the next available rank.'

In concluding Members were satisfied that Mr Ramzan had been given sufficient warnings but despite this had parked illegally on 15 October 2010, again on the 18 February 2011 whereby of particular concern on this date, his actions were deemed to be dangerous and again on the 19 February 2011.

Members felt that the suspension was a proportionate and necessary response to the breach of the Road Traffic Orders and Byelaw 8 in an attempt to ensure public safety.

1. Key points and Summary

- 1.1 To consider and determine the above application for Review of a Premises Licence.
- 1.2 The matter may affect the Corporate Priorities of Community Prosperity and Economic Prosperity.
- 1.3 As the Licensing Authority has no powers under the Act to raise a Representation, Officers are unable to make any recommendation.
- 1.4 The matters raised relate to the Licensing Objectives "The Prevention of Crime and Disorder" and "The Prevention of Public Nuisance".
- 1.5 The Authority must hold a hearing to consider the application and any relevant Representations.

The Authority must, having regard to the application and any relevant Representations, take such of the steps as detailed below, if any, as it considers necessary for the promotion of the Licensing Objectives.

The steps are -

- (a) to modify the conditions of the licence;
- (b) to exclude a licensable activity from the scope of the licence;
- (c) to remove the Designated Premises Supervisor;
- (d) to suspend the licence for a period not exceeding three months;
- (e) to revoke the licence;

and for this purpose, the conditions of the licence are modified if any of them are altered or omitted or any new condition is added.

If the licence is subject to sections 19, 20 and 21 (requirement to include certain

conditions in Premises Licences) they remain.

Where the Authority takes a step to modify the conditions or exclude a licensable activity, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

1.6 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Responsible Authorities at the determination of the matter.

2. Introduction

2.1 An application has been made under Section 51 of the Act for a Review of the Premises Licence, at the Premise detailed above. Details of the application are shown in Appendix 1.

A brief description of the Review is as follows:

Public Protection have sought a Review of the Premises Licence on the ground relating to the Licensing Objective "The Prevention of Public Nuisance".

Supporting information relating to the Review has been provided by Public Protection, as shown in Appendix 2.

A copy of the current Premises Licence is shown in Appendix 3.

2.2 Torbay Council as the Licensing Authority, is satisfied that the application has been properly made, that the Applicant is a Responsible Authority, and that the administrative requirements of Section 51(3)(a) and (b) have been met and that the Representation has not been subsequently withdrawn and is not vexatious, frivolous or repetitious.

The Police have made a Representation relating to the Licensing Objective "The Prevention of Crime and Disorder". This is shown as Appendix 4.

The Licensing Authority has received 2 Representations from Interested Parties in relation to the Licensing Objectives "The Prevention of Crime and Disorder" and "The Prevention of Public Nuisance". We have also received 2 letters in support of the Sportsmans Arms. These are shown as Appendix 5.

There have been no Representations from any other Responsible Authority or any other Interested Party.

- 2.3 The Authority is required to conduct a hearing by the provisions of Section 52(2).
- 2.4 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.5 Once the matter is determined, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 8(2) of Schedule 5 to :-
 - (a) the Applicant for the Review,
 - (b) the holder of the Premises Licence, or
 - (c) any other person who made relevant Representations in relation to the application.

In the event that an Appeal is entered, the determination will not have affect until the Appeal is either determined or withdrawn.

2.6 Following such Appeal, the Magistrates' court may:
(a) dismiss the Appeal,
(b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or
(c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court, and may make such an order as to costs as it thinks fit.



Despite efforts on the part of the responsible authority to assist the licence holder to control noise arising from their premises, the premise continues to be operated in a manner that is causing public nuisance.

The premise does not have a licence for regulated entertainment, yet on numerous occasions they have continued to play music (including a disco event) at a level well in excess of background music. The licence holder was advised that this was a breach of the premises licence and has been advised on many previous occasions. Particularly advice has been given on what constitutes regulated entertainment. However problems have continued.

The licence holder makes little effort to control noise from patrons resulting in public nuisance arising as a result of shouting, arguments and singing in the premises and outside of the premises resulting in residents of Laburnum Street being unreasonable disturbed.

The Licence holder has no regard for complying with their licensing conditions as demonstrated recently by knowingly allowing patrons to continue purchasing and consumers alcohol on the premises beyond their permitted hours.

The licence holder who is also the Designated Premises Supervisor is not at all times in full control of the premises and as a consequence is not able to address the concerns raised by the Licensing Department or by the Responsible Authorities.

The Sportsman's Arms has a history of noise complaints from residents of Laburnum Street brought against it since Lisa Lang took over the premises in November 2009 as the Licensee and the Designated Premises Supervisor. Despite numerous meetings, good advice and warning letters since April 2010 noise has continued to be a problem at this premises. The DPS has made some efforts to control the noise problems and has shown willing to co-operate with the Council but after these meetings complaints quickly return.

The noise complaints regularly consist of excessive noise from Patrons inside the pub and more often from Patrons smoking on the pavement at the front of the premises. Patrons continue to smoke and talk loudly on mobile phones, even though reassurance were given by the DPS that no one would be allowed to smoke outside the front of the premises after 8pm. No attempts to control noisy customers smoking outside have been witness by Officers of the Council or residents of Laburnum Street. The worst disturbance to local residents is at closing times when patrons are leaving, this can be from people shouting and talking loudly. This has on occasions continued until gone 2:30am when the premises should have closed to the public by midnight.

On one occasion the Licensee knowingly permitted a disco event to take place. This is despite being reminded on previous occasions they are not licensed for this type of regulated entertainment. They had the option of applying for temporary event notices but this advice was not heeded. The event itself resulted in a number of complaints about excessive noise from music and customers both of which could be clearly heard in the complainants homes.

Fecently the licensee allowed alcohol to be served beyond their permitted hours. The Police altended the premises and established the Patrons where not bona-fide guests and friends of the licensee and the front door was still open.

To an extent the problem lies with Lisa Lang (Licensee and DPS) who is not assertive enough in controlling her more dominant husband and business partner Jim Lang. Mr Lang appears to be the persons in charge and the persons making the decisions which have resulted in activities such as the disco and drinking after hours taking place which has led to this review being called. On a number of occasions Mrs Lang has been advised she is the person who is legally responsible for the premises and the conduct of the patrons and she must take full control and responsibility for what occurs at the Sportsman's Arms.

The Sportsman's Arms is a licensed premise in Laburnum Street, Torquay. Laburnum Street and its adjoining streets are almost all residential accommodation. Laburnum Street consists of terrace houses without front gardens and the Sportsman's Arms occupies three of these houses. Residential accommodation is adjoining both sides of the Premises and directly opposite. The Road operates a one way system and in the main most of the vehicle traffic is local, however pedestrians use the street as a cut through. The area at night is generally quiet.

The Premises has a licence for the supply of Alcohol for consumption on and off the Premises from Noon till Midnight. Monday to Friday the premises does not open until 4pm. There are no other provisions for regulated entertainment on the licence except for the provision of facilities for making music.

This Authority has received and investigated a number of complaints over the last 10 years regarding noise nuisance associated with the Sportsman's Arms. However it was when the new owners took over the premises that noise complainants began to escalate. Lisa Lang the Licensee and DPS took over the running of the Premises with her husband Jim Lang in November 2010. This department has visited the premises on a number of occasions to meet with the Licensee to discuss noise issues and given advice and guidance. In the last 12 months a pattern has emerge whereby after visits made by this department the disturbance residents are suffering with diminish before gradually the problems begin to return.

1ST February 2010

The department received its first complaint regarding noise since Lisa Lang took over the premises. A resident of Church Street complained about excessive noise from people using the smoking area at the rear of the premises in the form of loud shouting, laughing and frequent swear words. A dairy sheet was sent, but not returned.

5th February 2010

Second noise complaints from a resident of Laburnum Street regarding noise from Patrons smoking outside the premises and could hear the juke box. The complaint believed locks in were occurring.

A visit made by this department advised Lisa Lang to remove the chairs from the smoking area at the rear of the property and not to allow customer to take out drinks with them. Signage was asked to be displayed asking people smoking outside to consider the neighbours. A letter was sent to the premises confirming the outcome (Appendix 1)

22nd March 2010 &12th April 2010

The department received further noise complaints from another resident of Laburnum Street regarding noise from Patrons smoking outside the front of the premise and from amplified music till 1am.

A further letter was sent from this department advising the licensee further noise complaints are being received and advising them they could be breaching licensing conditions if they open beyond the existing opening hours (Appendix 2).

29th May 2010

On Saturday I visited Laburnum Street to investigate a complaint about noise nuisance from Karaoke events held at the Sportsman's Arms. I concluded the noise was excessive and likely to be causing a nuisance to nearby residential accommodation. At a meeting held with the Lisa and Jim Lang on the 3rd June 2010 they were informed the they had undertake regulated entertainment which they are not licensed for. Lisa Lang was given advice on how to apply for a variation. A background music level was also set during this meeting as complainants had previously been disturbed by amplified music. The premises is not currently licensed for amplified music. A letter was sent to the premises' confirming the details of the meeting (Appendix 3).

A complaint from a resident of Laburnum Street was received by this department about the Karaoke event I had witnessed.

July & August 2010

The department continued to receive complaints throughout the summer of 2010. The complaints were logged with Torbay Councils Out-of-hours service (Appendix 4).

During August a digital video camera was left in a complainant's home to record the disturbances being experienced. The footage clearly demonstrated groups of patrons outside the premises smoking and generating significant noise whilst doing so. The footage also showed windows and doors left open added to problem of noise breaking out of the premises. Please appendix (Appendix 5)

The complainant was also added to the Torbay Councils 'Out of Hours Service'. Two visits were made by two different officers. One of regarding the noise a general background noise you might associate with a pub and the second recorded an obscene conversation between a group of individuals smoking out side of the pub which could clearly be hear inside the complainants home (Appendix 6)

September 2010

The department continued to receive complaints from residents of Laburnum Street. A meeting was held at Roebuck House between attended by Karen Ellicot, Licensing Officer, myself and Lisa and Jim Lang. They were advised noise complaints continued to be received by this department. Additional advice was given and this was confirmed in writing (Appendix 7). Lisa Lang was again reminded the playing of amplified music is a licensable activity and they must keep recorded music at background levels.

20th November 2010

A disco was held at the Sportsman's Arms to celebrate the 1st year of Lisa Lang taking over the pub. Despite being made aware on several occasions that they are not licensed to undertake such activities the Lisa Lang knowingly permitted Licensable activities to take place. The complaints were disturbed by the amplified music breaking out of the premises and by patrons congregated outside of the premises. The complainant was disturbed until 2:00 am in the morning and suggested a lock in might of occurred. The police was phoned but due to operation demands where not able to attend.

Jim Lang admitted they had held a disco during a meeting with the Langs, Neil Stanlake Police Licensing Officer and myself at the Sportsman's Arms on the 23rd November. A warning letter was sent to the Lands advising if any more breaches of the licensing Act occurred Torbay Council would consider taking enforcement action which could include a review of its premises licence and or prosecution (Appendix 8)

December 2010

I made a couple of visits the Sportsman's Arms during December 2010, however the visits were early in the evening and did not witness any disturbances. A Temporary Event Notice for a Disco on New Years Eve sought by Lisa Lang and granted. A resident of Laburnum Street could hear amplified music in their home and it was impossible to sleep until the music had stopped.

January 2011

The department continued to receive complainants regarding noise breaking out of the premises and noise from patrons being disturbing residents whilst smoking outside the premises. Increasingly the complainants mentioned possible locks in. The Police were asked to monitor the pub and a number of evening visits were made by offices of Torbay Council but did not find any evidence of lock-ins.

11TH February 2011

At about 10:55 I and Neil Stanlake observed disturbance from taxis picking up fairs from the Sportsman's Arms and the noise patrons were making whilst smoking outside. I felt this was consistent with what the complainants have been reporting. I felt the noise was unreasonable and witnessed no attempt from the management of the Sportsman's Arms to control the noise being made by patrons outside the front of the premises.

5th March 2011

Neil Stanlake visited the premises at 1.10am and found a large number of customers still drinking Alcohol in the premises. The premises should have closed by 00:30 am. Mr Stanlake observed before entering the premises the only noise he could hear on the street was noise coming from customers inside the Sportsman's Arms. It was later confirmed during visit to the Sportsman's Arms Alcohol has continued to be served after midnight.

This incident confirms reports made by resident of Laburnum Street of being disturbed by unreasonably noise directly attributably to the Sportsman's Arms.

30th April 2011

The Sportsman's Arms applied for and was granted a Temporary Event Notice for a disco/Karaoke to be held in celebration of the Royal Wedding. I reminded Lisa Lang this was an important opportunity to demonstrate she can manage these events and not create a noise nuisance. I visited the Laburnum Street at approximately 10:45 pm and could clearly music emanating from the Sportsman's Arms. It could be heard at the top and bottom of the street. I formed the view the music would be audible in residents homes. I noted a SIA doorman outside. I observed for about 20 minutes and did not see anyone come out onto the street. I left and retuned at 11:50 pm until 00:15 and observed the volume of music was still excessive and likely to cause a nuisance. Again I observed no one on the street except the SIA doorman. The following working day I spoke with a resident who confirmed she was disturbed by music and people leaving the pub until gone 1:30am.

Throughout the last 12 months Lisa Lang and Jim Lang have always been approachable and co-operative and have put into place the majority of the advice that has been given. Yet despite all the interventions problems have continued. There have been times, normally after an intervention where complaints have diminished and naturally complaints about noise drops out in the winter months, however the management of the Sportsmans Arms have shown disregard for complying with the Licensing Act.

To explain this has more to do with the Jim Lang being the person who is really in charge of running the Sportsman's Arms despite his wife Lisa Lang being the person who is legally in charge and responsible. Lisa Lang appears to be unable to control her more dominate husband and he is the person who has made the decisions which have resulted in licensable activities taking place and allowing drinking beyond permitted hours. It has taken the calling of a review by the Responsible Authorities the Langs to take seriously the running of a Licence Premise. To their credit the Sportsman's Arms is their first licensed premises and the last 12 months has been a big learning curve in tackling noise issues.

Lisa and Jim Lang often refer to the Sportsman's Arms as a locals pub and has been in the heart of the Community for more than 50 years and as such provides a valuable public service. It is my opinion that the public nuisance suffered by the complainants far outweighs any benefit received by the community by the operation of The Sportsman's Arms. In considering this issue, I would draw the attention of the Committee to the case law R v Dennis [2003] EWHC 793 (QB) that deals with the effect of public nuisance on premises arising from the use of an RAF airfield for training pilots. In this case the judge decided that whilst the benefit to society provided by trained RAF pilots was highly laudable, it was unacceptable that residents should suffer the burden.

I am writing to you following the inspection carried out on 8th February 2010, your copy of the Inspection Form is enclosed. The inspection visit was a result of two noise complaints received by this department. One of the complainants were concerned with the noise emanating from customers in the smoking area at the rear of the premises. As discussed during the visit, the premises have had serious noise issues about this area in the past. The other complaint was a result of excessive noise from the front of the premises where customers are congregating. As the Sportsmans Arms stands in a residential area, it is absolutely imperative you monitor these areas regularly to ensure noise is kept to a minimum.

You agreed at the meeting to display additional signage but in a larger and bolder print to both the rear area and the doors leading to the external area at the front. You also agreed to undertake monitoring on a regular basis and to remove the table and chairs from the rear area which should dissuade customers from frequenting the area for longer than is necessary. Additional measures must also be put in place to ensure alcohol is not taken into the rear smoking area.

However, under the above legislation, the Council has a duty to investigate such complaints, even though they may turn out to be incorrect or unfounded. As part of these duties the Council may undertake monitoring of your premises for a period of time. If it appears that the complaint may be justified, then the Council must take action to stop the nuisance that is causing the problem, preferably by offering advice on measures to avoid creating a nuisance.

I would appreciate if you can write to me and confirm the measures you propose to take in the matter. If you would like advice, then please do not hesitate to contact me on the above number.

I am writing to you following receipt of yet more noise complaints. As you are aware, I had cause to visit the premises on 16 February 2010 because of noise complaints concerning noise from your customers both in the rear smoking area and out the front of the premises where customers were congregating. Prior to this, a visit was made to the premises on 5 June 2009 due to similar problems involving noise from customers in the rear smoking area.

The latest complaint is regarding noise from smokers outside the front of the premises shouting, as well as loud music emanating from the premises. As the only regulated entertainment permitted is karaoke on one occasion per week, I would assume the complaints were from this. However, it would appear that the windows were open while the entertainment was in progress and commenced from early afternoon until around 1.00am. The licensable hours for the activity of karaoke are 8.30pm until 11.00pm on a Friday or Saturday. This would mean you are in breach of your Premises Licence.

Therefore I can inform you that the premises will be monitored and if evidence is gathered to prove you are contravening the conditions attached to the Premises Licence, there is the possibility that Torbay Council will look at calling a review of the premises licence or a prosecution.

I write to confirm the outcome of the visit to the above premises on 3 June 2010 by myself and Karl Martin. The purpose of the visit was to address the noise complaints both received by the Licensing Section and witnessed by Karl Martin on an out of hours visit.

The premises are presently licensed for 'The provision of facilities for making music' which actually allows the premises to provide instruments or a PA system for use on the premises. This does not actually allow karaoke, although you have conditions restricting karaoke to once per week. You state you hold a karaoke night every other month and held one such night on Saturday 29 May 2010. As discussed, in order to carry out this activity in the future, you should vary your Premises Licence. However in light of the recent complaints, I would not recommend you apply to vary by way of a Minor Variation as just one objection would mean the application would be rejected.

In order for you to start the Full Variation process, I am enclosing an application to 'Vary a Premises Licence' together with the 'Guide to Applying to Vary a Premises Licence' and the 'Site Notice'. As discussed, if you would like assistance with the process, please call me for an appointment.

During the visit it became apparent that you were carrying out licensable activities without being authorised. The stereo sound system you have appears to be allowed to play at a level which would require a licence for recorded music. Mr Martin did assist your husband, Jim, to set the system at a level (22) which would be acceptable as 'background' music. Recorded Music can be applied for under the Variation application, but background music levels must not be exceeded prior to the grant of the variation. If recorded music is played at a level above background levels, without authorisation, you will be committing an offence under Section 136 of the Licensing Act 2003.

It would also appear the premises hold Darts Tournaments which are another licensable activity. The requirement of 'Indoor Sporting Events' can also be addressed by way of the variation before the season re-starts in October.

One other complaint received was the level of noise from patrons outside the front of the premises which has been an on-going problem in this residential area. You have agreed to encourage your customers to use the rear smoking area and restrict them from smoking at the front of the premises after a certain hour with a no re-entry policy after this time.

I would recommend, prior to making your Variation application, you speak to Gareth Fudge on 01803 208126 with regard to advice on conditions required in order for the premises to carry out the above regulated entertainment. As advised, this may include the fitting of a noise limitation device.

I would appreciate if you could write to me confirming what actions you will be taking to appease the situation.



I write to confirm the outcome of a recent meeting with yourself, Jim Lang, Karen Ellicott and myself at Roebuck House on the 23rd September 2010. The purpose of the meeting was to discuss the ongoing noise complaints received by the Licensing Section and witnessed by Environmental Health Officers during out of hours visits.

I would like you to be aware that it is noted you have been co-operative during this process and have put into place many of our recommendations outlined in previous letters. I have outlined below a summary of points and suggested actions to be taken that were agreed during the meeting.

- 1. Ensure all three front doors are kept closed at all times during opening hours to help minimise noise breakout.
- 2. Repair the self closer on the main entrance to prevent it from banging shut as soon as reasonably practicable.
- 3. Liaise with the Fire Authority to see if it is possible to remove two of the front entrances and keep only the lobbied central entrance. This will help greatly to prevent noise breakout during opening hours. In addition this will enable you to have a greater supervision over patrons entering and leaving the premises. You can contact the Fire Authority on 01803 653700 and ask to speak to a Fire Safety Officer for the Torquay area.
- 4. The Sportsman's Arms is currently not licensed for any amplified music. You are only entitled to background music which is not a licensable activity. Therefore the music **must** be set at the volume of 22 on your music system as previously agreed.
- 5. Previously it was agreed not to allow smokers outside the front after 8pm and it has been noted you have put this action into place. As we have continued to receive noise complaints regarding excess noise during the day, I strongly recommend you instruct Patrons to use the rear

smoking area before 8pm instead of using the street. Alternatively continue your hard work in dissuading Patrons from making excess noise whilst using the outside area of the pub (see also point 8).

You should also discourage patrons from congregating outside the premises, this is especially important during kicking out times.

- 6. With regard to Patrons using mobile phones outside the premises, I sympathise with your position that you do not feel you have a right to instruct patrons not to use their mobile phones. However, I do believe you need to remind you patrons to show some respect to your neighbours whilst using mobile phones. I suggest you consider appropriate signage.
- 7. With the issue of the football team meeting at the Sportsman's Arms on Sunday mornings, it was agreed to put in place alternative arrangements. During the meeting you proposed the team will meet at the football ground with the exception of a number of individuals to meet at Sportsman's Arms to assist with moving equipment.
- 8. I appreciate it is difficult to control at all times the behaviour of Patrons and indeed you may argue this is an unrealistic goal. However that said it you must make it your upmost priority to continue to remind your customers they must take some responsibility to help keep the noise levels to an acceptable level.

I would appreciate if you could write to me, as requested during the meeting, detailing all the action you have taken to date and confirm what future actions you will be taking to remedy the situation.

I write in reference to our recent meeting with your self, Jim Lang and Neil Stanlake, Police Licensing Office. The meeting was arranged to discuss a disco you organised for the 20th November 2010 and admitted you knowingly allowed to take place at the Sportsman's Arms. A disco with amplified music is regulated entertainment and is not currently allowed under your existing premises licence.

I was very disappointed to hear this despite you have been told on numerous occasions you are not licensed for this type of event and after being advised on the procedure for adding these activities to your licence you still knowingly held the disco. As stated in previous correspondence you are not authorised for regulated entertainment which includes any form of amplified music (except background music). This includes discos, karaoke and sporting events.

Undertaking unauthorised licensable activities is an offence under Licensing Act 2003 Sec 136(1)(a) if a person carries on or attempts to carry on a licensable activity on or from any premises otherwise than under and in accordance with the premises licence or knowingly allows a licensable activity to be so carried on.

I would like to emphasis you **must not** undertake any unauthorised activities at this premises unless you have applied for a Temporary Event Notice to cover an event. If you do knowingly allow a licensable activity in the future this Licensing Authority will have no option but to seek a prosecution. Please note this is your final warning and it is a credit to you that you admitted the event took place and you were apologetic that you are not being prosecuted in this instance. Please be aware a person guilty of an offence under this section Sec 136(1)(a) is liable on summary conviction to imprisonment for a term not exceeding six months or to a fine not exceeding £20,000 or both.

Furthermore, the disco event also raised complaints about noise breaking out of the building. I refer you to my previous letters for guidance on controlling noise. During the up coming TEN event on New Years Eve please be mindful to monitor the level of noise breaking out of the premise. Although I do appreciate during New Years Eve celebrations there is an expectation noise level will be higher than

other times throughout the year. But, as you wish to have regulated entertainment put on your licence in the New Year it is advisable you use New Years Eve as way of demonstrating to the appropriate authorities and your neighbours you are able to managed regulated events effectively.





ANNEXE 1

MANDATORY CONDITION: WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

- 1) No supply of alcohol may be made under the premises licence:-
 - (a) at a time where there is no designated premises supervisor in respect of the premises licence , or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

ANNEXE 2

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

General

None

The Prevention of Crime and Disorder

- 1. Staff shall be made aware of the need for vigilance and the importance of compliance with the Licensing Act 2003 and the requirements of Criminal Law.
- 2. A 30-minute winding down period shall be provided at the end of permitted hours to encourage customers to leave the premises in a quiet and orderly fashion.

Public Safety

- 1. The fire precautions in place must comply with the requirements of the fire officer.
- 2. Gas and electrical systems must be regularly inspected and maintained.

The Prevention of Public Nuisance

- 1. The provision of music/karaoke shall be infrequent.
- 2. The movement of bins and rubbish outside the premises must be kept to a minimum after 23:00hrs.
- Patrons must be reminded not to stand around talking in the street outside the premises after leaving the premises.

The Protection of Children from Harm

1. Bar staff must be trained to be aware of and alert to issues of underage drinking.

Restrictions transferred from the On Licence

The restrictions related to permitted hours do not prohibit:

- (a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;

- (c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
- (d) consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (f) the sale of alcohol to a trader or club for the purpose of the trade or club.
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there; or
- (i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of alcohol so supplied, if the liquor is supplied at the expense of the employer or of the person carrying on or in charge of the business on the premises.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied:

- (a) with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal;
- (b) for consumption by a person residing in the premises or his guest and paid for together with his accommodation;
- (c) to a canteen or mess.

ANNEXE 3

CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY

The Prevention of Public Nuisance

- Noise or vibration will not emanate from the premises such as to cause persons in the neighbourhood to be unreasonably disturbed. Noise should not be audible within any noise sensitive premises with windows open for normal ventilation especially after 23:00hrs. The criteria applied, from the boundary to the nearest residential property, are;
 - (a) Before 23:00hrs Noise emanating from the premises will not be clearly distinguishable above other noise.
 - (b) After 23:00hrs Noise emanating from the premises will not be distinguishable above backgrounds levels of noise.
 - (c) The Local Authority will reserve the right in cases of tonal noise and where the premises are attached to others (i.e. semi's and terraced properties) to make further assessments from within the residential property.
- 2. Doors and windows will be kept shut during entertainment to reduce noise breakout. A management scheme shall be in place to ensure this situation remains.


3. The volume of amplified sound used in connection with the entertainment provided shall at all times be under the control of the Licensee/ Management.

I refer to the above premises and an application for the Review of the Premises Licence made by Mr Karl Martin of Torbay Council Licensing and Public Protection Team.

The police wish to make the following representation:

These premises have been managed by Mrs Lisa Lang since 16th November 2009, who since that date has been the Designated Premises Supervisor (DPS).

Historically the premises have regularly given rise to concerns from local residents in respect of noise and disturbance. The premises are situated in the middle of a densely populated residential area, and is in fact in the middle of a long terrace of private houses.

Together with the Torbay Council Licensing Team and Environmental Protection Team, the Police have made efforts to monitor the premises, particularly late at night.

Since Mrs Lang has taken over, the level of complaints has increased and the premises have been closely monitored by the Police Licensing Team and the local patrolling police officers. A lot of these complaints surround issues connected to patrons going outside into Laburnum Street and smoking and alleged after hours drinking.

At about 10.55 pm on Friday the 11th February 2011, and 10.45 pm on Saturday 12th February 2011 Neil Stanlake, one of my Licensing Officers, carried out observations at the premises. He witnessed a number of patrons coming outside the front door to smoke and numerous taxis arriving to pick up fares. This created a great deal of noise as the smokers were continually shouting and screaming to each other and quite a few



of them were using their mobile phones whilst outside, thus creating additional noise. Quite a few of the taxis arriving would park directly outside the premises with their engines and radios running, and when fares did not come out promptly, the taxi drivers would either sound their horns or get of their vehicles and go into the premises, and in doing so created loud noise by slamming the car door, more than would be necessary if the fare had come outside promptly

On more than one occasion, there were as many as four taxis queued behind each other, with their engines running and taxi radios going, directly outside the Sportsman's Arms, completely blocking the road waiting for fares.

At about 1.10 am on Saturday 5th March 2011, Neil Stanlake again visited the Sportsman's Arms to monitor the premises and immediately could see that lights were on and people were inside and he formed the opinion that the premises were still open, bearing in mind that the Premises Licence only permits the sale of alcohol until midnight on a Saturday night and that the opening hours for the premises finish at 12.30 am. He witnessed a male leave the premises who looked to be under the influence of alcohol. The only noise evident that night was from people still inside the premises.

Mr Stanlake summoned police officers to assist him and on their arrival they entered the premises and could see that there were still a large number of customers present, most of whom were still drinking alcohol. Behind the bar was Mr Lang, the DPS's husband and a male barman. Mrs Lang, the DPS, was in the customer area of the bar.

Three particular males sat at the bar immediately became loud and challenging when questioned about why they were still drinking. All three had full pints of lager and were clearly the worse for drink. Mr Lang and the barman were asked to remove the customers drinks and ensure no further alcohol was supplied to them.

Mr Stanlake engaged with Mrs Lang and requested she close the bar and ask people to leave, which she did. The majority of those present left the premises without question, but the three males previously mentioned immediately became noisy and disorderly once outside the premises and the police officers present had to move them away. Whilst dealing with these males outside, a taxi arrived and it was clear that he had attended at the request of these males. The taxi driver was told to take them away as quickly as possible so as to limit the impact the noise they were making had on the local residents. The males got into the taxi and as it drove off at least one of the males shouted loud obscenities towards the police officers.

On all three occasions that Mr Stanlake monitored these premises late at night, it was clear that the premises and its customers were having a negative impact on local residents who live nearby, in what is generally a quiet area. Mr Stanlake is able to confirm that at the time of his visits there was no other noise being generated from any premises in the area.

On Monday the 7th March 2011, Mr Stanlake revisited the premises in the company of Mr Karl Martin of Torbay Council Environmental Protection Team and spoke to the DPS Mrs Lang at length regarding their concerns and the till roll for the evening of Friday the 4th of March into Saturday 5th March 2011, was seized and indicates after hours sale of alcohol.

Mr Stanlake has a record of all police logs and L10's connected to these premises since Mrs Lang became DPS and will refer to these at the Review Hearing if required. The majority of these are local residents reporting noise and disturbance and alleged after hours activities. At least two of these residents have been personally visited by Mr Stanlake, and it is clear from what they say that their quality of life is being adversely affected by the activities of the Sportsman's Arms.

Should you wish to seek clarification regarding the above, please do not hesitate to contact Neil Stanlake of my Licensing Department, who intends to be present at the Review Hearing, and can expand on the above if required.
