The Respondents Solicitor welcomed the suggestion that the Police Licensing Officer and Designated Premises Supervisor meet regularly to discuss how to promote the Licensing Objectives.

Decision:

Having carefully considered all the written and oral representations Members resolved to modify the conditions of the Licence as follows:

- i) the terminal hours for the sale of alcohol be 11 pm Sunday to Thursday and 11:30 pm Friday to Saturday without exception. The premises shall close one hour later, without exception;
- ii) The performance of live music and playing of recorded music will cease at 11 pm apart from Sundays, when it shall remain at 10:30 pm;
- iii) The Designated Premises Supervisor must undertake the following courses as soon as possible, but within no longer than 28 days:
 - a. the BIIAB Level 2 National Certificate for Designated Premises Supervisors, and
 - b. the BIIAB Level 2 Award in Conflict Management
- A meeting between the Police Licensing Officer and Designated Premises Supervisor will take place within 14 days of completion of the above courses to discuss how the Designated Premises Supervisor is going to promote the Licensing Objectives.

Reason for decision:

We have taken note of the agreement reached between the parties to modify the conditions in order to promote the Licensing Objectives and we agree to modify the conditions as agreed as we believe this will promote the Licensing Objectives and alleviate the concerns of the Police.

We note the acceptance of the Designated Premises Supervisor's Solicitors that the Police will have the right to rely on the evidence supporting this Review in any future Review relating to these premises.

Respondent's response to representations:

With the agreement of all parties present, the Respondent circulated a poster advising patrons to 'keep the noise down when smoking and using the patio area'.

Decision:

That the Premises Licence be revoked in respect of the Old Brewery, Lower Ellacombe Church Road, Torquay.

Reason for decision:

Having carefully considered all the written and oral Representations and answers to questions put by the Members, they resolved that this decision was proportionate and necessary for the following reasons:

Members were seriously concerned at the impact on the Licensing Objectives and on the complainant and her families' quality of life by Mr Martin's continued and apparent unwillingness or inability to manage his Premises. These concerns are reinforced by the evidence provided by Torbay Council's Senior Environmental Health and Licensing Officers and the Police.

Members are satisfied by the evidence before them that Mr Martin had been given extensive advice and guidance by Officer's of the Council and the Police in an attempt to assist Mr Martin to manage his Premises in an effective manner to promote the Licensing Objectives, to not carry out regulated entertainment for which his current Premises Licence does not permit and to alleviate the negative impact the running of his Premises is having on the quality of the life of the complainants.

Despite this advice, guidance and enforcement action by the Council, Members were seriously concerned that Mr Martin continued to allow amplified music to be played at his Premises which caused a significant nuisance to the complainants and is other than in accordance with his current Premises Licence. As such Members resolved that they could not be satisfied that Mr Martin would comply with any conditions and lawful activities in the future.

Although Members noted the Petition and the Representations from the Interest Parties in the benefit of having a community pub, which they found to be valid, Members resolved that this benefit should not be to the detriment of those living within the community, as supported by the case of R v Dennis (2003) EWCH 793 (QB), as referred to by Mr Fudge. Members also found merit in the submission by the Police and Mr Fudge that there were other community pubs within Torbay that existed and were not detrimental to nearby residents and that this was down to these Premises being managed effectively.

Members found that the measures taken by Mr Martin in his own admission that he had tried everything to be inadequate and flawed. In particular the keeping of a daily book which did not record evidence of Police visits which Members believed should have been relevant information to record so that he could have acted upon the concerns raised by the Police. In addition, the oral Representation by Mr Martin that he would welcome help from the Responsible Authorities as to what else he could do, did not alleviate their serious concerns as he had not acted upon previous advice or guidance offered by the Responsible Authorities to resolve historical and ongoing issues of concern.

Members noted with great alarm and empathy the audio evidence presented by Mr Fudge which demonstrated the continued impact this Premises is having on the complainant and her family's quality of life. This was noted in the knowledge of the evidence before them that Mr Martin was made fully aware of the noise nuisance, by Officer's in person and in writing. An aggravating feature of this evidence was that some of the audio evidence was recorded after the service of the Review Application and the service of an Abatement Notice on the Premises.

In concluding, Members considered all the options available to them to address the issues raised in this Review but found that adding conditions, curtailing what is already a limited Premises Licence, removing Mr Martin as the Designated Premises Supervisor and/or suspending the Premises Licence for a period of time to allow measures to be put in place to alleviate the concerns of the complainants and Responsible Authorities would in their opinion not be sufficient enough as Mr Martin's ongoing involvement in the Premises would result in the continuation of the Licensing Objectives being undermined, as evidenced and previously demonstrated.

1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a Variation to a Premises Licence. This application has been deferred from the Licensing Sub-Committee hearing on the 19 May 2011. A copy of the Committee report is shown as Appendices 1 to 4.
- 1.2 At the Sub- Committee hearing the Senior Licensing Officer referred to a letter that had been received from Coyote Café Bar stating that Coyote Torbay Limited had become technically insolvent and as such had ceased trading on the 11 May 2011. A copy of this letter is shown as Appendix 5. A letter was sent to Coyote Torbay Limited on the 17 May 2011 asking them to confirm if they wished to proceed with their Variation Application. This letter is show as Appendix 6. There was no response to the letter.
- 1.3 Further to the Sub-Committee hearing on the 19 May 2011 a letter was sent to Coyote Torbay Limited informing them of the Committee's decision to defer the consideration of their application until the 16 June 2011. The letter also stated that we had received an application to transfer the Premises Licence and as such, asked them if they wished to formally withdraw their application, as they were no longer able to carryout business from this Premises. This letter is shown as Appendix 7. A notice inviting Coyote Torbay Limited to the Sub-Committee meeting on the 16 June 2011 was also sent. This notice is shown as Appendix 8. Torbay Council's Licensing Department has to date, received no response from either of these letters.
- 1.4 On the 26 May 2011 an application was received from John Gaunt and Partners

Solicitors to transfer the Premises Licence to Whitbread Group Plc who own the freehold of the building. This is shown as Appendix 9. The letter that accompanied the application stated the whereabouts of the outgoing Premises Licence Holder is not known. The application for the transfer application was requested to take immediate effect and is due to be granted on the 9 June 2011. Whitbread Group Plc has previously held the licence from 5 August 2008 until 3 November 2010. It was transferred to Coyote Torbay Ltd.

1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a Variation to a Premises Licence. The Premise is situated within the Cumulative Impact Area.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 As the Licensing Authority has no powers under the Act to raise a Representation, Officers are unable to make any recommendation.
- 1.4 The matters raised relate to the Licensing Objective "The Prevention of Public Nuisance".
- 1.5 The matter must be considered on its merits having received details of the issues arising either at a hearing or by written Representation if all parties have agreed that a hearing is not necessary. Having regard to the Representation, a decision must be made to take such steps as are necessary for the promotion of the licensing objectives. These are either:-
 - (a) to modify the conditions of the licence, or
 - (b) reject the application in whole or in part.

For this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

1.6 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Responsible Authorities at the determination of the matter.

2. Introduction

2.1 An application has been made under Section 34 of the Act for a Variation to a Premises Licence. Details of the application are shown in Appendix 1. Only the relevant pages of the application are shown.

A brief description of the proposed Variation is as follows:-

To increase the times for Films, Recorded Music, Performance of Dance, Provision of Facilities for Making Music, Provision of Facilities for Dancing, and the Supply of Alcohol both on and off the Premises. These activities are currently licensed from 1000 until midnight Sunday to Wednesday and from 1000 until 0100 Thursday to Saturday. The Variation requests these hours are extended to allow the activities to be licensed from 1000 until 0300 seven days a week. This is an extra 3 hours Sunday to Wednesday and an extra 2 hours Thursday to Saturday.

To increase the times for Late Night Refreshment from 2300 until 0300 7 days a week. The Premises is currently licensed for this activity from 2300 until midnight Sunday to Wednesday and from 2300 until 0100 Thursday to Saturday. This is an extra 3 hours Sunday to Wednesday and an extra 2 hours Thursday to Saturday.

To be open to the public from 0800 until 0330 7 days a week. The Premises is currently licensed to be open from 1000 until 0030 Sunday to Wednesday and from 1000 until 0130 Thursday to Saturday. This is an extra 5 hours Sunday to Wednesday and an extra 4 hours Thursday to Saturday.

- 2.2 There is a current Premises Licence in place which is shown as Appendix 2.
- 2.3 Torbay Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 35(1) but is unable to issue the amended Premises Licence, as relevant Representation have been received from a Responsible Authority. The Licensing Authority is also satisfied that the Representation was received within the appropriate time-scale, has not been subsequently withdrawn and is not vexatious or frivolous.

We have received a Representation from Public Protection in relation to the Licensing Objective "The Prevention of Public Nuisance". This is shown as Appendix 3.

There have been no additional Representations received from any other Responsible Authority or any Interested Party.

- 2.4 The Authority is required to conduct a hearing by the provisions of Section 35(3) unless all parties agree that this is not necessary.
- 2.5 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.6 If the application is rejected, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.

2.7 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 4(2) of Schedule 5 to :-

(a) The applicant for the variation of the licence against any decision to modify the conditions

- (b) Any person who made a relevant representation in relation to the application who desires to contend
 - (i) that any variation made ought not to have been made, or

(ii) that, when varying the licence, the Licensing Authority ought to have modified the conditions of the licence or ought to have modified them in a different way.

2.8 Following such Appeal, the Magistrates' Court may:-

(a) dismiss the appeal,

(b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or

(c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,

and may make such order as to costs as it thinks fit.





ANNEXE 1

MANDATORY CONDITION: WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

1) No supply of alcohol may be made under the premises licence:-

- (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

3) . (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on -

- (i) the outcome of a race, competition or other event or process, or
- (ii) the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti social behaviour or to refer to the effects of drunkenness in any favourable manner.

4) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

5) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

6) (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.





7). The responsible person shall ensure that -

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) beer or cider: 1/2 pint;

- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (ii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

MANDATORY CONDITION: DOOR SUPERVISION

- 1) Where one or more individuals are carrying out security activities, each individual must be licensed by the Security Industry Authority.
- But nothing in the aforementioned conditions requires such a condition to be imposed in respect of a) and b) and (b)(i) and (b)(ii)
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), are exempt.
 - (b) In respect of premises in relation to-
 - any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- 3) For the purposes of the aforementioned conditions:-
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

MANDATORY CONDITION: EXHIBITION OF FILMS

- 1) Where the film classification body is specified in the licence, admission of children must be restricted in accordance with any recommendation made by that body.
- 2) Where -
 - (a) the film classification body is not specified in the licence, or
 - (b) the relevant licensing authority has notified the holder of the licence that this condition applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

In the case of the aforementioned conditions

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (authority to determine suitability of video works for classification).

- 2. Such a person shall be employed at the premises at the discretion of the designated premises supervisor/holder of the Premises Licence.
- 3. Any person as defined in condition (1) shall clearly display his name badge at all times whilst on duty.
- 4. No customers apparently carrying open bottles upon entry shall be admitted to the premises at any times the premises are open to the public.
- 5. Where CCTV is installed with recording facilities, such recordings shall be retained for a period of 30 days and made available within a reasonable time upon request by the police.
- 6. Alcoholic and other drinks shall not be removed from the premises in open containers save for consumption in any external area provided for that purpose.

Public Safety

- 1. The resonable requirements of the fire officer shall be complied with from time to time.
- 2. The reasonable requirements of the building control officer shall be complied with.

The Prevention of Public Nuisance

- 1. Where appropriate, prominent, clear and and legible notices shall be displayed at all exits requesting the public respect the needs of local residents and to leave the premises and area quietly.
- 2. Noise or vibration shall not emanate from the premises so as to cause a nuisance to nearby properties.
- 3. Where necessary shall liaise with the environmental health department to restrict noise pollution in residential areas.

The Protection of Children From Harm

1. Persons under the age of 18 years shall not be permitted to enter the premises after 22.00.

CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY The Prevention of Crime and Disorder

- 1. A CCTV system of an evidential standard shall be installed to the satisfaction of the Police, and the system to be in operation at all times the premises are open to the public. All recordings from that system shall be kept for a period of 31 days and the police to have access to recordings at any reasonable time.
- 2. On every occasion that the premises sells alcohol after midnight and then closes after 12.30am, SIA door staff shall





ANNEXES continued be employed from 9.00pm until closing.

- 3. All drinks shall be served in shatterproof glasses and no alcohol to be served in glass bottles from which it is intended or likely that a person shall drink.
- 4. Premises shall join and maintain membership of the Nitenet Radio Communications Scheme.
- 5. There shall be no entry or re-entry to the premises after 12 midnight.

Public Safety

1. If there is a requirement placed upon a Premises Licence for Security Industry Authority (SIA) Trained Stewards, then the ratio of stewards to customers on the premises shall be no less than 1:75.

The Prevention of Public Nuisance

- 1. Recorded and live music, provision for making music, films and dancing shall be permitted on Monday, Tuesday, Wednesday, Thursday, Friday and Saturday between the hours of 12.00hr to 23.00hr and on Sunday between the hours of noon to 22.30hr, thereafter any regulated entertainment taking place shall be restricted to entertainment of a nature and at a volume which permits normal conversation in the premises.
- 2. Noise or vibration shall not emanate from the premises such as to cause persons in the neighbourhood to be unreasonably disturbed. In general terms, noise from the premises shall not be audible within any noise sensitive premises (e.g. dwelling) with windows open for normal ventilation especially after 23:00hr. This shall be assessed from the boundary to the nearest residential properties, on all sides of the licensed premises. The criteria that will be applied are;

Before 23:00hr- Noise emanating from the premises shall not be clearly distinguishable above other noise.
 After 23:00hr- Noise emanating from the premises shall not be distinguishable above background levels of noise.

(iii) The local authority shall reserve the right in cases of tonal noise and where premises are attached to others (i.e. semi's and terraced properties), to make further assessments from within the residential property.

- 3. To allow live and amplified music inside doors and windows shall be kept shut during entertainment beyond this time, to reduce noise break out. A management scheme shall be in place to ensure this situation remains.
- 4. Deliveries of kegs, bottles, food or other materials necessary for the operation of the business shall be carried out at such a time or in such a manner as to prevent nuisance and disturbance to nearby residents.
- 5. The handling of beer kegs, bottles and other similar items shall not take place in the late evening, at night and during the early morning, when the noise generated could cause a nuisance particularly outside buildings.
- 6. Bottle skips and bins containing cans or bottles shall not be emptied outside after closing but shall be dealt with the next day during normal office hours.
- 7. The movement of bins and rubbish outside the premises shall be kept to a minimum after 23.00hr. This shall help to reduce the levels of noise produced by the premises.

The Protection of Children from Harm

- 1. No alcohol shall be sold to any person under the age of 18. Age identification shall be sought from any person appearing to be under the age of 18 years.
- 2. Staff shall receive training on matters related to the sale of alcohol.

This premises is situated in a mixed residential and commercial area of Union Street in the centre of Torquay. Whilst it is not immediately adjacent to the premises some of the residential accommodation is occupied by vulnerable adults as there is sheltered accommodation opposite the main entrance on Abbey Road. Furthermore, there are a large number of flats above the Tesco store opposite in Fleet Street.

I have already received complaints in respect of noise arising from the premises. I believe the number of complaints received has been limited by the fact that the premises has only been open thus far through the winter. This has the effect of limiting the number of people that attend the premises and reducing the level of noise reaching sensitive people as they tend to have their windows closed.

However, as the summer approaches, I am concerned that there will be a significant increase in disturbance arising from the premises particularly from patrons attracted to the area by the later hours, most notably, this will occur at 03:30 am when the premises closes and when patrons leave the premises to smoke.

The nearest housing is a sheltered housing complex for the elderly, and it is clear, that they will not be able to have their windows open during the summer evenings as they are likely to be disturbed by the activities of patrons at the above premises, particularly at closing time. Furthermore, the Residential accommodation above the Tesco Store is also likely to be disturbed.

I have not received any communication from the management of the premises identifying how they intend to address my concerns.

If the committee are minded to grant the extension to the licence, I recommend that careful consideration be given to conditions being placed on the licence.

Typically in these situations, I receive complaints regarding patrons outside premises smoking causing noise complaints as well as noise from patrons leaving. The Health and Safety Executive published information that indicates that 80% of people ignore signs giving instruction, I therefore, have no reason to believe that patrons leaving the premises who have been drinking will pay any more heed to signs requesting that they leave quietly

so I do not feel the provision of signs would offer any control. I would therefore, recommend that conditions be placed on the consent requiring that door staff actively manage patrons in the street and speak to them when they leave to ensure that they behave in a reasonable manner. Active management would include such measures as speaking to customers being unduly noisy and banning persistent offenders.
