Decision:

That the application for a Premises Licence be granted as applied for subject to the following:

That the proposed timings detailed in the application shall be permitted from 9 a.m. until 11 p.m. except for live music and performance of dance which will cease at 10 p.m.

That Schedule 4 point 16 be amended to read:

'That there shall be no more than 10 days of events per year and these shall be no more than 2 days consecutive.'

That the condition be added as proposed by the Police and agreed by the applicant. However this condition shall be amended to include the Torbay Council Licensing Department and therefore shall read as follows:

'A copy of risk assessments, event itinerary and event notification shall be supplied to the local Police Inspector, Torbay Police Licensing Department and Torbay Council's Licensing Department at least three months prior to any event.'

That the following amendments shall be made to the operating schedule as proposed by the Legal Advisor and agreed by the Applicant:

Schedule 1 point 5 shall read:

'All relevant documentation such as health and safety records and policies, risk assessments (including fire assessment), evacuation plans, site maps, emergency procedures, communications lists and insurances shall be kept available and produced for inspection when required by persons of a responsible authority.'

Schedule 1 point 6 shall read:

'Attendants shall as far as reasonably practicable be evenly distributed throughout all parts of the premises to which the public have access and we will keep under observation all parts of the premises to which the audience have access, to ensure crowd control and security.'

Schedule 2 point 2 shall read:

'A register of staff, including security staff, working at the premises whilst the public is present shall be maintained and available upon request of the Police, Local Authority and Fire Service.'

Schedule 2 point 7 shall read:

'In the event of an alcohol licence being issued for an event only plastic glasses shall be used and extra security staff shall be hired as required and agreed by the Public Safety Advisory Group and recommended to be followed. No glass bottles will be sold.'

Schedule 3 point 4 shall read:

'Adequate access for emergency vehicles shall be provided and kept free from obstruction. Emergency points and hydrants shall be maintained.'

Schedule 3 point 11 shall read:

'Persons shall not be allowed to stand, sit or otherwise remain in any gangway or exit way.'

Schedule 5 point 1 shall read:

'There shall be a lost children's point on site and facilities to have announcements as laid out in the specific event operational plan.'

Reason for Decision

Having carefully considered all the written and oral representations Members resolved that in light of the comprehensive conditions put forward in the application. The oral reassurance from the Police that the Applicants had done everything to get their application right and as such supported it in the belief that they will work with them to ensure the local population is not unreasonably affected. Members noted the representations by the residents and gave them due consideration. However it was noted by Members the absence of any representation from the Environmental Protection Department and as such were reassured by the conditions proposed in Schedule 4 of the applicants operating schedule that should alleviate the concerns of the residents in respect of public nuisance.

Members were also reassured that the applicant has considered the impact that their application will have on nearby residents and in their opinion resolved that all reasonable steps had been taken.

Should issues arise as a result of this grant, that seek to undermine the Licensing Objectives, Members would encourage a Review of this Licence from the Responsible Authorities or Interested Parties.

In concluding, Members resolved that these amendments and proposals are proportionate and necessary to ensure the promotion of the Licensing Objectives.

Prior to consideration of evidence provided by the Member of the Public, the Sub-Committee passed a resolution to exclude the press and public from the meeting on the grounds that exempt information (as defined in Part 1 of Schedule 12A of the Local Government Act 1972 (as amended)) was likely to be disclosed.

Decision:

That the application for a Premises Licence in respect of PB Stores, 105 Foxhole Road, Paignton, TQ3 3SU be granted as applied for subject to the inclusion of the condition proposed by the Police, and the amendment of the Challenge 21 policy to a Challenge 25 Policy, as agreed by the Applicant. In addition, the hours for the permitted sale of alcohol by reduced to 9 a.m. to 11 p.m., as agreed by the Applicant.

Reason for decision:

Having carefully considered all of the written and oral Representations, Members gave due consideration of the concerns raised by the Interested Party in particular respect to the Protection of Children from Harm, however they noted the absence of any Representation from Safeguarding Children or Trading Standards, and that Trading Standards had reported no incidence of underage sales of age-restricted products from this Premises previously.

In respect of anti-social behaviour and Police resources, Members noted no formal objection from the Police other than the imposition of a condition.

The conditions proposed by the Applicant, in the Members opinion, sought to promote the Licensing Objectives and as such alleviated their concerns of the issues raised by the Interested Party.

Should issues arise as a result of this grant, Members would encourage a Review of the Premises Licence.

That the application for a Premises Licence in respect of Co-operative, Foxhole Road, Paignton, TQ3 3SS be granted as applied for subject to the hours for the permitted sale of alcohol being reduced to 8 a.m. to 11 p.m., as agreed by the Applicant.

Reason for decision:

Having carefully considered all of the written and oral Representations, Members resolved that concerns in respect of the proposed hours for the permitted sale of alcohol on balance were alleviated given the comprehensive policies, procedures and training for staff in relation to the sale of age-restricted products, along with the history and reputation of this Applicant's retail experience.

Members considered the concerns raised by the Interested Party, but were satisfied that his concerns were alleviated by the oral Representation of the Applicant's Representative. Members noted the absence of Representations from the Responsible Authorities, and as such were reassured that the application sought to promote the Licensing Objectives.

Title: Licensing Act 2003 – An application for a Premises Licence in respect of Kingsway Minimart, 83 Kingsway Avenue, Paignton

1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a new Premises Licence.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 As the Licensing Authority has no powers under the Act to raise a Representation, Officers are unable to make any recommendation.
- 1.4 The matters raised relate to the Licensing Objectives "The Prevention of Crime and Disorder", "Public Safety", "The Prevention of Public Nuisance" and "The Protection of Children from Harm".
- 1.5 The matter must be considered on its merits having received details of the issues arising either at a hearing or by written Representation if all parties have agreed that a hearing is not necessary. A decision must be made, having considered the Representations, either:-
 - (a) to grant the licence subject to

(i) such conditions as are consistent with the submitted operating Schedule modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and

(ii) any condition which must under Section 19, 20 or 21 be included in the licence;

(Such conditions may differ in respect of different parts of the Premises and/or different activities).

(b) to exclude from the scope of the licence any of the licensable activities to which the application relates;

- (c) to refuse to specify a person in the licence as the Premises Supervisor;
- (d) to reject the application.

1.6 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Interested Parties and Responsible Authorities following the determination of the matter.

2. Introduction

2.1 An application has been made under Section 17 of the Act for a Premises Licence to permit licensable activities at the Premise detailed above. Details of the relevant pages of the application and the plan are shown in Appendix 1 and 2.

A brief description of the application, as follows:

The sale of alcohol on and off the Premises from 0700 until 2300, 7 days a week.

To be open to the public from 0700 until 2300, 7 days a week.

2.2 The Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 17(5) but is unable to issue the Licence, as a relevant Representation has been received from an Interested Party. The Licensing Authority is also satisfied that the Representation has been received within the appropriate time scale, has not been subsequently withdrawn and is not vexatious or frivolous.

We have received one Representation from an Interested Party in relation to the Licensing Objectives "The Prevention of "Crime and Disorder", "Public Safety", "The Prevention of Public Nuisance" and "The Protection of Children from Harm". This is shown in Appendix 3.

- 2.3 The Authority is required to conduct a hearing by the provisions of Section 18(3) unless all parties agree that this is not necessary.
- 2.4 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.5 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.
- 2.6 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 2(1) of Schedule 5 to :-
 - (a) The holder of the licence against any decision
 - (i) to impose conditions on the licence, or
 - (ii) to take any step to exclude a licensable activity or refuse to specify a person as Premises Supervisor.
 - (b) Any person who made a relevant Representation who desires to contend
 - (i) that the licence ought not to have been granted, or
 - (ii) that, on granting the licence, the Licensing Authority ought to have imposed different or additional conditions, or taken any step to

exclude a licensable activity or refuse to specify person as Premises Supervisor.

2.7 Following such Appeal, the Magistrates' Court may:-

(a) dismiss the appeal,

(b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or

(c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,

and may make such order as to costs as it thinks fit.

Background History

These premises have been empty for over two years. The previous business trading as a Costcutter shop had held a premises licence which was surrendered on the 30th December 2008. The application is for a newly established independent local neighbourhood store. The shop has undergone substantial refurbishment resulting in the creation of a convenience store with a retail selling area in excess of 600 sq ft.

The Shop

This purpose built shop has been designed to serve both the local community and those from further a-field. Trading as a convenience store, under the **Mace** facia, a good range of fresh foods, groceries and other products are to be offered and the off-licence is an important part of the service that the store is expected to provide.


The Operation

The store is to be operated by the manager, assisted by a team of full and part time staff all whom will live locally. The designated premises supervisor, trained and certified through the an accredited training scheme will be responsible for training all staff and keeping and maintaining ongoing training records utilising the **Premises Licence Manual**. The **Challenge 21** trading initiative is also used supported by the refusals system with records kept in the **Refusals Book** to tie in with the CCTV system. The premises will be fully alarmed.

Security

The CCTV system benefit from a 24-hour recorder and library which can be made available to Police if required.

Retail Trading Area


