Members were informed that the Applicant had returned their notice, in accordance with Section 8 (1)(a) and (2) of The Licensing Act 2003 (Hearings) Regulations 2005. The Applicant was accompanied by a friend who had not been specified on the notice as attending. Members' permission was sought and granted for the Applicant's friend to assist the Applicant in presenting the Application.

Applicant's response to Representations:

During deliberation it was deemed necessary for the Senior Lawyer to seek clarification from the Applicant regarding the sale of alcohol, following a submission put forward by the Applicant during the hearing. As a result, Members were advised that the Applicant agreed to the sale of alcohol being amended from 8am to 11a.m.

Decision:

That the application for a Premises Licence in respect of Ephesus Turkish – Greek Restaurant, 48 Torwood Street, Torquay be granted as applied for, subject to the following amendment and additional conditions being imposed:

- i) that the sale of alcohol be permitted from 11 a.m., as opposed to 8 a.m.
- ii) that staff shall monitor the outside area during opening times to ensure that Patrons do not congregate at the shared entrance to the Premises;
- that notices shall be displayed in a prominent position in the shared entrance area stating that "No smoking and drinking shall occur in that area"; and
- iv) that notices shall be displayed prominently informing Patrons when leaving the premises to keep noise to a minimum, to ensure that that nearby residents are not disturbed.

Reason for Decision:

Having carefully considered all the written and oral Representations, Members resolved to grant the application subject to the amendment and additional conditions being imposed, having been satisfied that to do so would not undermine the Licensing Objectives.

Members considered the application in respect of the Councils Licensing Statement of Principles 2011 and resolved to depart from the Policy noting that the grant, in their view, would not add to the problems of crime and disorder and/or public nuisance in the area.

Members also noted that there were no Representations from either of the Responsible Authorities.

1. What we are trying to achieve

1.1 This report concerns a Torbay Council Licensed Driver who is said to have used aggressive, threatening and abusive language towards two Torbay Council Civil Enforcement Officers.

2. Recommendation(s) for decision

2.1 There is no recommendation.

3. Key points

- 3.1 By the provisions of the Town Police Clauses Act 1847 and the Local Government (Miscellaneous Provisions) Act 1976, Torbay Council is the Licensing Authority in respect of Hackney Carriages, Private Hire Vehicles and their drivers within Torbay.
- 3.2 On the 1st May 2013 Torbay Council's Licensing Team received an email from the Council's Parking Services stating that an incident involving Hackney Carriage Vehicle number 30, and two of their Civil Enforcement Officers had occurred at the GPO roundabout in Torquay. It said that the Driver used aggressive, threatening and abusive language towards the two Officers when they approached him about parking in areas in Torbay covered by Road Traffic Orders, as well as causing an obstruction to other road users. Enquires showed that Mr Imran Nasim was the Driver Licensed to use this vehicle, at the time of the alleged incident

3.3 To assist Members in dealing with this matter, it is important to note that this is not the first time that Mr Nasim has come to the attention of the Council's Licensing Team and Licensing Sub-Committee due to incidents of unacceptable conduct. Mr Nasim has a history of complaints against him, including one occasion where his driver's licence was suspended by the Licensing Sub Committee for 7 days due to parking offences. Mr Nasim has also received a final warning letter about further parking issues and allegations of overcharging customers. This is brought to Members attention as in accordance with Section 18.4, Page 28, of the Torbay Council Hackney Carriage (Taxi) and Private Hire Policy 2013. A summary of these and other incidents held by the Licensing Team can be seen at A1.8 below

Supporting information

A1. Introduction and history

- A1.1 By the provisions of the Town Police Clauses Act 1847 and Local Government (Miscellaneous Provisions) Act 1976, Torbay Council is the Licensing Authority in respect of Hackney Carriages, Private Hire Vehicles and their drivers within Torbay.
- A1.2 This report concerns a Torbay Council Licensed Drivers behaviour towards two Civil Enforcement Officers when approached about parking in areas in Torbay covered by Road Traffic Orders, as well as causing an obstruction to other road users.
- A1.3 On the 1st May 2013 Torbay Council's Licensing Team received an email from the Council's Parking Services giving details of an alleged incident that occurred at the GPO Roundabout, Torquay. The email referred to aggressive, threatening and abusive language towards two of their Civil Enforcement Officers when they approached the driver of Hackney Carriage plate number 30 to inform him that he had parked on the Double Kerb Blip outside of the Taxi Bay markings. A copy of the email is shown as Appendix 1 and photographs taken by the Civil Enforcement Officer at the time are shown as Appendix 2. A second Civil Enforcement Officer has provided a statement shown as Appendix 3.
- A1.4 As a result of the allegation the Licensing Team sent a letter dated 1st may 2103 to Mr Steven Fenlon, the owner of the vehicle, regarding the allegation and to confirm who was driving the vehicle at the time. This is shown as Appendix 4.
- A1.4 In response to the letter to Mr Steven Fenlon we received an email from Mr Imran Nasim on 6th May 2013 who confirmed he was the driver of the vehicle, Hackney Carriage plate number 30, registration WG08 BFY. This is shown as Appendix 5. We also received a letter from Mr Imran Nasim on 7th May 2013 to give further information about his interpretation of events regarding the alleged incident. The letter is shown as Appendix 6.
- A1.5 A letter was subsequently sent from the Licensing Team to Mr Imran Nasim on the 17th May 2013 offering him the opportunity to provide witness statements from other divers that may have observed the incident which could back up his claims. This letter is shown as Appendix 7. In response to this letter, the Licensing Team received 2 email statements. One from Miss Louise Cartright dated the 28th May 2013 who says she was on the taxi rank at the time of the alleged incident, this is shown as Appendix 8. The other was from Mr Steven Fenlon dated the 27th May 2013 who is the owner of vehicle plate 30 who also says he witnessed the alleged incident; this is shown as Appendix 9.
- A1.6 The submissions provided regarding this alleged incident give two conflicting accounts. As such, it is felt that the Licensing Sub-Committee should hear the evidence of both accounts and arrive at their own conclusion.
- A1.7 A summary of complaints held by the Licensing Team and the outcome are shown below:-

A1.8 There is a right of Appeal. Any Appeal would be to the Magistrates' Court within 21 days from the date of a Notice being sent out following the decision.


I told the first person that I was reporting him for his threatening and abusive manor. I was told to first off and he would be seeing me later when it was dark (Photos).





I would like very much to defend my position regarding an incident which occurred on Wednesday 1st of May 2013 at approx 11:55am. Whilst waiting for my next customer on the GPO roundabout Rank, I was approached by two traffic enforcement officers, who immediately, through their behaviour and manner, made me feel threatened and harassed. One of the officers seemed to be in charge and was issuing orders, such as the other telling him to take photos of me and my vehicle.

The officer in charge didn't, at any time, want to discuss anything calmly or seemingly rationally. He seemed intent on showing up a taxi driver showing, it seemed, 'how they should be handled' - i would like to enquire whether the officer with him was in training of any sort?

I have received photographs indicating that i was driving up the Pimlico area along the one way street.

However, it can clearly be seen by these same photos that i am reversing to ensure i am doing exactly as i was instructed.

In the letter i received with the same photos it was also insinuated that a driver travelling down Pimlico had to 'slam on' to avoid me and an accident.

This driver did no such thing; he saw me and waived me on letting me manouvre into a new spot. This was witnessed by several drivers.

The spot that i was manouvering into was being vacated by Louise Cartwright; who also witnessed the whole episode.

Whilst i understand that the traffic officers have a job and duty to enforce traffic law it really seemed to me to be an incident blown out of all proportion admittedly, on both sides, our discussion became heated as he and i had a complete difference of opinion as to what i was actually doing.

Morning Shaun,

As per our conversation regarding the incident involving Imran and 2 traffic enforcement officers.

On the day in question Shaun I can categorically confirm that Imran was not, under any circumstances, trying to drive up a one way system after being asked to move his vehicle from over the line on the GPO roundabout rank. I actually moved for Imran to move into my space as I was going for lunch with my partner. I was quite shocked at the behavior of the warden and felt that he was trying to come across very much as he was going to prove his authority with Imran due to him being with a younger warden (I think the other warden was in training). Once I'd pulled around the roundabout I did notice the traffic warden seemed to be goading Imram by waking back to carry on the discussion (which I did not hear). Having read the letter which was sent by yourself to Imran I am shocked at the accusations that are being made against him regarding the verbal abuse that was apparently pointed towards the officers by Imran.

Shaun, I was there, I did not here any kind of verbal abuse, I don't doubt for one second that Imran was not however annoyed at the way he was spoken to. I have had experience of this particular traffic warden in the past and I must say that I find his manner extremely aggressive and not at all professional. I know that as taxi drivers we are not perfect, far from it, and yes we park where we shouldn't some of the time, but I have always responded well to the traffic wardens for several reason, like us, they have a job to do and its the law. It's also the way that they deal with us and the majority of them are very good. The fact remains that when a traffic warden asks us to move etc, we are somewhere we shouldn't be, but does this give the odd one the right to speak to us like we are stupid????? I am aware that you have photographic evidence of Imran sticking up his middle finger, again, I did not see this. The accusation that the warden has made about Imran threatening to attack him once he is out of of uniform is a serious allegation!!!! and if found to be true this could result in Imran losing his taxi licence, I can only hope that facts are correct at the time of this decision being made. I would also like to ask if this particular traffic warden has been taken to task regarding his attitude?

I am aware that there has been issues with Imran in the past, but having done a little bit of investigation of my own, Imran seems to of sorted himself out and from speaking to the other drivers (mainly on the GPO rank) he seems to of settled down. Shaun, as you know I've had problems of my own since becoming a Hackney driver. Taxi drivers are a pain in the arse at the best of times, but, the one thing I have always tried to hold onto is a sense of justice and I feel very strongly about this particular incident and the allegation's that have been made. As i said to you during our conversation I would never bare false witness for anyone, nor would I lie if I thought somebody was in the wrong, regardless of who they are. Re: Licensing Sub-Committee Hearing – 9th December 2010 Suspension of Hackney Carriage Drivers Licence

I am writing to you following the Licensing Sub-Committee hearing on the 9th December 2010 to consider a report with respect to the suspension of your Hackney Carriage Drivers Licence for 7 days. This was with regard to not complying with Torbay Council's Road Traffic Orders and byelaw.

The Licensing Sub-Committee decision "that Mr Imran Nasim's Hackney Carriage Driver's Licence be suspended for a period of seven days on the ground of 'any other reasonable cause,' as in accordance with Section 61(1)(b) of the Local Government (Miscellaneous Provisions) Act 1976. This will take effect from Friday 31st December 2010 for 7days unless you appeal the decision, see additional information below. The reasons given for the decision were that

"Having carefully considered all the oral and written Representations, the Sub-Committee resolved that Mr Nasim had received a warning letter from the Principal Safety and Licensing Officer dated 4 December 2009 and

a warning letter from the Environmental Health Manager (Commercial) dated 31 August 2010 raising awareness of the issues of taxis parking in bus bays and non compliance with the Road Traffic Orders. Mr Nasim confirmed that he had received these warning letters.

Members noted the correspondence from Richard Brown (Parking Operations Officer), PC Anthony Moorhouse, Leslie Dransfield (Public Transport Officer) and Christina Ratcliffe (Operations Manager – Torbay Stagecoach South West), contained within the report which highlighted the impact and concerns of public safety by drivers parking in the bus bays and obstructing the flow of traffic.

In addition, Members noted the admission of Mr Nasim that he had parked his vehicle in such a way so as to cause an obstruction on the 23 October 2010 at 00:43 and that he had been parked illegally at the GPO roundabout on Thursday 11 November 2010 at 18:01.

Members also found an aggravating factor in that despite receiving the warning letters and being advised in a letter dated 12 November 2010 that he was to come before the Licensing Committee, Mr Nasim received an endorsement on his drivers licence for parking illegally to alight passengers on the 27 November 2010.

Members felt that the suspension was a proportionate and necessary response to the breach of Road Traffic Orders and Byelaw 8 in an attempt to ensure public safety."

You do have a 21 day right of appeal regarding the decision to suspend your drivers licence from the date of this letter. This has to be made to the Magistrate's Court under Section 300 Public Health Act 1936. I attach a copy of the relevant sections for your information.

If you do appeal then the decision is suspended until the appeal is heard. If you do not appeal then you need to hand deliver your drivers badge to Roebuck House either late on Thursday 30th December 2010 or first thing on Friday 31st December 2010, and collect it again the following Friday 7th January 2011.

Can I take this opportunity to warn you, should you be caught again ignoring the Road Traffic Orders and Byelaws that any future recommendation for suspension will be a great deal higher.



Re: Complaints of contraventions of Road Traffic Orders and charging for journeys

I am writing to you with regard to two files that have been handed to me to consider with respect to non compliance with Road Traffic Orders and with respect to series of allegations/complaints about the charges you have made for journeys.

On the matter of the queuing on the GPO roundabout on Tuesday 7th June 2011, it is not my intention at this time to take this matter to Licensing Committee but to remind you that you have already been suspended once and should the matter be taken back to Licensing Committee I would anticipate a longer suspension. The letter, notes of the offence and your response will be kept on file should we have any future need to take the matter back due to a further offence, so please take this as a last warning.

On the matter of the complaints about overcharging for journeys, we have had four complaints spanning 18 months. This may not in itself seem like many, but bearing in mind we have no other driver who has more than one complaint, this reflects badly on you. As a result of this we undertook a test purchase operation on you and you will be pleased to know that you charged the correct fare on that occasion; however we can and may undertake this operation again.

The details of the four complaints are as follows. The first complaint, which we received in retrospect, related to over charging 18 months ago, so it was too long ago to investigate now. The second Craig Noble wrote to you about in a letter dated 8TH July 2010. The third related to an investigation regarding a journey dated 14th April 2011, which we have a third party statement and finally the last relates to a letter we have received regarding an incident on the 22nd May 2011. Having reflected on the evidence I have decided on balance that the appropriate action on this occasion is to warn you that if we receive any further complaints about overcharging, which we can substantiate, then you can expect to be referred to Licensing Committee with a recommendation for the revocation of your licence. Clearly any final recommendation or decision will ultimately be based upon the evidence available, but please take this as a final warning.
