Additional Information:

At the Hearing the Applicant made a request for additional time for oral representations. The Chairman agreed to the request from the Applicant and permitted 15 minutes for Oral Representations.

With agreement from the interested parties the Applicant and Council's Environmental Health Officer both circulated additional conditions for consideration.

### Decision:

That the application for a Variation to a Premises Licence, in respect of Park Lane, 1 Torwood Street, Torquay be granted as orally amended by the Applicant at the Hearing, in withdrawing all licensable activities from taking place on the newly constructed roof terrace area. This Variation is granted with the following conditions:

1) No entry or re-entry into the Premises after 02:00 hours.

- 2) No amplified or live music on the roof terrace at any time.
- The volume of background music must be set and maintained at a level that is agreed by a Torbay Council Environmental Health Officer before the roof terrace is open to the public.
- 4) Background music on the roof terrace must cease at 02:00 hours, and be in accordance with that detailed in Annex 3, conditions 7 and 8 of the Premises existing Premises Licence.
- 5) Before the roof terrace area is open to the public, the door leading onto the roof terrace area shall be inspected by an Environmental Health Officer of Torbay Council and where it is deemed necessary by that Officer, an acoustic lobby shall be constructed to the satisfaction of Torbay Council to ensure that potential noise outbreak from the Premises does not occur. Any such lobby shall be constructed before the roof terrace area is open to the public to use.
- 6) Where it has been necessary to construct a lobby as mentioned in point 5 above, that lobby shall be constructed and operated in such a way to ensure that if regulated entertainment is being played inside the premises, only one door shall be opened at any one time to prevent noise breakout. These doors shall be fitted with automatic closers.
- 7) After 23:00 hours numbers of patrons permitted to use the roof terrace area shall be limited to a maximum of 60 patrons at any one time.
- 8) Patrons shall not be permitted to take drinks onto the roof terrace area after 23:00 hours
- 9) All patrons consuming drinks on the roof terrace area must cease doing so at 23:00 hours and arrangements must be in place by the premises licence holder for all glasses to be cleared from that area at 23.00 hours. Those patrons wishing to continue drinking must be advised to do so inside the Premises.
- 10) All patrons using the roof terrace area shall be seated at all times.
- 11) Patrons who behave in a noisy or disorderly manner on the roof terrace area shall be removed from that area and where appropriate asked to leave the Premises. Details of this noisy or disorderly conduct shall be recorded in a log book and where appropriate, details of the patron(s) causing the noise or disorderly conduct shall be recorded in that log book too.
- 12) Signage must be displayed reminding patrons to keep noise to a minimum and warning customers who are excessively noisy or disorderly will be removed from that area and potentially the Premises.
- 13) The SIA door steward placed on the roof terrace area must as part of their duties ensure and manage customers' behaviour and take appropriate actions, as required by condition 11.

- 14) Patrons leaving the Premises for all purposes between 22:00 hours on Saturday nights until 02:00 hours on Sunday mornings will not be permitted back into the Premises without paying an entrance fee.
- 15) From the time the Premises open until 21:00 hours, members of staff and SIA door stewards should direct patrons to the roof terrace area if they suspect that the patron(s) is leaving by the main entrance to smoke outside the Premises.
- 16) From 21:00 hours until the Premises close, members of staff and SIA door stewards shall direct patrons to the roof terrace area if they suspect that the patron(s) is leaving by the main entrance to smoke outside the Premises.
- 17) Notices shall be prominently displayed within all bars of the Premises informing patrons who wish to smoke to use the roof terrace area.
- 18) If Torbay Council receives a complaint of noise nuisance emanating from the Premises and an Environmental Health Officer of Torbay Council deems noise nuisance to exist and the upholds the complaint, the Premises Licence Holder shall on receiving written confirmation of that complaint from Torbay Council:
  - a) Co-operate with Torbay Council's Environmental Health Officers and implement remedial measures to the satisfaction of the Environmental Health Officers immediately or as reasonably practicable to do so, as determined by the Environmental Health Officer; and
  - b) Where remedial action cannot be identified and remediated to the satisfaction of the Environmental Health Officer, the roof terrace area shall be closed to all patrons at 20:00 hours until such time that the noise nuisance can be identified and the necessary remedial work can carried out.
- 19) In respect of the roof terrace area, CCTV cameras shall be installed in this area to the satisfaction of the police and there shall be a monitor situated behind the ground floor bar for viewing by staff.
- 20) The roof terrace is to have a solid perimeter wall of at least eight feet, with the exception of the Torwood Street elevation where it shall be six feet. The wall is to have a density of at least 10 kilograms per square meter with no gaps.
- 21) Non sound reflective surfaces shall be used on the walls and floor where practically possible.
- 22) The roof terrace will close at:
  24:00 hours on Sunday, but 03:00 hours Bank Holiday Sundays;
  24:00 hours on Monday and Tuesday;
  02:00 hours on Wednesday
  24:00 hours on Thursday
  03:00 hours Friday and Saturday

- 23) The playing of back ground music shall switch off automatically at 02:00 hours.
- 24) At all times that the roof terrace area is open after 21:00 hours, an SIA registered door steward shall be situated in that area. Their duties will include, ensuring that persons using the roof terrace behave in an orderly manner, and that persons shouting, singing or acting in a way that may cause a noise nuisance will be asked to leave the roof terrace area and if necessary, the Premises.

### **Reasons for Decision:**

Having carefully considered all the written and oral representations and the significant amendment to the application, in that the Applicant was no longer seeking to apply for licensable activities on the roof terrace area, Members resolved to modify the Premises Licence, having been satisfied that noise nuisance and an increase in crime and disorder were occurring from and at this Premise.

Members noted the attempt made by the Applicant to address the concerns raised by the Police by constructing a smoking area to avoid patrons using the outside area of the Premises to smoke.

Taking in to consideration this attempt and concerns, Members gave careful consideration to the concerns and potential concerns raised by residents and the Council's Senior Environmental Health Officer. In doing so, Members concluded that not all noise nuisance could be attributed to this Premises, that the current situation at the Premises as it stood was unacceptable, that the restricted use of the roof terrace area with the additional 23 conditions should help alleviate the current increase in crime and noise nuisance, whilst placing more responsibility and control of those patrons on the Premises Licence Holder.

Members gave careful consideration to all of the conditions put forward by the Applicant, the Police and the Council's Environmental Health Officer and in turn, resolved that each of the conditions accepted and in part modified by them were appropriate in light of the current situation at the Premises, the concerns raised by both residents and Responsible Authorities and the Applicant's history of not immediately responding to or resolving Responsible Authorities concerns.

In considering the Council's Licensing Statement of Principles 2011, as raised in a number of representations, Members resolved that with the oral representation of the Applicant and his significant amendment to the application, the restricted use of the roof terrace area with the additional 23 conditions that the grant of this variation would not add to crime and disorder or public nuisance. Instead Members concluded that the grant of this variation would alleviate the current unacceptable situation and promote the Licensing Objectives which on the evidence before them, were clearly being undermined.

Having given careful consideration to all of the concerns raised in respect of this Premise and the Premises Licence Holder, Members resolved that the modification of this licence should alleviate these concerns. However if it does not, Members in concluding noted that both Interested Parties and the Responsible Authorities could call a Review of this Premises Licence.

### 1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a Variation to a Premises Licence.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 The matters raised relate to the Licensing Objectives "The Prevention of Crime and Disorder", "The Prevention of Public Nuisance", "Public Safety" and "The Protection of Children from Harm".
- 1.4 The matter must be considered on its own merits having received details of the issues arising either at a hearing or by written Representations if all parties have agreed that a hearing is not necessary. Having regard to the Representations and issues arising, a decision must be made to take such steps as are necessary for the promotion of the licensing objectives. These are either:- (a) to modify the conditions of the licence, or (b) reject the application in whole or in part.

For this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

1.5 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Interested Parties and Responsible Authorities at the determination of the matter.

### 2. Introduction

2.1 An application has been made under Section 34 of the Act for a Variation to a Premises Licence. Details of the application are shown in Appendix 1. Only the relevant pages of the application are shown.

A brief description of the proposed Variation is as follows:-

To extend the hours for the Sale of Alcohol off the Premises to 24 hours daily.

The licence presently allows the Sale of Alcohol off the Premises Monday to Saturday from 0800 until 2300; Sunday 1000 until 2230; Good Friday 0800 until 2230; Christmas Day 1200 until 1500 and 1900 until 2230.

To add the Provision of Late Night Refreshment from 2300 until 0500 daily both indoors and outdoors.

To be open 24 hours daily. The licence presently has no restrictions on opening hours.

To remove the embedded restrictions in the licence as detailed in section L of the application.

To make structural alterations to the Premises and to increase the licensable area to allow the Sale of Alcohol and the Provision of Late Night Refreshment throughout the entire Premises.

- 2.2 A copy of the current premises licence showing the licensable activities, timings and conditions is shown at Appendix 2 of this report.
- 2.3 Torbay Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 35(1) but is unable to issue the variation to the Premises Licence, as relevant Representations have been received from Responsible Authorities and Interested Parties. The Licensing Authority is also satisfied that the Representations were received within the appropriate time-scale, have not been subsequently withdrawn and are not vexatious or frivolous.

We have received a Representation from the Police in relation to the Licensing Objective "The Prevention of Crime and Disorder" and "The Protection of Children from Harm". This is shown as Appendix 3 of this report.

We have received a Representation from Public Protection in relation to the Licensing Objective "The Prevention of Public Nuisance". This is shown as Appendix 4 of this report.

We have received 16 Representations from Interested Parties in relation to the Licensing Objectives "The Prevention of Crime and Disorder", "The Prevention of Public Nuisance" and "Public safety".

Of these Representations one is in the form of a petition with 38 signatures. The other 15 Representations have in total 20 signatures. It is important to note that 6 Interested Parties who have sent individual Representations have also signed the petition and are included within the 38 signatures. These are shown as Appendix 5 of this report.

There have been no Representations received from any other Responsible Authority or any other Interested Party.

- 2.4 The Authority is required to conduct a hearing by the provisions of Section 35(3) unless all parties agree that this is not necessary.
- 2.5 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.6 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.
- 2.7 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 4(2) of Schedule 5 to :- (a) The applicant for the variation of the licence against any decision to modify the conditions
  - (b) Any person who made a relevant representation in relation to the application who desires to contend
    - (i) that any variation made ought not to have been made, or

(ii) that, when varying the licence, the Licensing Authority ought to have modified the conditions of the licence or ought to have modified them in a different way.

- 2.8 Following such Appeal, the Magistrates' Court may:-
  - (a) dismiss the appeal,

(b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or

(c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,

and may make such order as to costs as it thinks fit.

### b) The prevention of crime and disorder

- 1. A CCTV system will be installed, or the existing system maintained, such system to be fit for the purpose.
- 2. The CCTV system shall be capable of producing immediate copies of recordings on site. Copies of recordings will be capable of being recorded digitally on to CD/DVD or other equivalent medium.
- 3. Any recording shall be retained and stored in a suitable and secure manner for a minimum of 28 days and shall be made available, subject to compliance with Data Protection legislation, to the police for inspection on request.
- 4. The CCTV system will incorporate a camera covering the entrance door and the alcohol display areas and will be capable of providing an image which is regarded as identification standard. The precise positions of the cameras may be agreed, subject to compliance with Data Protection legislation, with the police from time to time.
- 5. The system will display, on any recording, the correct time and date of the recording.
- 6. A system will be in place to maintain the quality of the recorded image.
- 7. The CCTV system will be maintained so as to be fully operational throughout the hours that the premises are open for any licensable activity.

### c) Public safety

The premises licence holder will at all times maintain adequate levels of staff. Such staff levels will be disclosed, on request, to the licensing authority and police.

### d) The prevention of public nuisance

Adequate waste receptacles for use by customers shall be provided in and immediately outside the premises.

### e) The protection of children from harm





The Premises Licence Holder or Designated Premises Supervisor shall ensure that a Refusals Register is maintained to include details of all alcohol sales that are refused and the reason for refusal. This register shall be retained for a period of 12 months and will be made available to the Police Licensing Officer, and other authorised enforcement officers of Responsible Authorities on request.
- 9. Challenge 25 Posters shall be displayed in prominent positions within the premises and adjacent to the service hatch.
- 10. An Incident Book shall be maintained to record details of the dates, times and details of any incidents occurring on the premises. This Incident Book shall be retained for a period of 12 months and will be made available for inspection at any reasonable time by the Police Licensing Officer or other authorised enforcement officers of Responsible Authorities on request.
- 11. The Premises Licence Holder or Designated Premises Supervisor shall ensure that all members of staff employed in the sale of alcohol shall receive appropriate training, and regular refreshment training, with regards to the Challenge 25 Policy, the identification of persons who are drunk and refusing service. A record of such training will be maintained and kept on the premises for a period of 12 months and shall be available for inspection at any reasonable time by the Police Licensing Officer or other authorised enforcement officers of Responsible Authorities on request.

After careful consideration of the above application, I wish to make it known to the licensing committee my views on the proposed application to assist your deliberations.

Abbey service station is located on a busy main road in area of mixed residential and business use. The site currently operates 24hrs a day for the sale of petroleum products and the shop provides a typical range of consumable products offered by most petrol stations. Currently the shop closes to the public at 11:00pm and service is offered via the night hatch until 6:00am the following morning. This site like many petrol stations are single manned during the night period and to my knowledge this is the only 24hr petrol station serving Torquay.

The department in the last ten years has received one complaint about noise and rubbish in 2007. The site was under different management at the time and the owners were given advice and no further complaints have been received to date from members of the public or other businesses.

It is my view that as the site currently operates 24hrs a day without any recorded history of noise complaints to our department and if this application is therefore granted as applied for it is unlikely to add to the existing noise environment and therefore not currently undermine the licensing objective 'The Prevention of Public Nuisance'.

This opinion is based upon the fact that the current activities, i.e. the sale of groceries, which could be commercially expanded and have been a planning matter for consideration in the past, are not licensable activities and would arguably form the basis for the majority of sales during the night time period even if this application was agreed. This we have no power to manage via the Licensing Act 2003 but could form the basis for a complaint under other statutory provisions, and would be investigated through those provisions.



I would like to strongly object to the application for an extended licence to sell alcohol 24 hours a day, 7 days a week and late night refreshment licence on the following grounds.

### Increased volume of vehicular and pedestrian traffic throughout the night.

Although the garage is already open 24 hours, the granting of a 24 drinks licence would increase the volume of undesirable traffic in a residential area. Residents are regularly disturbed by the constant noise generated by the garage customers, apart from vehicles using the garage there is a constant stream of shouling and foul language especially at weekends. This will only be enhanced by the granting of this licence by encouraging even more people into the area to purchase alcohol on the way home from pubs and clubs.

### Increase in volume of litter

The discarding of unwanted food packaging, drinks containers etc is a constant source of frustration to local residents. The serving of late night refreshments without the facilities to consume them on the premises will only encourage more litter as people discard packaging in gardens and driveways.

### Increase in volume of violence, unsociable behaviour and property damage.

In the 10 years that I have lived in this property I have had damage caused to three of my vehicles, seen many other vehicles with broken mirrors, windscreen wipers, damaged gardens and signs. I have also witnessed many drunken arguments and a total disregard for local residents who are trying to sleep, there has also been a murder just a few yards from the garage. Although I cannot attribute all of these problems to the garage, I do feel that the 24 hour opening of this garage encourages many drunken individuals and groups into the area to purchase cigarettes and food throughout the night, the sale of alcohol with only escalate these problems.

### Increase in driving offences

The selling of alcohol 24 hours will possibly increase the volume of irresponsible people who drive under the influence of drink or drugs, with people who have been drinking at home or partying at friends, driving to the garage from other areas of the town to purchase more alcohol.

### Increase in general noise and discomfort to local residents

Although Avenue Road is a main route into the central seafront, it is a predominantly residential area occupied mainly by people who have to work and require a reasonable nights sleep, there are also a number of small guest houses who are struggling to survive during these difficult financial times. The additional problems caused by the granting of this licence will not help the future of these local businesses or holiday guests views on their holiday in Torquay.



We are writing to raise our concerns and to request that Torbay Council refuse the application by Rontec Watford Limited to extend the hours for the sale of alcohol to 24 hours / 7 days a week, at the Abbey Service Station, Torquay, TQ2 5LG (formerly Esso). Given the article in this week's Herald Express on a new crackdown by the Police and Council to prevent drunken and unacceptable behaviour in Torquay, selling any alcohol from this Service Station seems foolhardy in the extreme, and a total contradiction to the image Torbay Council appear to be wanting to give.

Currently alcohol sold until 2300hrs is already creating a severe anti-social climate on our lives and that of our guests and business. I wish to make representation against the application to vary the above licence for the following reasons.

We have lived and traded as a guest house at the address above directly across the road from the Abby Service Station for nearly 11 years and in that time we have had constant problems with the petrol station mainly loud noise shouting and foul language and loud revving of engines from youths on the fore court

When we first moved here in 2004 the service station was open all night and the noise and rowdy behaviour went on sometimes till 2.00 am and 3.00 am in the morning to such an extent that several of our guests said that although they loved staying with us they would not return because of the noise we lost quite a significant amount of trade for this reason.

Any complaints to the service station were met with the attitude that they did not see that there was a problem and anyway they were making money...

We called the police on numerous occasions but nothing seemed to get done, I eventually wrote to the chief constable and he passed the problem to an inspector in Paignton who passed it down to the local PCSOs they started to take action and the problem seemed to subside for a while.

When the service station closed at night because of problems with the safety of their staff and thefts and intimidation we thought that that would be the end of the problem and so it seemed apart from the odd occasion when noisy youths in their cars, congregated revving their engines and turning their radios up high again, again with no response from the service station staff or the police.

If this application is allowed I fear the same old problems will start again and if they sell alcohol

Through the night we will have the added problem of the drunken stag parties returning to their hotels stopping at the service station for more drinks. At the moment they just pass down Avenue Road and back to their hotel albeit rather noisily but the noise does not last that long at present.

We have had a spate of cars parked on Avenue Road being vandalised by having the wing mirrors ripped off and some cars being keyed down the side probably by drunks I worry that we may see an increase in this sort of behaviour with 24 hour drinking at the service station.

If they are going to sell late night refreshments between 2300 and 0500 does that mean the shop area will be open through the night sgain? If so I fear for the safety of the night staff again.

I know for a fact the some of the staff do not want this application to go ahead as I have spoken to some of them but of course they will not say anything against it as they fear for their jobs.

I don't believe we will be able to count on the police for support because of the drastic manpower cuts they are facing

In finishing I would add I can see no advantage to this application but can foresee all sorts of problems again.

For all the above reasons I object in the strongest terms to the application being granted.



#### 1. What we are trying to achieve

1.1 This report concerns a Torbay Council Licensed Driver who has pleaded guilty and been convicted of claiming £9,768.76 of benefits whilst working as a part time taxi driver, contrary to Sections one and two Fraud Act 2006. This report is addressing whether the licensed driver remains a 'fit and proper person' to hold a Torbay Council Driver's Licence.

#### 2. Recommendation(s) for decision

2.1 There is no recommendation.

#### 3. Key points and reasons for recommendations

- 3.1 By the provisions of the Local Government (Miscellaneous Provisions) Act 1976, Torbay Council is the Licensing Authority in respect of Hackney Carriages, Private Hire Vehicles and their drivers within Torbay.
- 3.2 Sections 51 and 59 Local Government (Miscellaneous Provisions) Act 1976 respectively state that a district council shall not grant a licence to drive a private hire vehicle or hackney carriage unless they are satisfied that the driver is a 'fit and proper person to hold a driver's licence'.
- 3.3 Torbay Council is in receipt of information in the form of an article from the Herald Express that on or around the 17<sup>th</sup> July 2014, Mrs Joyce Daulby had "pleaded guilty to five counts of fraud by false representation after claiming nearly £10,000 in benefits she was not entitled to. Torquay Magistrates Court heard that Joyce Daulby, fraudulently claimed £9,768.76 in benefits after failing to disclose that she was working part-time as a taxi driver." This is contrary to Sections 1 and 2 Fraud Act 2006. See Appendix one and three.

- 3.4 On the 24<sup>th</sup> July 2014 Mrs Joyce Daulby was informed by letter which stated that matter was likely to be heard at a Licensing Sub-Committee hearing and whether she wished to submit anything to be included within the committee report, both in relation to the offence and in relation to not advising Torbay Council of that conviction within 7 days, contrary to Torbay Council's Hackney Carriage and Private Hire Policy. The letter was hand delivered to her address, which is different to that included within the Herald Express article. See Appendix Two.
- 3.5 No correspondence or contact has since been received from Mrs Joyce Daulby after that letter was hand delivered.
- 3.6 Fraud including benefit fraud is defined as dishonesty within Torbay Council's Hackney Carriage and Private Hire Policy, and the 'Licensing Authority may refuse to renew, suspend or revoke the licence' upon conviction.

#### Supporting information to Report

#### A1. Introduction and history

- A1.1 By the provisions of the Local Government (Miscellaneous Provisions) Act 1976, Torbay Council is the Licensing Authority in respect of Hackney Carriages, Private Hire Vehicles and their drivers within Torbay.
- A1.2 Sections 51 and 59 Local Government (Miscellaneous Provisions) Act 1976 respectively state that a district council shall not grant a licence to drive a private hire vehicle or hackney carriage unless they are satisfied that the driver is a 'fit and proper person to hold a driver's licence'.
- A1.3 Section 61 Local Government (Miscellaneous Provisions) Act 1976 states that a district council may suspend or revoke or refuse to renew the licence of a driver of a hackney carriage or a private hire vehicle on any of the following grounds:—
  - (a) that he has since the grant of the licence—
    - (i) been convicted of an offence involving dishonesty, indecency or violence; or
    - (ii) been convicted of an offence under or has failed to comply with the provisions of the Act of 1847 or of this Part of this Act; or
  - (b) any other reasonable cause.
- A1.4 Torbay Council is in receipt of information in the form of an article from the Herald Express that on or around the 17<sup>th</sup> July 2014, Mrs Joyce Daulby had "pleaded guilty to five counts of fraud by false representation after claiming nearly £10,000 in benefits she was not entitled to. Torquay Magistrates Court heard that Joyce Daulby, fraudulently claimed £9,768.76 in benefits after failing to disclose that she was working part-time as a taxi driver." This is contrary to Sections 1 and 2 Fraud Act 2006. See Appendix one.
- A1.5 On the 24<sup>th</sup> July 2014 Mrs Joyce Daulby was informed by letter which stated that matter was likely to be heard at a Licensing Sub-Committee hearing and whether she wished to submit anything to be included within the committee report, both in relation to the offence and in relation to not advising Torbay Council of that conviction within 7 days, contrary to Torbay Council's Hackney Carriage and Private Hire Policy. The letter was hand delivered to her address, which is different to that included within the Herald Express article. See Appendix Two.
- A1.6 No correspondence or contact has since been received from Mrs Joyce Daulby after that letter was hand delivered.
- A1.7 The details of the Magistrates Court hearing are confirmed in the Memorandum of an Entry dated 17<sup>th</sup> July 2014. See Appendix three.
- A1.8 Section 2.2 of Appendix One of Torbay Council's Hackney Carriage and Private Hire Policy says

In the case of a licensed driver being convicted of an offence involving dishonesty the Licensing Authority may refuse to renew, suspend or revoke the licence. If a licence is revoked, no further application will be considered until a period of at least three years free from the date of conviction of this type has Page 46

elapsed.

Dishonesty is defined in Section 2.3 as

Offences of Dishonesty include:

- Theft
- Burglary
- Fraud including benefit fraud
- Handling or receiving stolen goods
- Forgery
- Conspiracy to defraud
- Obtaining money or property by deception
- Other deception
- Any similar offences of dishonesty where the conviction is less than three years prior to the date of application
- A1.9 Section 9.3 of Appendix One of Torbay Council's Hackney Carriage and Private Hire Policy says

Convictions of any description committed by bot hackney carriage proprietors, private hire drivers and operators during the duration of their licence must be declared to the Licensing Authority in writing immediately and in any case no later than 7 days.

A1.10 Torbay Council's Hackney Carriage & Private Hire Licensing Policy says

#### 1 General Policy

- 1.1 Each case will be decided on its own merits.
- 1.2 The Licensing Authority has a duty to ensure, so far as possible, that applicants are 'fit and proper' persons to hold licenses and in the absence of a judicially approved definition of "fit and proper", the Licensing Authority use the test of:

"Would the Officer charged with the ability to grant a licence allow their son or daughter, spouse or partner, mother or father, grandson or granddaughter, or any other person for whom they care, to get into a licensed vehicle with the applicant alone"

The wording of this test originates from Button, J. T. H. (1999), Taxis –

Licensing Law and Practice, Butterworths, London.

1.3 The overriding consideration is the safety of the public. The Licensing Authority has a duty to ensure so far as possible that those licensed to drive hackney carriage and private hire vehicles are suitable persons to do so, that they are safe drivers with good driving records and adequate experience, sober, courteous, mentally and physically fit. An aspect of this is the extent to which previous convictions, including but not limited to convictions of dishonesty, sexual offences, traffic offences, violence and drugs, indicate that a person is not a 'fit and proper' person and would not take advantage of passengers or abuse or assault them.

- 1.4 Simply remaining free from convictions will not generally be regarded as sufficient evidence that a person is a 'fit and proper' person to hold a licence. Some discretion may be appropriate if the offence is isolated and there are mitigating circumstances. However, the overriding consideration should be the protection of the public. The following examples afford a general guide on the actions to be taken where convictions are admitted or discovered.
- A1.11 There is no recommendation.
- A1.12 There is a right of Appeal against the Licensing Sub-Committees decision to the Magistrates' Court within 21 days from the date of a Notice following the decision

#### A2. Risk assessment of preferred option

#### A2.1 Outline of significant key risks

- A2.1.1 Having pleaded guilty, Mrs Joyce Daulby has been convicted of an offence of fraud on the public purse. If Mrs Daulby retains her Torbay Council issued Drivers Licence, there may be as a result of this conviction, a risk in undermining public confidence in Torbay Council as a taxi licensing authority and in its Policy.
- A2.1.2 If Mrs Joyce Daulby's Torbay Council issued Drivers Licence is suspended or revoked then there is a risk of this decision being appealed.

#### A3. Options

- A3.1 The options are:
  - (i) to suspend Mrs Joyce Daulby's Torbay Council Driver's Licence, without immediate effect;
  - (ii) to suspend Mrs Joyce Daulby's Torbay Council Driver's Licence, with immediate effect;
  - (iii) to revoke Mrs Joyce Daulby's Torbay Council Driver's Licence.
  - (iv) to issue Mrs Daulby with a warning
  - (v) to do nothing.

#### A4. Summary of resource implications

- A4.1 There are some resource implications if there is an Appeal to the Magistrates' Court.
- A5. What impact will there be on equalities, environmental sustainability and crime and disorder?
- A5.1 There are no equalities or environmental sustainability issues. However, should

Mrs Joyce Daulby's continue to work as a Torbay Council Licensed Driver, there is a potential crime and disorder risk, due to her current and recent conviction.

#### A6. Consultation and Customer Focus

A6.1 There has been no public consultation on this matter and there is no requirement for the Committee to consult the public in this matter.

#### A7. Are there any implications for other Business Units?

A7.1 There are no implications for other business units.

# Taxi driver admits nearly £10,000 benefit fraud

A TORQUAY woman taxi driver has pleaded guilty to five counts of fraud by false representation after claiming nearly £10,000 in benefits she was not entitled to.

Torquay Magistrates Court heard that Joyce Daulby, fraudulently claimed £9,768.76 in benefits after failing to disclose that she was working part-time as a taxi driver.

The court heard from Chris Bittlestone, prosecuting, that Daulby's claim was fraudulent from the outset, with her claim beginning on May 1 and her beginning work on May 2.

He added that it appeared that this initially began out of financial concerns, but it carried on as 'she could not see the wood for the trees'.

Mr Philip Myles, mitigating, said that there was a complicated set of circumstances that had initially led to a change in benefits that she was entitled to.

The case was adjourned until Monday, August 11, for a pre-sentence report to be carried out.

Daulby was granted unconditional bail.
