Decision:

That the application for a Variation to a Premises Licence in respect of Tiger Lills, 3 Victoria Parade, Torquay be granted as applied for, subject to the following conditions:

- i) Where the premises sells alcohol after midnight, there shall be two SIA Registered Door Stewards located at the entrance to the premises (reducing to one for the proximity of time needed to respond to any incident arising inside the premises) and one floating SIA Registered Door Steward within the premises from midnight until closing;

To replace condition 3 under the Heading 'Crime and disorder' on page 14 of the submitted Report:

- ii) The level of amplified music shall be reduced by 50% of the agreed level set by the noise limiter at 1.30 am until closing, seven days a week.
- iii) That the Premises License Holder shall in consultation with the Police have in place a written drugs Policy;
- iv) All staff in the premises selling alcohol after midnight shall be trained and hold, within 3 months of the commencement of their employment, a BIIAB Level 1 Award in Responsible Alcohol Retailing.
- v) No under 18s shall be permitted on the premises after 2100hrs, unless they are consuming a table meal in the company of a responsible adult in which case they can remain until 22.00hrs.

Having considered the new premises licence plan, Members resolved to remove the ladies and gents toilets on the lower ground floor from being a licenced area following the submission of the Premises Licence Holder that this had been applied for in error.

Reason for Decision:

Having carefully considered all the oral and written representations, Members resolved to grant this application having recognised the Applicants willingness at the hearing to adopt further conditions to ensure that the Licensing Objectives would be promoted.

Members were also satisfied that the additional conditions would strengthen the application to ensure that the premises would not add to Public Nuisance or Crime and Disorder in the area and that in doing so, should alleviate the concerns raised by the Police.

Members were further reassured that the additional condition regarding the ratio of SIA Registered Door Stewards would enable any incidents arising inside the premises to be responded to without compromising the condition relating to underage access.

In concluding, Members noted that there were no objections in respect of this application from any Interested Party, in particular nearby residents and the Licensing Authority's Public Protection Department.

Should issues arise as a result of this grant, then a Review of the premises licence can be sought by any Responsible Authority or any Interested Party.

1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a Variation to a Premises Licence. The Premise is located within the Cumulative Impact Area.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 The matters raised relate to the Licensing Objectives “The Prevention of Crime and Disorder”, “The Prevention of Public Nuisance” and “Public Safety”.
- 1.4 The matter must be considered on its own merits having received details of the issues arising either at a hearing or by written Representations if all parties have agreed that a hearing is not necessary. Having regard to the Representations and issues arising, a decision must be made to take such steps as are necessary for the promotion of the licensing objectives. These are either:-
 - (a) to modify the conditions of the licence, or
 - (b) reject the application in whole or in part.

For this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

- 1.5 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Interested Parties and Responsible Authorities at the determination of the matter.

2. Introduction

- 2.1 An application has been made under Section 34 of the Act for a Variation to a Premises Licence. Details of the application are shown in Appendix 1. Only the relevant pages of the application are shown.

A brief description of the proposed Variation is as follows:-

To remove 16 conditions from the licence. These are listed on pages 14 and 15 of the application form.

To add an additional 3 conditions to the licence which are listed on page 17 of the application form.

To extend the timings by one hour on Public Holidays for the following licensable activities: Supply of Alcohol; Recorded Music; Performance of Dance; Anything similar to Recorded Music, Live Music and the Performance of Dance.

A change to the layout of the premises as shown on the plan attached with the application. This is just for the first floor and include to provision of doors through to the venue.

- 2.2 A copy of the current premises licence showing the licensable activities, timings, conditions and the plan of the premise is shown at Appendix 2 of this report.

- 2.3 Torbay Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 35(1) but is unable to issue the variation to the Premises Licence, as relevant Representations have been received from Responsible Authorities and Interested Parties. The Licensing Authority is also satisfied that the Representations were received within the appropriate time-scale, have not been subsequently withdrawn and are not vexatious or frivolous.

We have received a Representation from the Police in relation to the Licensing Objectives “The Prevention of Crime and Disorder” and “The Prevention of Public Nuisance”. The Representation states that it is not an objection to the application but a means to provide information to assist in the decision of the application. This is shown as Appendix 3 of this report.

We have received a Representation from Public Protection in relation to the Licensing Objective “The Prevention of Public Nuisance”. The Representation states it is not an objection to the application but a means to assist in the decision of the application by providing relevant technical information where necessary. This is shown as Appendix 4 of this report.

We have received Representations from 2 Members of the Public in relation to the Licensing Objectives “The Prevention of Crime and Disorder”, “The Prevention of Public Nuisance” and “Public Safety”. These are shown as Appendix 5.

There have been no Representations received from any other Responsible Authority or any other Interested Party.

- 2.4 The Authority is required to conduct a hearing by the provisions of Section 35(3) unless all parties agree that this is not necessary.
- 2.5 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.6 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.
- 2.7 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 4(2) of Schedule 5 to :-
- (a) The applicant for the variation of the licence against any decision to modify the conditions
 - (b) Any person who made a relevant representation in relation to the application who desires to contend
 - (i) that any variation made ought not to have been made, or
 - (ii) that, when varying the licence, the Licensing Authority ought to have modified the conditions of the licence or ought to have modified them in a different way.
- 2.8 Following such Appeal, the Magistrates' Court may:-
- (a) dismiss the appeal,
 - (b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or
 - (c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court, and may make such order as to costs as it thinks fit.

PREVENTION OF CRIME AND DISORDER

7. There must be no entry/re-entry after 0200 hours.

PREVENTION OF PUBLIC NUISANCE

4. Cooking, noxious or persistent smells from the premises will not cause a nuisance to nearby properties.

5. Provision of mechanical ventilation and air conditioning system shall not allow noise breakout from the premises or cause a nuisance by its operation.

6. Regular maintenance shall be carried out on all plant and machinery to ensure that noise disturbance from such sources is kept to a minimum.

8. There shall be no use of explosives, pyrotechnics and fireworks of a similar nature which could cause disturbance in surrounding areas.

5. Suitable and clearly identifiable areas for dancing must be set aside, and separate from the dance area suitable means of providing cool air/ventilation and adequate seating

must be provided.

6. ✓ Suitable and sufficient sanitary accommodation must be provided, clearly marked and in good order at all times.
7. ✓ No explosive or highly inflammable material shall be brought into the premises.
8. ✓ No pyrotechnics shall be used on the premises.
9. ✓ Lasers must not be used on the premises without consultation with the Licensing Authority and compliance with HS(G) 95.

PUBLIC SAFETY

1. ✓ The fire safety measures with which the premises are provided shall be maintained in good working order, and their adequacy shall be determined on a regular basis by the carrying out of a fire risk assessment as required by and in accordance with the Fire Precautions Regulations.
2. ✓ In the event of evacuation caused by failure of general lighting, the public shall not be readmitted until the general lighting is fully restored.
3. ✓ The premises shall undertake to maintain a safe occupancy level.

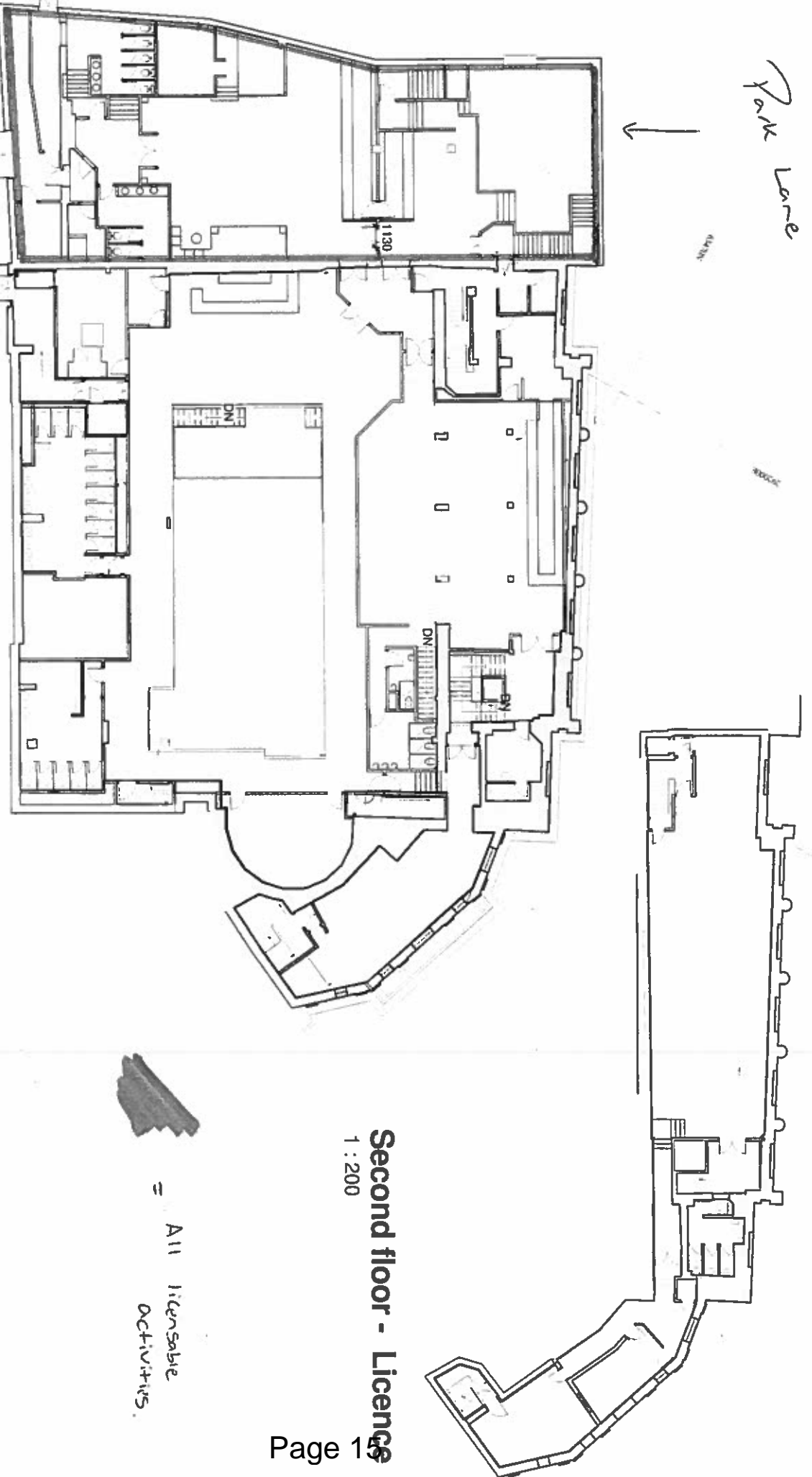

ANNEXE 1

MANDATORY CONDITION: WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

- 1) No supply of alcohol may be made under the premises licence:-
 - (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3) (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4) The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5) (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 6) The responsible person must ensure that:-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is

available to customers in the following measures:-

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2) For the purposes of the condition set out in paragraph 1

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

(b) "permitted price" is the price found by applying the formula $P = D + (D \times V)$

Where:-

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence:-

- (i) The holder of the premises licence
- (ii) The designated premises supervisor (if any) in respect of such a licence, or
- (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3) Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

MANDATORY CONDITION: DOOR SUPERVISION

1) Where one or more individuals are carrying out security activities, each individual must be licensed by the Security Industry Authority.

2) But nothing in the aforementioned conditions requires such a condition to be imposed in respect of a) and b) and (b)(i) and (b)(ii)

(a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), are exempt.

(b) In respect of premises in relation to-

ANNEXES continued ...

- (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
- (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).

3) For the purposes of the aforementioned conditions:-

- (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
- (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

ANNEXE 2

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Prevention of Crime and Disorder

1. A CCTV system of an evidential standard must be installed to the satisfaction of the police, and the system to be in operation at all times the premises are open to the public. All recordings from that system must be kept for a period of 14 days and the police to have access to recordings at any reasonable time.
2. In respect of the roof terrace area, CCTV cameras shall be installed in this area to the satisfaction of the police and there shall be a monitor situated behind the ground floor bar for viewing by staff.
3. On every operational day when SIA door stewards are required, then those stewards who are employed for front of house duties must wear yellow high visibility jackets for the entirety of their duty.
4. From 2300 hours until the premises close, members of staff and SIA door stewards shall direct patrons to the roof terrace area if they suspect that the patron(s) is leaving by the main entrance to smoke outside the premises.
5. Notices shall be prominently displayed within all bars of the Premises informing patrons who wish to smoke to use the roof terrace area.
6. Patrons leaving the premises for all purposes between 0000 hours on Saturday nights until 0200 hours on Sunday mornings will not be permitted back into the premises without paying an entrance fee.
7. There must be no entry/re-entry after 0200 hours.
8. The number of persons admitted to the premises on any one occasion shall not exceed a safe occupancy. This is in agreement with the responsible authorities notably Devon Fire and Rescue and the Health and Safety Team.
9. From 2300 hours all drinks must be served in toughened/strengthened glasses or polycarbonate/plastic vessels and no drinks will be served in glass bottles from which it is intended or likely that a person shall drink. All glasses are stamped in accordance with Weights and Measures Legislation.
10. Adequate glass and bottle collection shall be undertaken throughout the premises.
11. There must be a zero tolerance with drugs and have a drugs policy in force on the premises, with the objective of securing, as far as reasonably practical, the safety of others attending the premises.
12. A secure drug deposit box approved by Devon & Cornwall Constabulary shall be located on the premises for the safe storage of any drugs found or seized.
13. The DPS or member of the management team shall attend at least two Torquay Forum Meetings per calendar year, and any other meetings organised by the Police in relation to high risk events.
14. The Licensees shall work with the Local Authority and support any seasonal and other advertising campaigns.

The Prevention of Public Nuisance

1. Noise from the premises shall not be audible within any dwelling with windows open for normal ventilation especially

after 2300 hours. This shall be assessed from the boundary to the nearest residential properties, on all sides of the licensed premises. The criteria that shall be applied are:-

i) Before 2300 hours - Noise emanating from the premises shall not be clearly distinguishable above other noise.

ii) After 2300 hours - Noise emanating from the premises shall not be distinguishable above background levels of noise.

iii) The local authority shall reserve the right in cases of tonal noise and where premises are attached to others, to make further assessments from within the residential property.

2. Doors and windows must be kept shut during entertainment to reduce noise breakout. A management scheme will be in place to ensure this situation remains.
3. A management scheme shall be put in place to prevent excessive queuing into the street and particularly into Park Lane.
4. Cooking, noxious or persistent smells from the premises will not cause a nuisance to nearby properties.
5. Provision of mechanical ventilation and air conditioning system shall not allow noise breakout from the premises or cause a nuisance by its operation.
6. Regular maintenance shall be carried out on all plant and machinery to ensure that noise disturbance from such sources is kept to a minimum.
7. Delivery of kegs, bottles, food and other materials shall be carried out between the hours of 0930 hours and 1730 hours weekdays.
8. There shall be no use of explosives, pyrotechnics and fireworks of a similar nature which could cause disturbance in surrounding areas.
9. Background music on the roof terrace area must cease at 0200 hours and shall switch off automatically.
10. Patrons who behave in a noisy or disorderly manner on the roof terrace area shall be removed from that area and where appropriate asked to leave the Premises. Details of this noisy or disorderly conduct shall be recorded in a log book and where appropriate, details of the patron(s) causing the noise or disorderly conduct shall be recorded in that log book too.
11. Signage must be displayed in the roof terrace area to remind patrons to keep noise to a minimum, warning customers who are excessively noisy or disorderly that they will be removed from that area and potentially the Premises.
12. If Torbay Council receives a complaint of noise nuisance emanating from the Premises and an Environmental Health Officer of Torbay Council deems noise nuisance to exist and the upholds the complaint, the Premises Licence Holder shall on receiving written confirmation of that complaint from Torbay Council:
 - a) Co-operate with Torbay Council's Environmental Health Officers and implement remedial measures to the satisfaction of the Environmental Health Officers immediately or as reasonably practicable to do so, as determined by the Environmental Health Officer; and
 - b) Where remedial action cannot be identified and remediated to the satisfaction of the Environmental Health Officer, the roof terrace area shall be closed to all patrons at 2000 hours until such time that the noise nuisance can be identified and the necessary remedial work can be carried out.

Public Safety

1. The fire safety measures with which the premises are provided shall be maintained in good working order, and their adequacy shall be determined on a regular basis by the carrying out of a fire risk assessment as required by and in accordance with the Fire Precautions Regulations.
2. In the event of evacuation caused by failure of general lighting, the public shall not be readmitted until the general lighting is fully restored.
3. The premises shall undertake to maintain a safe occupancy level.

ANNEXES continued ...

4. Where crowd management measures are needed, all reasonable steps shall be taken to ensure that such persons do not obstruct exits, yards, passageways, stairways and ramps and that portable barriers shall be provided to prevent crushing and keep queues in an orderly fashion.
5. Suitable and clearly identifiable areas for dancing must be set aside, and separate from the dance area suitable means of providing cool air/ventilation and adequate seating must be provided.
6. Suitable and sufficient sanitary accommodation must be provided, clearly marked and in good order at all times.
7. No explosive or highly inflammable material shall be brought into the premises.
8. No pyrotechnics shall be used on the premises.
9. Lasers must not be used on the premises without consultation with the Licensing Authority and compliance with HS(G) 95.

The Protection of Children from Harm

1. No persons under the age of 18 shall be employed in connection with the sale of alcohol after 2300 hours.
2. Persons under the age of 18 shall not be allowed into the Nightclub on the first floor at anytime unless attending an under 18 event.
3. Suitable food and non-alcoholic beverages shall be available at all times that children are allowed on the premises.
4. All bar staff shall be suitably trained to prevent the sale of alcohol to under 18's.
5. The premises shall operate a Challenge 25 Policy and any individual who appears to be under the age of 25 shall be requested to provide an approved form of identification bearing a photograph.
6. **Under 18 events may take place to which the following conditions shall apply:**
 - 6.1 These events shall finish no later than 2300 hours, after which there will be a 30 minute period before re-opening to over 18's.
 - 6.2 The Police shall be notified in writing or email at least 14 days prior to the event.
 - 6.3 SIA door stewards must be employed throughout the event, which shall include at least one female steward. All stewards shall have undergone Disclosure & Barring Service check.
 - 6.4 All promotional material relating to alcohol shall be removed.
 - 6.5 All alcohol shall be locked and or obscured from view.
 - 6.6 All gaming machines with prizes shall be unplugged and locked.
 - 6.7 Any person refusing to be searched shall be refused entry.
 - 6.8 The event shall be promoted to ages 14 and above.
 - 6.9 Foreign student events shall be restricted to foreign students only.
 - 6.10 Throughout under18 events, the DPS or personal licence holder must be present.

ANNEXE 3

CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY

The Prevention of Crime and Disorder

1. On any Wednesday, Friday, Saturday and Sunday nights SIA door stewards shall be employed from 2200 hours until closing time at a ratio of 2 stewards for the first 100 patrons, and thereafter 1 additional steward for each 100 patrons. This condition shall also apply to Christmas Eve and New Years Eve when they do not fall on a Wednesday, Friday,

- Saturday or Sunday. On all other occasions the Premises Licence Holder shall risk assess the need for door stewards and employ these as such numbers and at such times determined by that risk assessment.
2. SIA door steward, when on duty, must wear distinctive dress.
 3. Nominated SIA door stewards and members of management must carry effective two way radios with earpieces and used at all times after 2200 hours. This equipment is kept in good working order.
 4. Subject to condition 1 above, on every occasion that the premises sells alcohol after midnight and then closes after 0030 hours, SIA door stewards shall be employed at the premises from 2200 hours until closing.
 5. At all times that SIA door stewards are employed at the premises after 2200 hours, an SIA door steward shall be positioned at the entrance to the premises.
 6. At all times that the roof terrace area is open, regular checks are to be made by staff and after 2200 hours, an SIA door steward shall be situated in that area. Their duties will include, ensuring that persons using the roof terrace behave in an orderly manner, and that persons shouting, singing or acting in a way that may cause a noise nuisance will be asked to leave the roof terrace area and if necessary, the premises.
 7. The premises will maintain membership and actively participate in the Nitenet Radio Scheme, with the radio being in the possession of either the Head SIA Door Steward (when SIA door stewards are employed on the premises) or the Duty Manager.
 8. Consumption of alcohol on the ground floor terrace shall be by persons seated, no alcohol shall be served in glass bottles within those areas from which it is intended or likely that a person shall drink.
 9. In relation to the consumption of food and drink (alcoholic and non-alcoholic) on the ground floor terrace, there shall be no consumption after 0200 on Friday and Saturday and after 0000 Sunday to Thursday.
 10. All bar staff will be trained in relation to their responsibilities in relation to the Licensing Act in respect of the sale/supply of alcohol. After 2200 hours at least one manager who holds a personal licence shall be on the premises whilst open to the public.

The Prevention of Public Nuisance

1. Noise or vibration shall not emanate from the premises such as to cause persons in the neighbourhood to be unreasonably disturbed.
2. The volume of amplified sound used in connection with the entertainment provided shall at all times be under the control of the licensee/management and the controlling mechanism shall be operated from a part of the premises not accessible to the public.
3. All regulated entertainment shall be played through a noise limiter which is set at a level as agreed with the local responsible authority for public nuisance. The noise limiter shall be made tamper proof and any adjustments to sound levels shall only be made in consultation with the responsible authority for public nuisance.
4. The level of amplified music shall be reduced automatically by 1/3 of the agreed level set by the noise limiter at 0300 hours until closing.
5. The volume of any regulated entertainment will be under the control of the management at all times. Should monitoring indicate that the volume should be reduced, management shall take steps to ensure levels are reduced immediately.
6. No changes that increase the level of volume to the Public Address system shall be made without prior consultation with the local Environmental Health Department; this includes moving of speakers, addition or removal of any equipment and the use of guest acts/DJ's own equipment.
7. Entrances must be provided with lobbies with automatic door-closers. The lobbies shall be in use throughout the time of entertainment.
8. Lobbies shall be constructed and operated in such a way to ensure that if regulated entertainment is being played inside the premises, only one door shall be opened at any one time to prevent noise breakout. These doors shall be fitted with automatic closers.
9. Where any proposed structural changes are made to the premises, agreement must be reached with the

Environmental Health Department that these works will not increase noise breakout before the works are commenced.

10. From 2300 hours until the premises closes, SIA door stewards shall monitor the external areas and ensure that patrons behaving in a noisy manner are either asked to leave or asked to return inside the premises.
11. SIA door stewards positioned at the exits shall take all reasonable steps to ensure that patrons leave the premises in a quiet respectful manner and do not congregate outside the premises.
12. The placing of refuse such as bottles in to skips outside the premises shall take place at times that will prevent disturbance to nearby properties and the movement of bins and rubbish outside the premises shall be kept to a minimum after 2200 hours.
13. The licensee shall ensure that staff leaving the premises after a late night shift will conduct themselves in a manner as not to disturb nearby residents.
14. The roof terrace will close at:

Sundays - midnight, except on Sundays of Bank Holiday Weekends when the terrace will close at 0300 hours on the Monday morning.

Mondays and Tuesdays - midnight.

Wednesdays - the terrace will close at 0200 hours on the following day (i.e. Thursday).

Thursdays - midnight.

Fridays and Saturdays - the terrace will close at 0300 hours on the following days (i.e. Saturday and Sunday mornings).
15. Other than recorded background music, no live or amplified music shall be permitted on the roof terrace area at any time.
16. The volume of background music played on the roof terrace area must be set and maintained at a level that is agreed by a Torbay Council Environmental Health Officer.
17. After 2300 hours, the number of patrons permitted to use the roof terrace area shall be limited to a maximum of 80 patrons at any one time.
18. Patrons shall not be permitted to take drinks onto the roof terrace area after 2300 hours.
19. All patrons consuming drinks on the roof terrace area must cease doing so at 2300 hours and arrangements must be in place by the Premises Licence Holder for all glasses to be cleared from that area at 2300 hours. Those patrons wishing to continue drinking must be advised to do so inside the Premises.
20. The roof terrace is to have a solid perimeter wall of at least eight feet, with the exception of the Torwood Street elevation where it shall be six feet. The wall is to have a density of at least 10 kilograms per square meter with no gaps.
21. Non sound reflective surfaces shall be used on the walls and floor where practically possible.

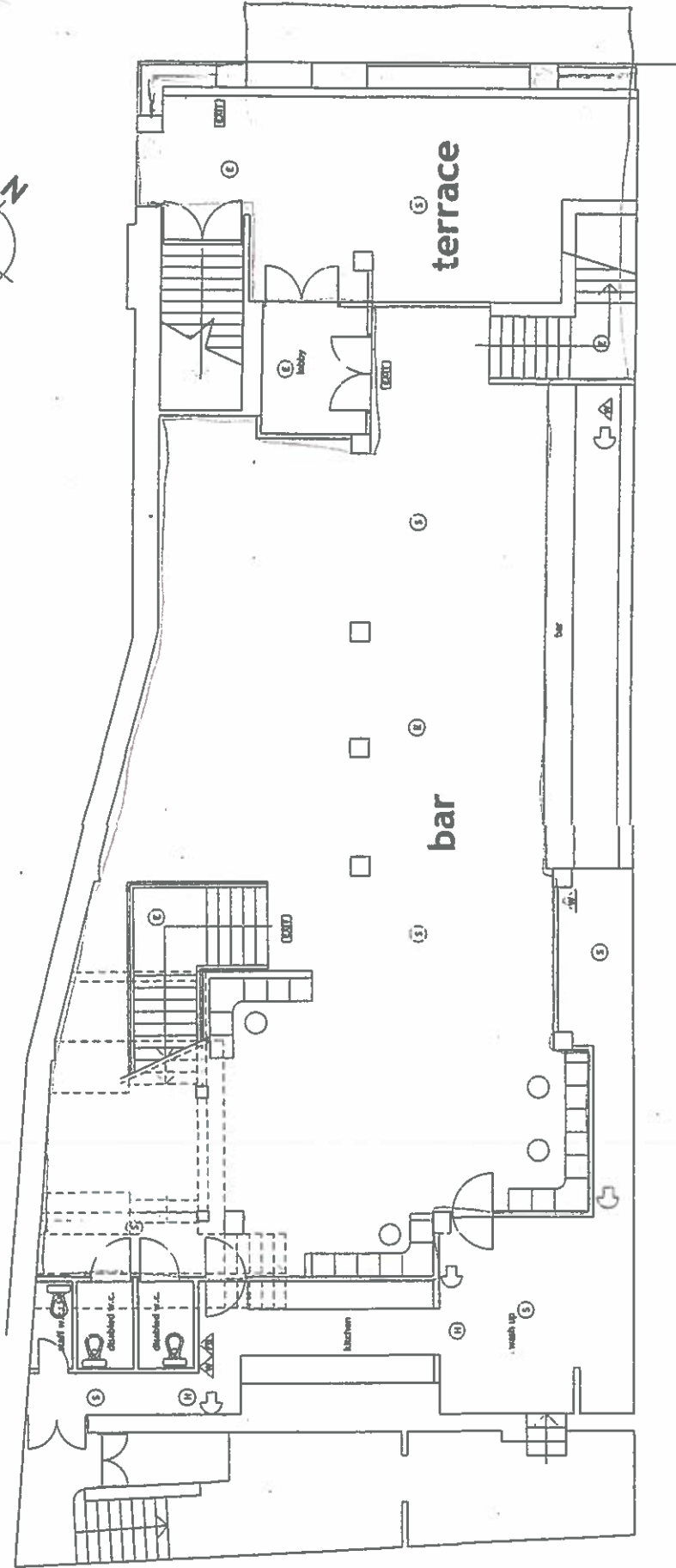

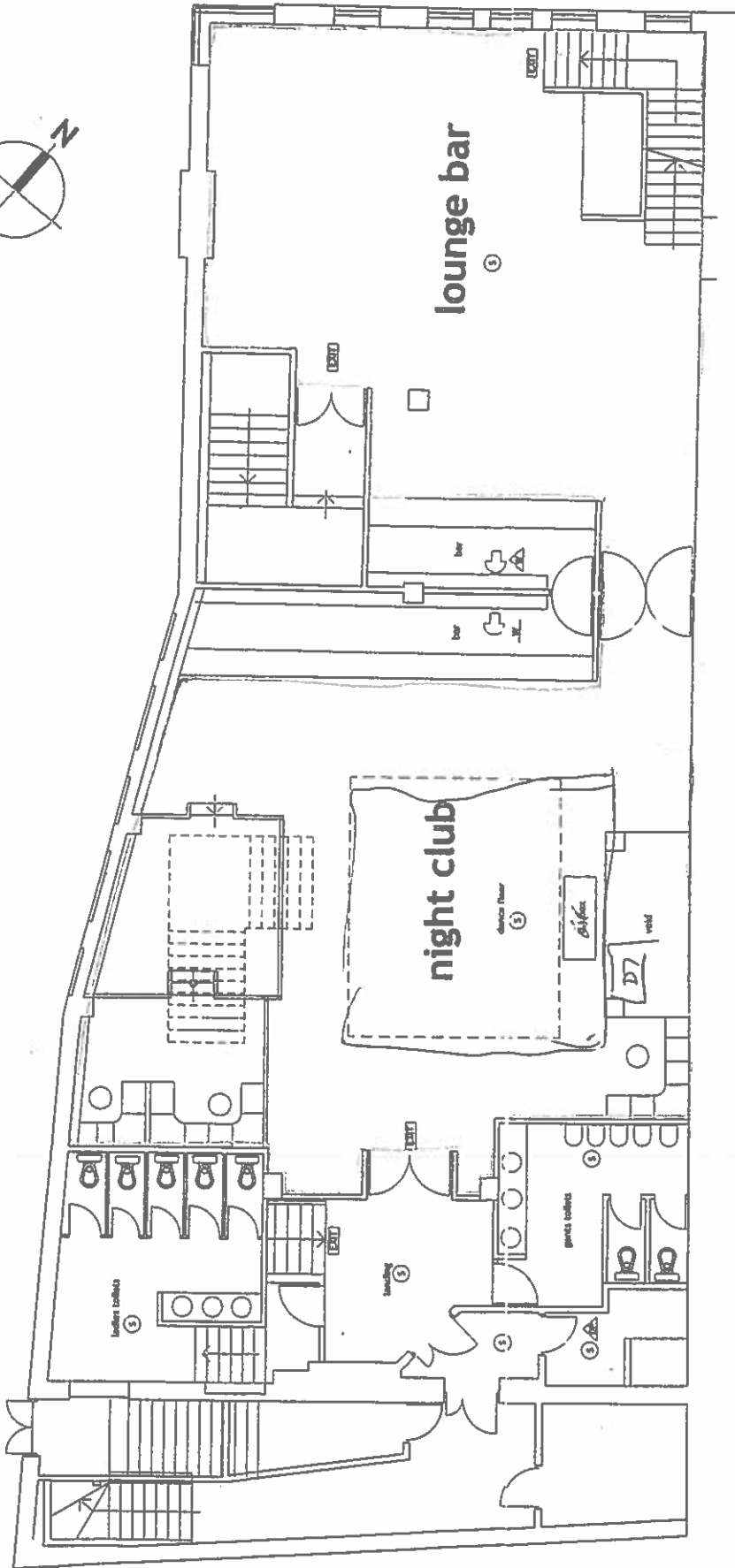

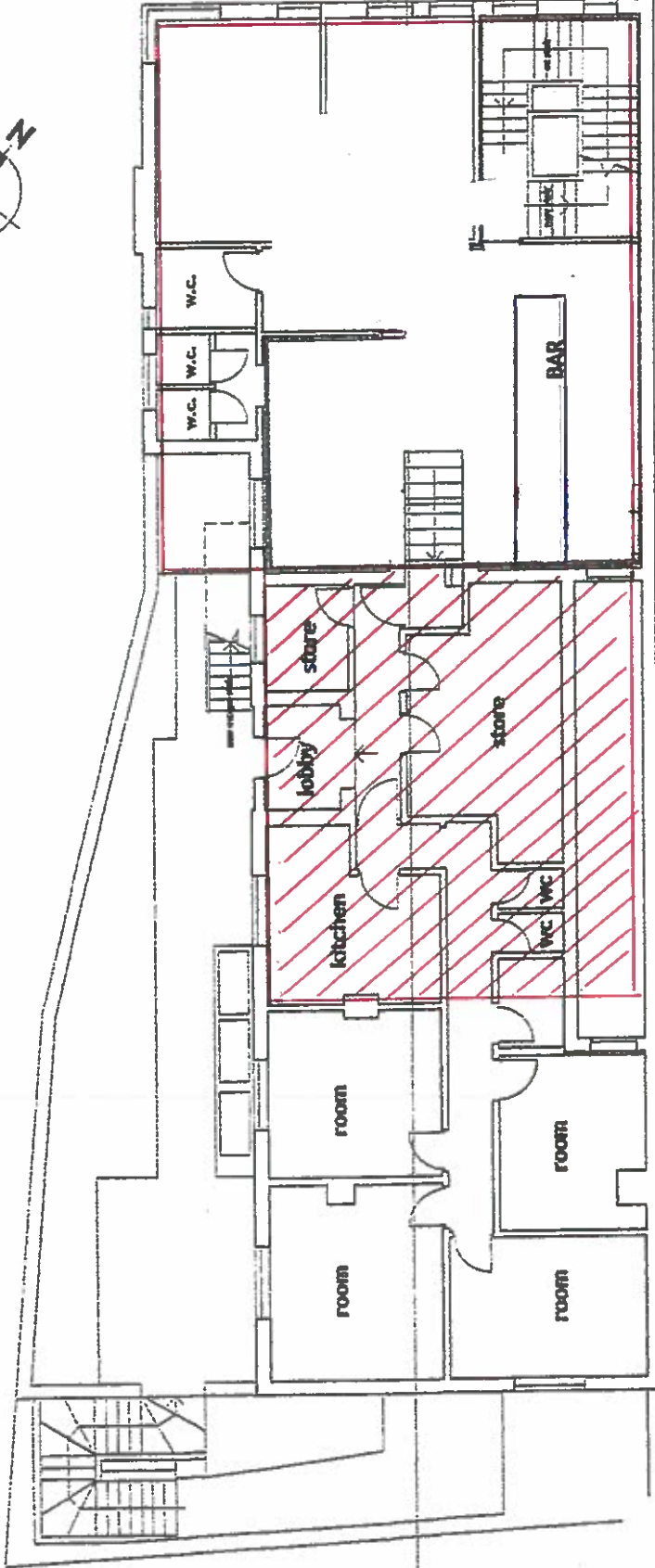

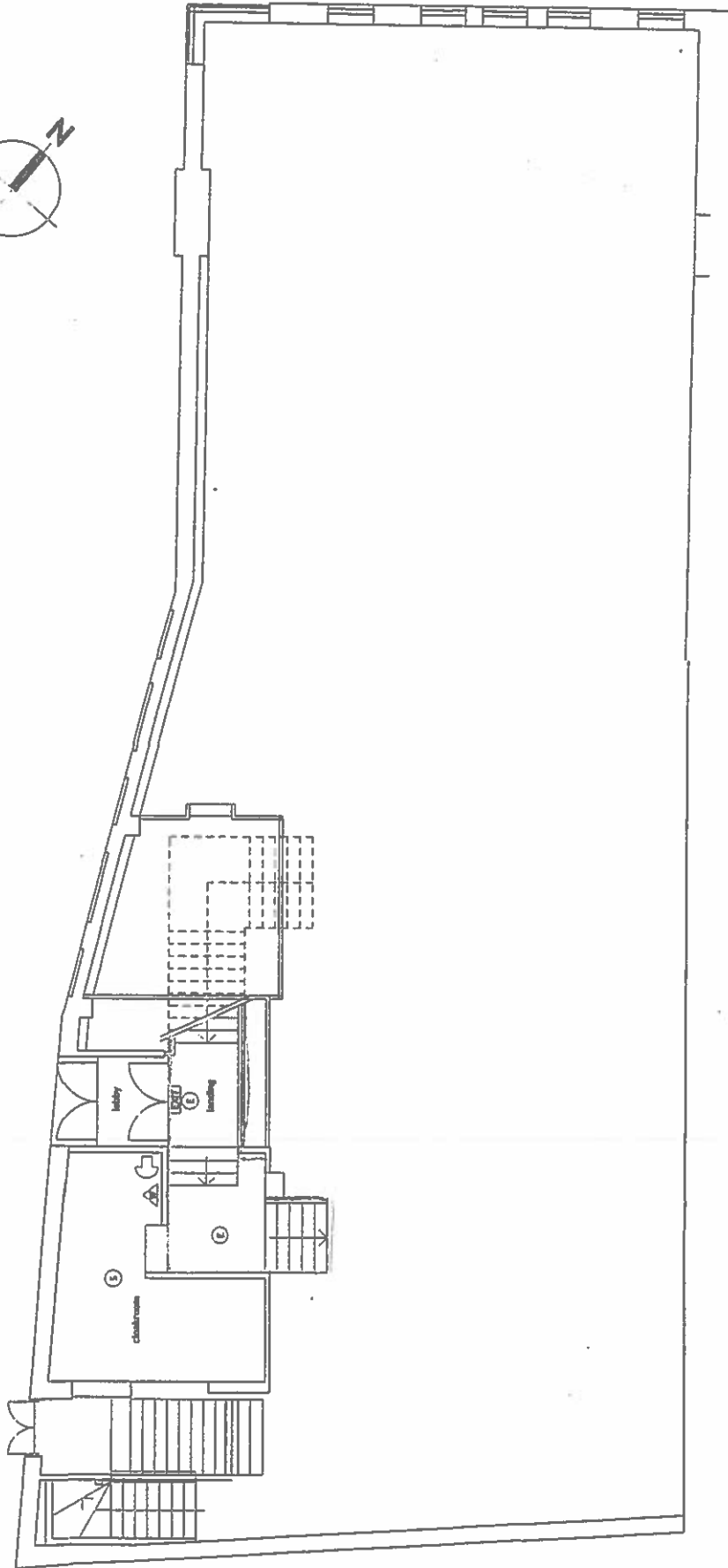


Second Floor Plan

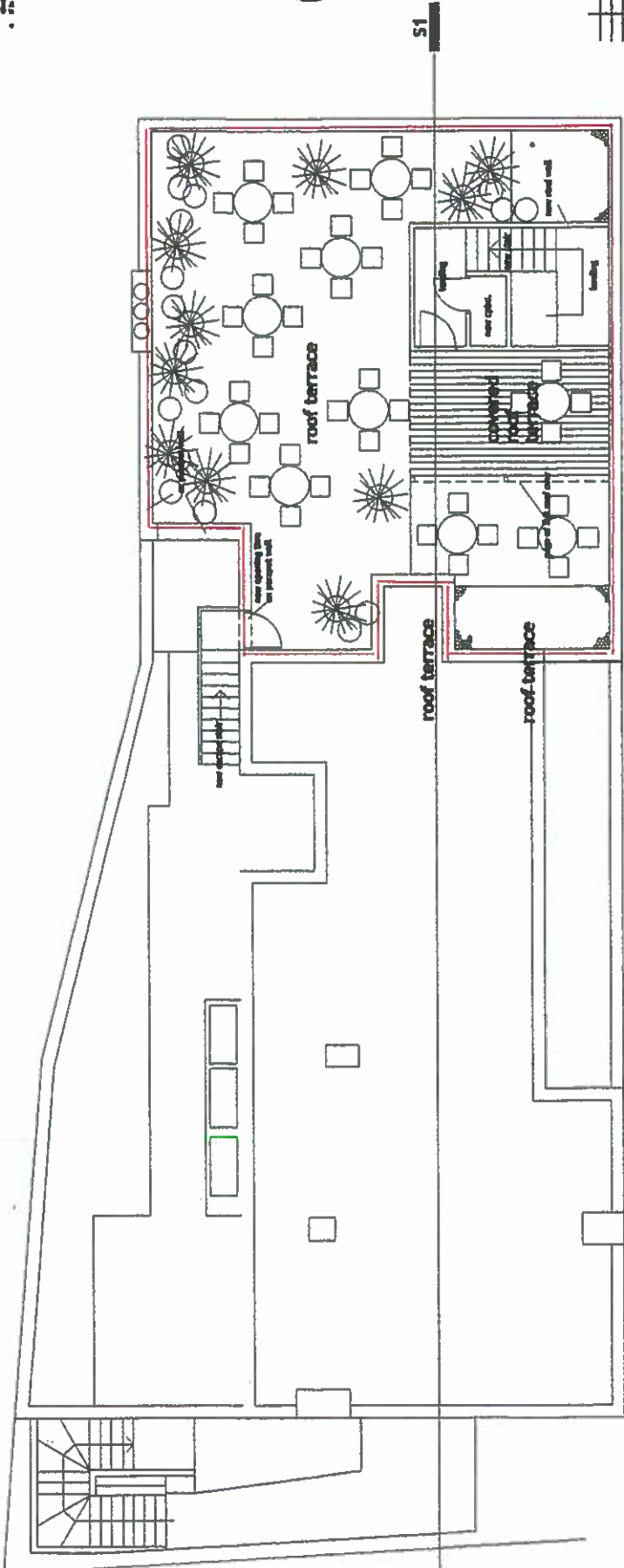

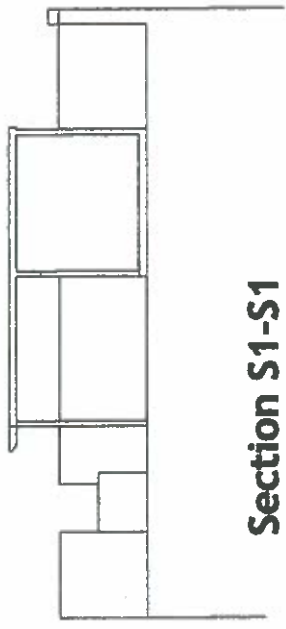

I refer to application for the Variation of the Premises Licence in respect of the above named premises, submitted by the applicants, Jam Leisure (Park Lane) Limited. The directors of this company are Mr Adrian Hobbs and Mrs Jacqueline Hobbs.

For your information Mr and Mrs Hobbs are also the directors of Jam Leisure (TQ) Ltd, who holds the Premises Licence in respect of the Venue, 13 Torwood Street, Torquay. An application for the variation of the premises licence in respect of this premises has also been submitted to Torbay Council.

My Police Licensing Officer, Mrs Julie Smart, and Sgt Mike Norsworthy (Licensing Sergeant Devon) have met with Mr Hobbs, and various members of the management teams of Park Lane and the Venue, several times over the last few months in relation to these variation applications. The police do not object to this application but would like to provide you with the following information which may assist you when considering this application.

Mrs Smart advises me that the variation applications have been made to change the layout of both premises. An interconnecting doorway is to be created on the first floor and, at times, customers will be allowed to move between the two premises. In addition, in respect of the Venue, other internal alterations will be made to provide a new smoking area and a 'retro club' within the main building. These changes of layout should help alleviate concerns regarding the crowding of customers on the first floor of

Park Lane and reduce the queue for the smoking area within Park Lane, as customers will be directed to an alternative smoking area within the Venue. It is also anticipated that fewer customers will smoke outside the Venue, thus reducing the likelihood of noise and public nuisance on the street. Mrs Smart and Sgt Norsworthy are satisfied that the changes of layout of both premises will not impact on any of the licensing objectives.

The applications also seek to remove and add additional conditions to the licences. Mrs Smart and Sgt Norsworthy have carefully considered these and do not anticipate that the proposed amendments will impact on any of the licensing objectives.

In respect of Park Lane, the applicants are reducing the opening hours on Saturdays to match the rest of the week, ie 1000 hrs until 0330 hrs. In respect of the Venue, the applicants are seeking to extend the sale of alcohol by an additional 30 minutes every day of the week, ie from 1100 to 0230 hrs to 1100 hrs to 0300 hrs, closing 30 minutes thereafter. This will mean that both Park Lane and the Venue can sell alcohol until 0300 hrs daily, and this will prevent the flow of customers from one premises to the other in the lead up to closing. At the present time customers leave The Venue at 0300 hrs however many use the services of the takeaways and do not leave the area immediately after leaving the premises. The police do not consider that this will have a detrimental effect on any of the licensing objectives.

In addition, Mrs Smart advises me that she has worked very closely with the management teams of both premises during the last couple of years. From statistics prepared by Mrs Smart, it is evident that recorded crime at both premises has reduced year on year. In respect of Park Lane in 2016 there was a 17.2% reduction of crime compared to 2015. In respect of the Venue, in 2016 there was a 26.4% reduction of crime compared to 2015.

I am writing these representations, the same for both, with regard to the Prevention of Public Nuisance Objective.

Park Lane 1 Torwood Street, Torquay TQ1 1ED and Venue 13 Torwood street, Torquay TQ1 1ED

I wish to make representation on behalf of the Responsible Authority for Environmental Health dealing with noise nuisance in respect of both variation applications for the above premises.

There have been complaints relating to noise emanating from both premises. Visits have been made to the premises from officers relating to noise issues and these matters have been discussed with both the owner and management of the premises.

Following the takeover of the Venue by the owners of Park Lane, a visit took place to discuss the noise issues both past a current and a full explanation of the proposed alterations to the premises was given at that time. All of the local authority concerns and details pertaining to complaints that had been received were discussed and assurances given by management in respect of both premises that measures would be put in place to combat further issues.

The applications have been submitted in accordance with the discussed measures and it is hoped that a premises operating under the revised (should they be granted) licences will bring about a vast improvement. It is difficult to assess the degree of any positive impact at this stage, however, the noise measures incorporated into the renovations to the building are of a standard that suggests that the outbreak of noise will be reduced in comparison to previously.

In view of this, the environmental health team are not objecting to the application as such, however, on the basis that Members are required to consider the merits of the application and that they may therefore have technical questions to ask of noise officers, this representation allows for an officer to be present at the hearing and ensures that measures discussed are incorporated on any licence that is deemed to be granted.

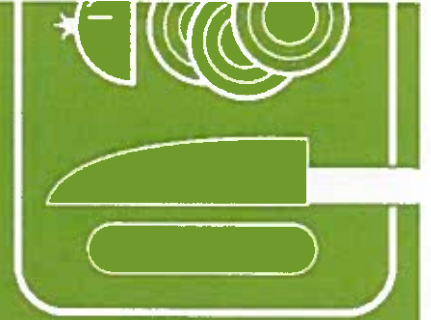

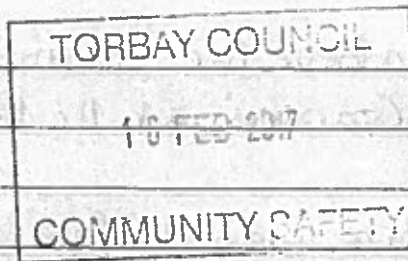

(1) Venue - we wish to protest their application on the grounds that the noise, experienced only recently will be gratefully exasibated if their re-newed application gets accepted and enter this complain with the Public Nuisance remit. The vibration from the constaur BASE is at times intolerable & could get worse if this application is granted

(2) Park Lane - Gives us great concern if their applicato is accepted as only recently we had to inform the police that a person/persons were both climbing on our roof

and then onto the roof above the 'Veuve' hoping to gain access to the 'Roof Garden' at the top of the Park Lane Veuve.

My last report to police was before Christmas 2016 as a gentleman had climbed onto the Veuve roof and unfortunately did not gain said access but was forced to fortunately SLEEP off his intake of alcohol.

However from my vantage point all I could see was a lifeless body on the roof, not knowing if he was injured or deceased I called the police who dealt with the individual.

I feel that this intrusion will happen more often and would be likely to be considered as a Public Safety problem.

We have had on two occasions some involvement with the Environmental Health dept and whilst I visit from Mr Karl Martin, who agreed with his colleagues that the noise we were experiencing was unacceptable, but did nothing to assist etc - - Or even inform us of any outcome from further conversations etc - -

We therefore wish to voice our concern as regular Community Charge payers to these two establishments making further developments that we feel will make our present situation even more intolerable.

We have had good reason to make complaints about noise emanating from these premises which contravene your Reg 1 relating to noise with regard to the prevention of public nuisance. In addition there has been significant base vibration. The side of the Park Lane club frequently has a number of used Nitrous Oxide ampules discarded on the road - the rear area and Park Lane steps are used as a rubbish, and people are frequently seen accessing the club from the rear by climbing over walls and onto nearby roofs. 1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a Variation to a Premises Licence. The Premise is located within the Cumulative Impact Area.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 The matters raised relate to the Licensing Objectives “The Prevention of Crime and Disorder”, “The Prevention of Public Nuisance” and “Public Safety”.
- 1.4 The matter must be considered on its own merits having received details of the issues arising either at a hearing or by written Representations if all parties have agreed that a hearing is not necessary. Having regard to the Representations and issues arising, a decision must be made to take such steps as are necessary for the promotion of the licensing objectives. These are either:-
 - (a) to modify the conditions of the licence, or
 - (b) reject the application in whole or in part.

For this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

- 1.5 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Interested Parties and Responsible Authorities at the determination of the matter.

2. Introduction

- 2.1 An application has been made under Section 34 of the Act for a Variation to a Premises Licence. Details of the application are shown in Appendix 1. Only the relevant pages of the application are shown.

A brief description of the proposed Variation is as follows:-

To remove 24 conditions from the licence. These are listed on pages 14 to 16 of the application form.

To add an additional 23 conditions to the licence which are listed on pages 18 to 20 of the application form.

To extend the time for the Supply of Alcohol from 11.00 until 03.00 which is an additional 30 minutes. Also to allow an additional hour on Public Holidays and when British Summertime commences.

To extend the time for Recorded Music; Performance of Dance; Anything similar to Recorded Music, Live Music and the Performance of Dance from 11.00 until 03.30 which is an additional 30 minutes. Also to allow an additional hour on Public Holidays and when British Summertime commences.

A change to the layout of the premises as shown on the plans attached with the application. This is for both floors and includes the provision of doors through to Park Lane, the addition of a roof top smoking area and other changes to the layout.

- 2.2 A copy of the current premises licence showing the licensable activities, timings, conditions and the plan of the premise is shown at Appendix 2 of this report.

- 2.3 Torbay Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 35(1) but is unable to issue the variation to the Premises Licence, as relevant Representations have been received from Responsible Authorities and Interested Parties. The Licensing Authority is also satisfied that the Representations were received within the appropriate time-scale, have not been subsequently withdrawn and are not vexatious or frivolous.

We have received a Representation from the Police in relation to the Licensing Objectives “The Prevention of Crime and Disorder” and “The Prevention of Public Nuisance”. The Representation states that it is not an objection to the application but a means to provide information to assist in the decision of the application. This is shown as Appendix 3 of this report.

We have received a Representation from Public Protection in relation to the Licensing Objective “The Prevention of Public Nuisance”. The Representation states it is not an objection to the application but a means to assist in the decision of the application by providing relevant technical information where necessary. This is shown as Appendix 4 of this report.

We have received Representations from 2 Members of the Public in relation to the Licensing Objectives “The Prevention of Crime and Disorder”, “The Prevention of Public Nuisance” and “Public Safety”. These are shown as Appendix 5.

There have been no Representations received from any other Responsible Authority or any other Interested Party.

- 2.4 The Authority is required to conduct a hearing by the provisions of Section 35(3) unless all parties agree that this is not necessary.
- 2.5 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representations and the procedure to be followed at the hearing.
- 2.6 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates’ Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.
- 2.7 If the application is granted, a Right of Appeal to the Magistrates’ Court is granted by Section 181 of the Act and, by Paragraph 4(2) of Schedule 5 to :-
 - (a) The applicant for the variation of the licence against any decision to modify the conditions
 - (b) Any person who made a relevant representation in relation to the application who desires to contend
 - (i) that any variation made ought not to have been made, or
 - (ii) that, when varying the licence, the Licensing Authority ought to have modified the conditions of the licence or ought to have modified them in a different way.
- 2.8 Following such Appeal, the Magistrates’ Court may:-
 - (a) dismiss the appeal,
 - (b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or
 - (c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,and may make such order as to costs as it thinks fit.

On any Thursday, Friday, Saturday and Sunday night that the premises remain open for the sale of alcohol after midnight and then close after 00.30hrs, SIA door stewards shall be employed on the premises from 22.00hrs until close, at a ratio of 1 steward per 100 customers. (This condition shall also apply on Christmas Eve and New Years Eve when they do not fall on a Thursday, Friday, Saturday or Sunday.) On all other occasions the Premises Licence Holder or Designated Premises Supervisor shall risk assess the requirement for door stewards and employ such door stewards, if at all, in such numbers and at such times determined by that risk assessment.

11. This premises licence applies only to the parts of the premises named below and the maximum number of persons to be permitted within those areas shall not exceed:-

Music singing and dancing - Ground Floor: 600; First Floor: 500; Second Floor: 90;

a. While live or recorded music takes place regular monitoring of noise levels at the nearest noise-sensitive locations shall take place. A record shall be kept of any monitoring.

4. The volume of any regulated entertainment will be under the control of the management at all times. Should monitoring indicate that the volume should be reduced, management shall take steps to ensure levels are reduced immediately.

5. No changes that increase the level of volume to the Public Address system shall be made without prior consultation with the local Environmental Health Department; this includes moving of speakers, addition or removal of any equipment and the use of guest acts/DJ's own equipment.

6. Entrances must be provided with lobbies with automatic door-closers. The lobbies shall be in use throughout the time of entertainment.

7. Lobbies shall be constructed and operated in such a way to ensure that if regulated entertainment is being played inside the premises, only one door shall be opened at any one time to prevent noise breakout. These doors shall be fitted with automatic closers.

8. All external emergency exit doors shall be fitted with sensor alarms and visible indicators to alert staff when doors have been opened.

9. Where any proposed structural changes are made to the premises, agreement must be reached with the Environmental Health Department that these works will not increase noise breakout before the works are commenced.

10. From 2300 hours until the premises closes, SIA door stewards shall monitor the external areas and ensure that patrons behaving in a noisy manner are either asked to leave or asked to return inside the premises.

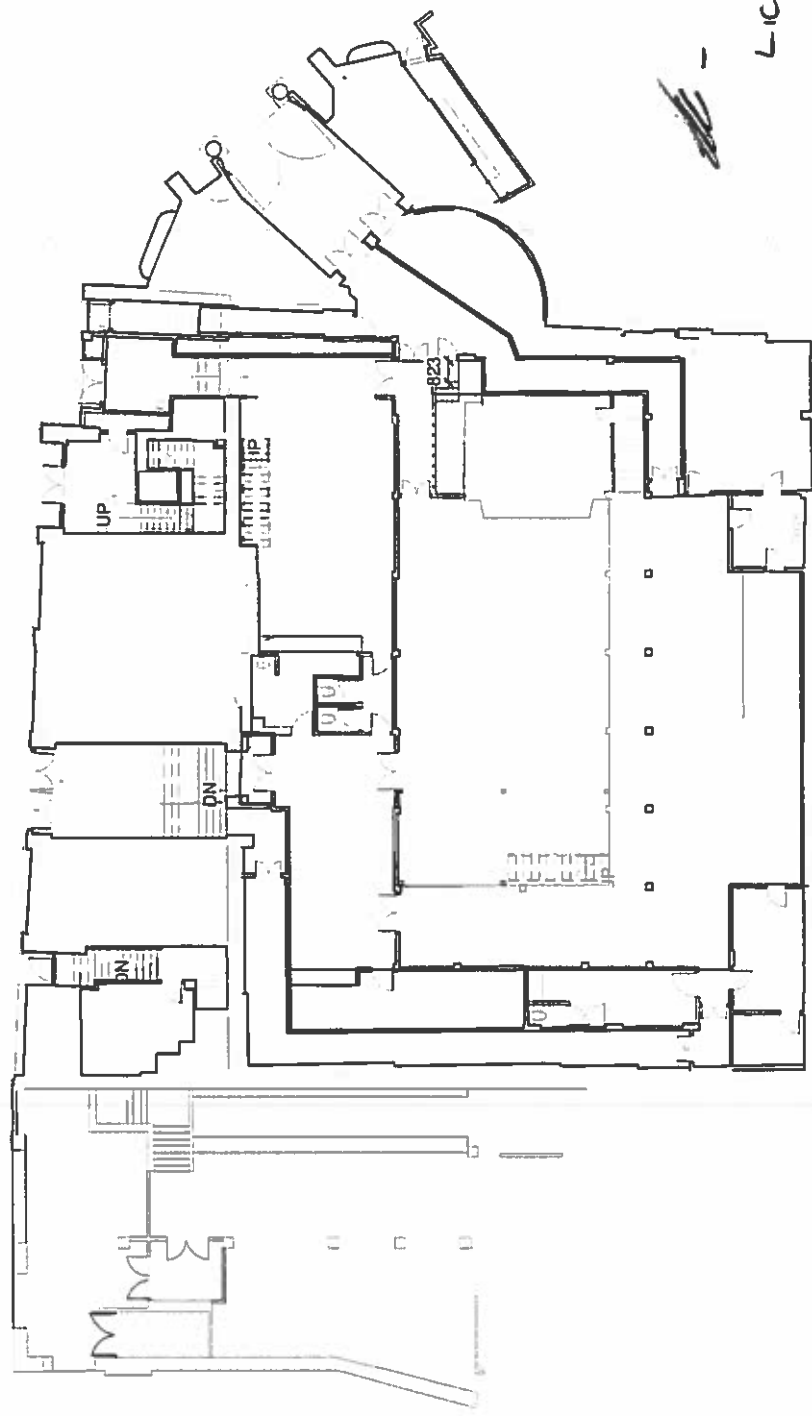
11. SIA door stewards positioned at the exits shall take all reasonable steps to ensure that patrons leave the premises in a quiet respectful manner and do not congregate outside the premises.

12. Other than recorded background music, no live or amplified music shall in the outside smoking area at any time..

13. Non sound reflective surfaces shall be used on the walls and floor where practically possible.

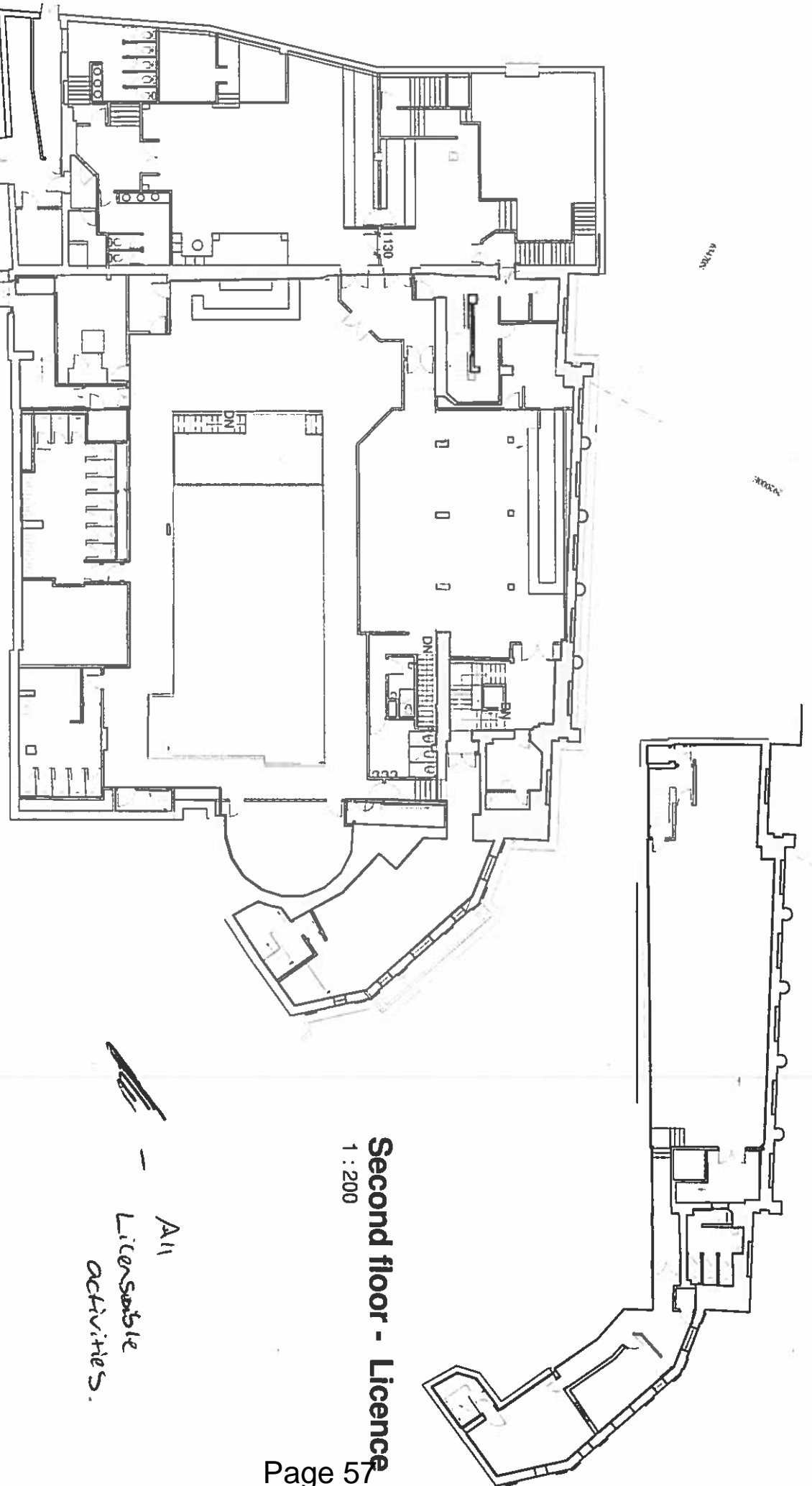

ANNEXE 1

MANDATORY CONDITION: WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

- 1) No supply of alcohol may be made under the premises licence:-
 - (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3) (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4) The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5) (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 6) The responsible person must ensure that:-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic

drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:-

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2) For the purposes of the condition set out in paragraph 1

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

(b) "permitted price" is the price found by applying the formula $P = D + (D \times V)$

Where:-

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence:-

- (i) The holder of the premises licence
- (ii) The designated premises supervisor (if any) in respect of such a licence, or
- (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3) Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

MANDATORY CONDITION: EXHIBITION OF FILMS

1) Where the film classification body is specified in the licence, admission of children must be restricted in accordance with any recommendation made by that body.

2) Where -

- (a) the film classification body is not specified in the licence, or
- (b) the relevant licensing authority has notified the holder of the licence that this condition applies to the film in

question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

In the case of the aforementioned conditions

“children” means persons aged under 18; and

“film classification body” means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (authority to determine suitability of video works for classification).

MANDATORY CONDITION: DOOR SUPERVISION

- 1) Where one or more individuals are carrying out security activities, each individual must be licensed by the Security Industry Authority.
- 2) But nothing in the aforementioned conditions requires such a condition to be imposed in respect of a) and b) and (b)(i) and (b)(ii)
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), are exempt.
 - (b) In respect of premises in relation to-
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- 3) For the purposes of the aforementioned conditions:-
 - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

ANNEXE 2

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

General

1. The Venue's current policies in place to meet all licensing objectives must be reviewed when appropriate.
2. On any Thursday, Friday, Saturday and Sunday night that the premises remain open for the sale of alcohol after midnight and then close after 00.30hrs, SIA door stewards shall be employed on the premises from 22.00hrs until close, at a ratio of 1 steward per 100 customers. (This condition shall also apply on Christmas Eve and New Years Eve when they do not fall on a Thursday, Friday, Saturday or Sunday.) On all other occasions the Premises Licence Holder or Designated Premises Supervisor shall risk assess the requirement for door stewards and employ such door stewards, if at all, in such numbers and at such times determined by that risk assessment.
3. The Premises shall join and participate in the Nitenet Radio Communications Scheme that operates in Torquay.
4. All drinks must be served in toughened, strengthened, polycarbonated or plastic glasses, and no alcohol shall be sold or supplied in glass bottles from which it is intended or likely that a person shall drink.
5. All doors and windows shall be shut during all licensable entertainment. (This would not include background music, which is not a licensable activity. Background music by its nature would not be loud enough to be audible in the street.)
6. There shall be no exterior sited speakers or speakers in doorways or lobbies.
7. Noise from licensable entertainment shall not be distinguishable from the ambient noise on the street 10 metres or more from the premises. This shall be assessed from the street. However, should complaint from a resident in the area be made steps shall be taken to ensure that noise breakout is reduced to a level agreed with the Local Authority

and the complainants.

8. A written management plan to be in place to ensure that the doors and windows are kept closed during any licensable entertainment.
9. The management of the premises shall undertake monitoring of noise breakout from the premises and a written record needs to be kept of this monitoring. This shall be undertaken at least once per day.
10. The volume of any regulated entertainment shall be under the control of the management at all times. Should monitoring indicate that the volume should be reduced, management shall take steps to ensure that levels are reduced to those agreed in condition.
11. This premises licence applies only to the parts of the premises named below and the maximum number of persons to be permitted within those areas shall not exceed:-

Music singing and dancing - Ground Floor: 600; First Floor: 500; Second Floor: 90; Second Floor Office Bar 60.
except that
Exhibitions of Sporting Events - 450 within the whole building at any time.
12. The maximum occupancy figure being ground floor 600, first floor 500, second floor 90 and Second Floor Office Bar 60 must be checked. Steps must be taken so that once the maximum occupancy is reached, no further persons are admitted.

The Prevention of Crime and Disorder

1. Policies on the promotion of non-alcoholic drinks including water must be adhered to.
2. Tap water must be free of charge.
3. On leaving, patrons must be informed that they are entering a "no drinking zone".
4. Extensive CCTV must be provided and kept in full working order and fully compliant with Data Protection.
5. There must be supervision of queues.
6. The supply of alcohol must cease 30 minutes before the premises is shut, whereupon "mood" music will be played to patrons.
7. The premises shall join and maintain membership of the Torquay Night-time Economy Forum where a premises management representative shall attend at least 2 meetings per calendar year.
8. On every operational day when door supervision is required then those SIA door supervisors employed in front of house duties shall wear high visibility reflective jackets for the entirety of their duty.
9. There shall be no entry or re-entry of patrons to the premises after 2am, except on the morning of the day that British Summer Time commences, when entry and re-entry shall be permitted to 3am BST.
10. A CCTV system of an evidential standard, covering both inside and outside the premises, shall be installed to the satisfaction of the police. The system shall be in operation at all times the premises are open to the public. All recordings from the system shall be kept for a period of 14 days and the police shall have access and be provided with recordings where requested.
11. The DPS must hold or complete the BIIAB National Certificate for Designated Premises Supervisors within three months of commencing employment at the premises. The appropriate certificate, or copy of such certificate, must be forwarded to the Police Licensing department forthwith.

Public Safety

1. Door staff must be rotated around the club.
2. All bars must be fitted with panic lights.
3. All doors staff must be equipped with radios.

4. Awareness posters for binge drinking and drink driving must be displayed.
5. There must be regular glass and bottles collection.
6. The premises licence holder and/or the DPS must maintain a health and safety risk assessment procedure.
7. The premises licence holder and/or the DPS must provide toilet attendant/medical room/qualified first aiders.
8. Fire Safety Measures for which the premises are provided, must be maintained in good working order and their adequacy will be determined on a regular basis by carrying out a fire risk assessment, as required by, and in accordance with the Fire Precautions (Work Place) Regulations.
9. The premises licence holder and/or the DPS must take precautions to maintain occupancy levels.
10. Electrical system, including portable appliances must be inspected and tested annually by a competent electrician to ensure safety.
11. Where temporary electrical equipment is to be used, a suitable circuit breaker device must be installed to cover this equipment.
12. Free drinking water must be available at all times.
13. When disabled people are present, adequate arrangements must exist to enable their safe evacuation in the event of any emergency, review and assessment of access ability in line with the Disability Discrimination Act will be completed and kept on the premises.
14. The premises licence holder and/or the DPS must ensure that at all times there are adequate first aid arrangements. Suitable protective equipment must be provided to deal with hypodermic needles, blood spillages and other body fluids.
15. Procedures must be in place to ensure that body fluids are dealt with in safe manner to avoid the risk of communicable diseases.
16. Gangways, exits routes and steps must be maintained in good order and non slippery and even surfaces.
17. A means of addressing patrons during operating hours which can be heard above entertainment, or a means of interrupting the entertainment to make important safety announcements must be made available.
18. For boxing and wrestling, an appropriately qualified medical practitioner shall be present when entertainment involving boxing, wrestling, judo, karate and other sports of a similar nature is taking place.
19. Any event involving wrestling or similar sport - the public shall not occupy any seat within 2.5 metres of the ring.
20. When a ring is constructed, it shall be of an appropriate nationally recognised standard and any material shall be of a fire resistant nature.

The Prevention of Public Nuisance

1. Noise or vibration must not emanate from the premises such as to cause persons in the neighbourhood to be unreasonably disturbed.
2. The premises must be fully soundproofed.
3. Signage asking for orderly egress and patrons cannot take out bottles and drinks must be displayed.
4. A payphone within the foyer must display local taxi numbers.
5. An appropriate break in accordance with licensing conditions must be used between the supply of alcohol and the premises closing.
6. Noise from the premises shall not be audible within any dwelling with windows open for normal ventilation especially after 11pm. This shall be assessed from the boundary to the nearest residential properties, on all sides of the licensed premises. The criteria that shall be applied are:
 - (i) Before 11pm - Noise emanating from the premises shall not be clearly distinguishable above other noise.
 - (ii) After 11pm - Noise emanating from the premises shall not be distinguishable above background levels of noise.

(iii) The local authority shall reserve the right in cases of tonal noise and where premises are attached to others, to make further assessments from within the residential property.

7. The placing of refuse, such as bottles, into receptacles outside the premises must take place at times that shall prevent disturbance to nearby properties.
8. Deliveries of kegs, bottles, food or other materials necessary for the operation of the business shall be carried out at such a time or in such a manner as to prevent nuisance and disturbance to nearby residents.
9. Provision of mechanical ventilation and air conditioning system shall not allow noise breakout from the premises or cause a nuisance by its operation.
10. Regular maintenance shall be carried out on all plant and machinery to ensure that noise disturbance from such sources is kept to a minimum.
11. The handling of beer kegs, bottles and other similar items shall not take place in the late evening, at night and during the early morning, when the noise generated could cause a nuisance particularly outside buildings.
12. Bottle skips and bins containing cans or bottles shall not be emptied outside after closing but shall be dealt with the next day during normal office hours.
13. All the rubbish produced by the premises shall be stored securely in a designated area or in a bin with a tight fitting lid. This shall help prevent litter being blown around.

The Protection of Children From Harm

1. Under 18s shall only be permitted in the premises during events specified within this licence. They will not be permitted in the premises at any other time.
2. Suitable signage shall be displayed at all points of sale of alcohol to remind staff that alcohol must not be sold to persons aged under 18 years old.
3. Door staff must ask for proof of ID.
4. Under 18 events may take place to which the following conditions shall apply:
 - a) These events shall finish no later than 23:00 hours after which there will be a 30 minute period before the nightclub opens to over 18s.
 - b) The police shall be notified in writing or email at least seven days prior to the event.
 - c) During International Student events a minimum of two SIA door stewards must be employed throughout the event. In addition, the PLH/DPS shall carry out a risk assessment based on the type of event being held and taking into account the ratio of students' leaders to students attending, and employ further door stewards, if at all, at such times and in such numbers as determined by that risk assessment.
 - d) All alcohol shall be locked away and/or obscured from view.
 - e) All gaming machines with prizes shall be unplugged and locked.
 - f) All promotional material relating to alcohol shall be removed.
 - g) Any person refusing to be searched shall be refused entry.
 - h) The event shall be promoted to ages 14 years and above.
 - i) International Student events shall be restricted to International Students only.

may re-queue outside the premises for entry to the second floor via separate entrance.

b) The police shall be notified in writing or email at least seven days prior to the event.

c) At least six SIA door stewards must be employed throughout the event.

d) Persons over the age of 18 will be identified by a door steward or the DPS or the personal licence holder who will apply a wristband to that individual. No alcohol will be served to anyone without a wristband and anyone between the age of 14-17 years must be accompanied by a responsible adult.

e) Throughout the event the door stewards will request and check ID of those people consuming alcohol to ensure that no-one under the age of 18 is consuming alcohol. Bar staff will still check ID while serving drinks including those people who are wearing wristbands. ANNEXE 3

CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY

Public Safety

- 1. The use of the Martin Atomic 3000 DMX shall only be permitted in instances where the flicker rate of the output unit is three and a half flicks per second or less.

The Prevention of Crime and Disorder

- 1. The premises must not operate 'All inclusive' drink promotions of any kind.
- 2. All drink promotions shall be managed in a responsible manner.
- 3. A Personal Licence Holder shall be on duty at all times whenever the premises sell or supply alcohol.
- 4. Any person employed at the premises in the sale and supply of alcohol, shall attend and successfully complete the BIIAB Level 1 Award in Responsible Alcohol Retailing within 2 months of commencing employment.
- 5. A record of all staff training, including copies of all relevant BIIAB Certificates, shall be kept on the premises and be available to the police or Local Authority Licensing Officers for inspection on demand. Such records to be kept at the premises for a minimum of 12 months.
- 6. Notices regarding the sale of alcohol to persons who appear drunk, shall be prominently displayed at all points of sale and supply of alcohol, for the attention of persons so employed.
- 7. Notices regarding the sale of alcohol to persons who appear drunk, shall be prominently displayed on the premises and at the entrance to the premises, for the attention of all customers.
- 8. Whenever the premises offer drink promotions, there shall be an SIA qualified door steward, strategically positioned in the area of each bar that is offering such promotions.
- 9. The DPS shall ensure that a written record of all bar staff employed each day the premises are open for the sale and supply of alcohol, is maintained and kept on the premises. Such record must be retained for a minimum of 12 months, and be available to the police or Local Authority Licensing Officers on demand.
- 10. The DPS must hold or complete the BIIAB National Certificate for Designated Premises Supervisors within 3 months of employed at the premises. In respect of the current DPS, Mr Dean Sanders, this must be done within 3 months. The appropriate certificate, or copy of such certificate, must be produced to the police forthwith.
- 11. The DPS shall ensure that an Incident Book is kept on the premises and that all incidents are recorded therein on a daily basis. The Incident Book shall be made available for inspection by a police officer, a police licensing officer or



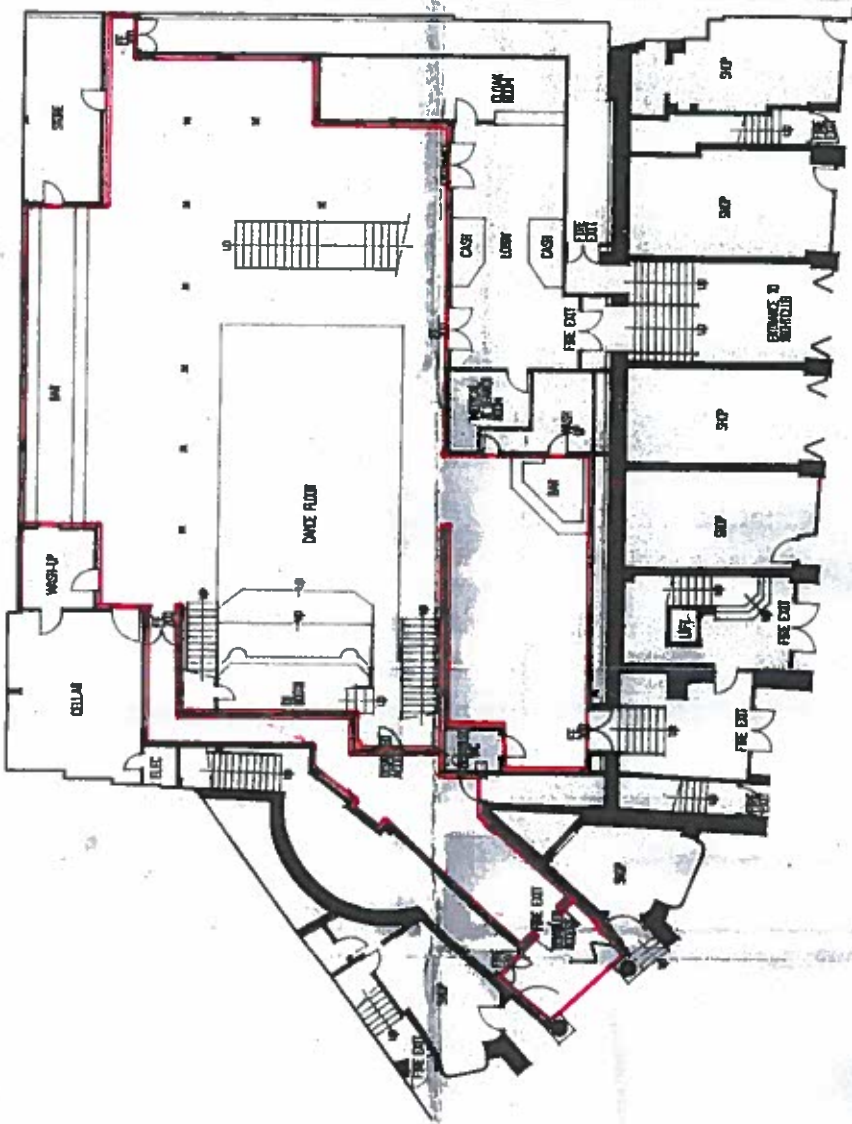

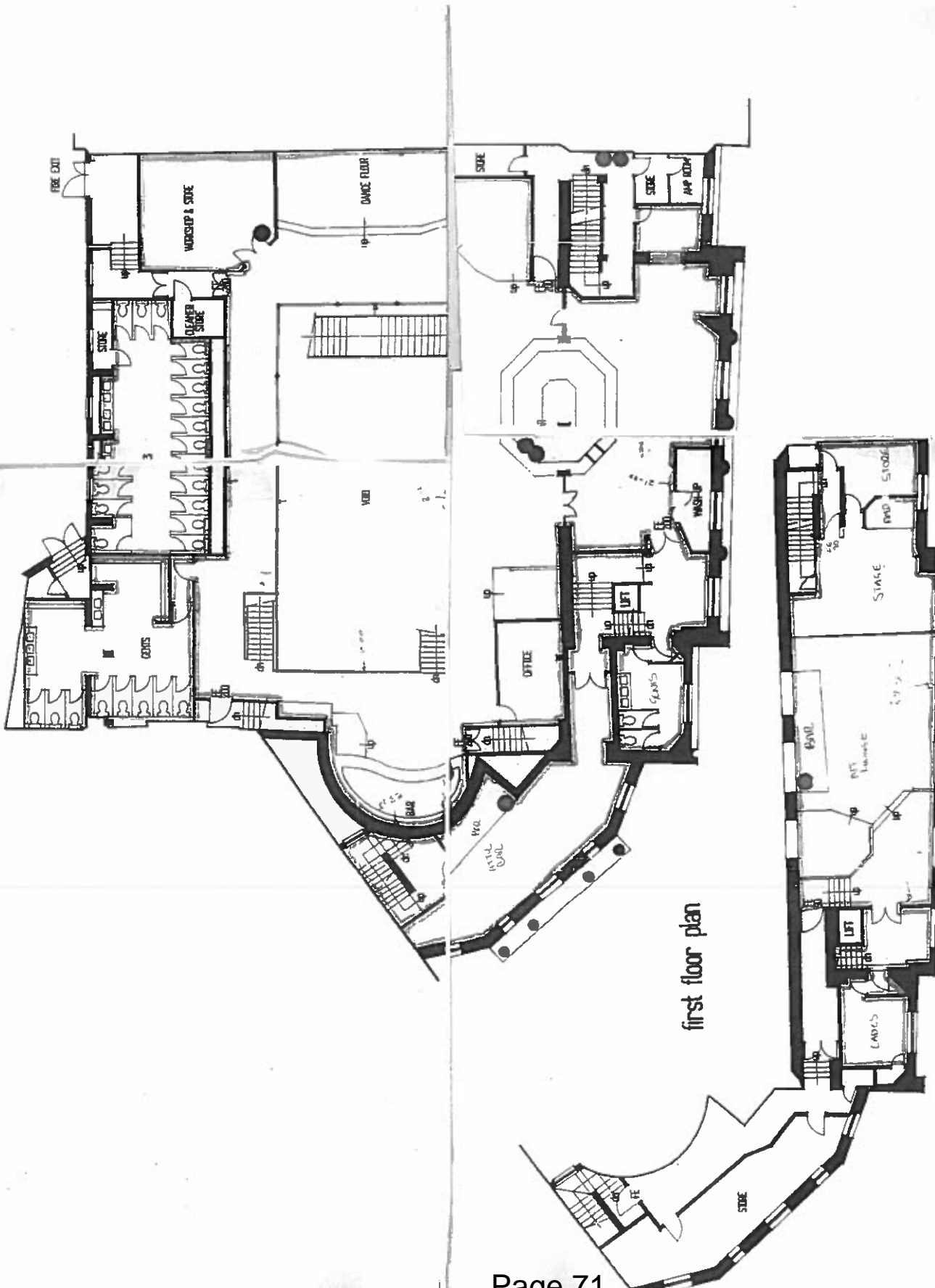

I refer to application for the Variation of the Premises Licence in respect of the above named premises, submitted by the applicants, Jam Leisure (TQ) Limited. The directors of this company are Mr Adrian Hobbs and Mrs Jacqueline Hobbs.

For your information Mr and Mrs Hobbs are also the directors of Jam Leisure (Park Lane) Ltd, who holds the Premises Licence in respect of the Park Lane, 1 Torwood Street, Torquay. An application for the variation of the premises licence in respect of this premises has also been submitted to Torbay Council.

My Police Licensing Officer, Mrs Julie Smart, and Sgt Mike Norsworthy (Licensing Sergeant Devon) have met with Mr Hobbs, and various members of the management teams of Park Lane and the Venue, several times over the last few months in relation to these variation applications. The police do not object to this application but would like to provide you with the following information which may assist you when considering this application.

Mrs Smart advises me that the variation applications have been made to change the layout of both premises. An interconnecting doorway is to be created on the first floor and, at times, customers will be allowed to move between the two premises. In addition, in respect of the Venue, other internal alterations will be made to provide a new smoking area and a 'retro club' within the main building. These changes of layout should help alleviate concerns regarding the crowding of customers on the first floor of

Park Lane and reduce the queue for the smoking area within Park Lane, as customers will be directed to an alternative smoking area within the Venue. It is also anticipated that fewer customers will smoke outside the Venue, thus reducing the likelihood of noise and public nuisance on the street. Mrs Smart and Sgt Norsworthy are satisfied that the changes of layout of both premises will not impact on any of the licensing objectives.

The applications also seek to remove and add additional conditions to the licences. Mrs Smart and Sgt Norsworthy have carefully considered these and do not anticipate that the proposed amendments will impact on any of the licensing objectives.

In respect of Park Lane, the applicants are reducing the opening hours on Saturdays to match the rest of the week, ie 1000 hrs until 0330 hrs. In respect of the Venue, the applicants are seeking to extend the sale of alcohol by an additional 30 minutes every day of the week, ie from 1100 to 0230 hrs to 1100 hrs to 0300 hrs, closing 30 minutes thereafter. This will mean that both Park Lane and the Venue can sell alcohol until 0300 hrs daily, and this will prevent the flow of customers from one premises to the other in the lead up to closing. At the present time customers leave The Venue at 0300 hrs however many use the services of the takeaways and do not leave the area immediately after leaving the premises. Therefore the police do not consider that this alignment of closing times will have a detrimental effect on any of the licensing objectives.

In addition, Mrs Smart advises me that she has worked very closely with the management teams of both premises during the last couple of years. From statistics prepared by Mrs Smart, it is evident that recorded crime at both premises has reduced year on year. In respect of Park Lane in 2016 there was a 17.2% reduction of crime compared to 2015. In respect of the Venue, in 2016 there was a 26.4% reduction of crime compared to 2015.

I am writing these representations, the same for both, with regard to the Prevention of Public Nuisance Objective.

Park Lane 1 Torwood Street, Torquay TQ1 1ED and Venue 13 Torwood street, Torquay TQ1 1ED

I wish to make representation on behalf of the Responsible Authority for Environmental Health dealing with noise nuisance in respect of both variation applications for the above premises.

There have been complaints relating to noise emanating from both premises. Visits have been made to the premises from officers relating to noise issues and these matters have been discussed with both the owner and management of the premises.

Following the takeover of the Venue by the owners of Park Lane, a visit took place to discuss the noise issues both past a current and a full explanation of the proposed alterations to the premises was given at that time. All of the local authority concerns and details pertaining to complaints that had been received were discussed and assurances given by management in respect of both premises that measures would be put in place to combat further issues.

The applications have been submitted in accordance with the discussed measures and it is hoped that a premises operating under the revised (should they be granted) licences will bring about a vast improvement. It is difficult to assess the degree of any positive impact at this stage, however, the noise measures incorporated into the renovations to the building are of a standard that suggests that the outbreak of noise will be reduced in comparison to previously.

In view of this, the environmental health team are not objecting to the application as such, however, on the basis that Members are required to consider the merits of the application and that they may therefore have technical questions to ask of noise officers, this representation allows for an officer to be present at the hearing and ensures that measures discussed are incorporated on any licence that is deemed to be granted.

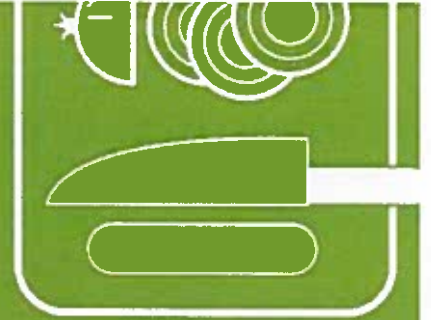

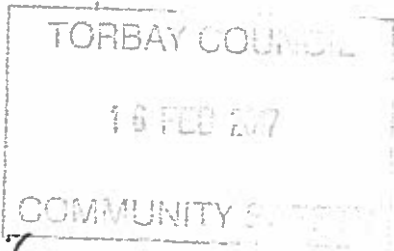

Dear Sir,

I wish to lodge an objection to the proposed variation of use on the above premises to that of a live music venue. I have lived at this address for a number of years and my neighbours and I have had occasion to make complaints to Torbay Council with regard to excessive noise and vibration with no satisfactory long term outcome. I have noted from an item in the Herald Express today that this application seems to be something of a fait accompli - I have enclosed a clipping from the Herald Express for your perusal! Our objections relate to the prevention of Public Nuisance.

1. "Noise or vibration must not emanate from the premises such as to cause persons in the neighbourhood to be unreasonably disturbed"
IT DOES and we ARE - frequently!
2. "The Premises must be fully SOUNDPROOFED!"
Has the Council proof that this is the case?
3. "Noise from the premises shall not be audible within any dwelling with windows open for normal ventilation especially after 11pm ..."

It has never been possible to have a window open when this club is in operation - such is the extent of the noise and vibration.

Mr Karl Martin of Torbay Council has been aware of our problems and complaints for some time and whenever a complaint is resolved it soon returns and over a period of over 15 years of complaints this has become exhausting for us.

With regard to THE PREVENTION OF CRIME AND DISORDER

We have had problems with people accessing the rear of the property where we live in order to attempt to gain access to the club. This is both dangerous and worrying as we are unable to differentiate between clubbers and burglars. Our back lane and Park Lane steps are frequently used as a public urinal. Our neighbours have had people on their roof and have had to notify police about youths on the roof of the Venue - both conscious and unconscious!

There appears to have been a significant Police presence when this club is operating - who pays for this? Is a live music venue a good idea when it will come at a large cost to the taxpayers?

I hope that you will take note of our objections. I realise that I can take formal action with a noise abatement EPA90 but have always hoped that the Council will adhere to the letter of the law!

Adrian Hobbs, has taken on the business, situated in the historic Scala Buildings in Torwood Street, just yards from his Park Lane club.

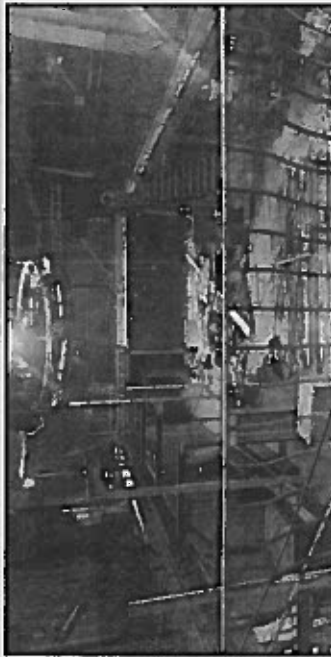
His company has already re-furbished The Attic, which has reopened, as part of plans to redevelop the entire building to create a 'multiple space music complex, offering a range of events'.

I wish to have known that we object to any change of usage for either venue.

We have until now been fairly quiet and not objected too harshly for past episodes of what could only be described as NOISE causing Public Nuisance. to our home which is situated in very close proximity to both the above named establishments.

(1) Venue - we wish to protest their application on the grounds that the noise, experienced only recently will be gratefully exasibated if their re-newed application gets accepted and enter this complainr with the Public Nuisance remit. The vibration from the constaur BASE is at times intolerable & could get worse if this application is granted -

(2) Park Lane - Gives us great concern if their applicatn is accepted as only recently we had to inform the police that a person/persons were both climbing on our roof

and then onto the roof above the 'Veuve' hoping to gain access to the 'Roof Garden' at the top of the Park Lane veuve.

My last report to police was before Christmas 2016 as a gentleman had climbed onto the Veuve roof and unfortunately did not gain said access but was forced to fortunately SLEEP off his intake of alcohol.

However from my vantage point all I could see was a lifeless body on the roof, not knowing if he was injured or deceased I called the police who dealt with the individual.

I feel that this intrusion will happen more often and would be likely to be considered as a Public Safety problem.

We have had on two occasions some involvement with the Environmental Health dept and whilst I visit from Mr Karl Martin, who agreed with his colleagues that the noise we were experiencing was unacceptable, but did nothing to assist etc - - Or even inform us of any outcome from further conversations etc - -
