#### **Preston Community Partnership**

Working with Torbay Council is paramount to Preston Community Partnership improving Preston for both Residents and Visitors.

Preston Community Partnership would be pleased to discuss in advance any plans made for Preston. We feel this would go a long way to ensure projects are carried out to the full benefit of Preston Residents and Visitors.

Preston Community Partnership, as will be the case for all the Partnerships throughout Torbay, would be delighted to take on tasks which are seen by Torbay Council as non essential or so low on the priority list as to be never undertaken.

Our list of items which are important to the Residents and Visitors of Preston is:

• Parks and Greens

These need to be kept clean, grass cut, trees planted and kept pruned, paths kept clear, plants planted and benches together with children's playgrounds fully maintained.

• Beaches

These need to be kept cleaned and the facilities fully maintained. The walls, steps and promenades need to be kept in good order.

- Roads maintained Pot holes need to be repaired, tarmac needs to be kept in good order, hedges need to be cut back and grass banks cut to ensure the highest level of safe driving.
- Paths maintained These need to be kept smooth and resurfaced when slabs become broken or lifted. This is essential for the safe movement of mobility scooters, prams and the elderly public.
- Household and Public bins emptied on a regular basis Public bins need to be emptied on a regular basis. Household bins including recycle bins need to be emptied on a regular basis. Recycle bins need to be made available in as many locations as possible. Dog toilet bins need to be made available everywhere and the owners enforced to us them, not leave it on paths and roads.
- Community assets such as Parkfield and Oldway Mansion These need to be kept in the local community as long as there are sufficient fund to keep them maintained fully. They should not be left to crumble into disrepair. Torbay Council needs to work with the Partnerships to achieve this.
- Security and safety of residents Cameras need to be kept operational and used when there are any incidents.
- Street Lighting These need to be kept maintained and Torbay Council should liaise with local Partnerships when they plan to change lighting times.
- Car Parking Residents and visitors need plenty of reasonably priced parking. Any changes to costs and numbers of spaces should be discussed with the local Partnership.
- Public Toilets These should be kept open, cleaned and maintained. If there are two in the same area, the Partnership should be asked to provide their input as to how to save money whilst still providing the necessary service to the public.

#### St Marychurch & District Community Partnership

1. St Marychurch is a community that has a larger amount of older residents. One priority for our community is public transport. Recently a number of bus services have been stopped.

- the 67 which serviced residents living in the Quinta Road and Lyme View areas of Babbacombe. The loss of this services is causing huge inconvenience and is having the effect of isolating some older people.
- part of the 32 bus route between the hospital and the Willows shopping area has been stopped and is also causing great inconvenience to residents of St Marychurch, Willows and Barton & Watcombe - the time taken to travel by alternative bus routes has trebled for some residents.

# By financially supporting local community bus services to cover those removed would greatly improve residents lives.

2. A further priority is to financially support additional Environmental services staff. Recent cuts have meant that regularly sheduled maintenance has been reduced, St Marychurch & Babbacombe have a high number of tourists visiting each year. **This is impacting on that local area and many residents are unhappy that certain areas are becoming overgrown and untidy.** 

3 Another priority is the repair and maintenance of the steps down to Maidencombe Beech. The MRA will be organising some fund raising events next year, and we shall be prepared to undertake some work such as clearing vegetation and painting the railings.

## A contribution from the Council to support the major repairs would be most welcome.

One money saving suggestion that the Council should consider is to hand over all the land being managed by TCCT and owned by Torbay Council to the National Trust.

This would save the constant drain of financial support from the tax payers of Torbay, it would mean no longer would the TCCT having to be both 'poacher and gamekeeper' when it comes to looking after the land, it would protect the land and as a result it would maximise this fantastic asset well into the distant future for all those that come after us to enjoy as well as all those who enjoy the open spaces in Torbay now. The coastal paths would be far better maintained and the services such as toilets, car parks and beach cafes would not only be kept open but to a higher standard, the farm land would be better utilised and made more productive. Councillors and Council servants would no longer be tempted to take short term decisions that would destroy the most valuable asset Torbay possesses. A simple matter of protecting the future in one easy step and it would increase the tourist and visitor activity giving a boost to Torbay economy for no extra cost - all marketing and up keep would be down to the National Trust.

#### Brixham Community Partnership priorities for Torbay Council's spend in Brixham

#### The Community

Continue to support and maintain adult and social care/children's services. Care in the community ensure no-one is homeless or living in unhealthy surroundings with insufficient food/care. Support local preschool facilities and ensure that young people are educated in life lessons, i.e., debt avoidance, saving for a house, having children, voting, drugs, alcohol and diet. Improve infrastructure and services as the community expands & ensure there are affordable homes. Retain good medical services. Support local police and maintain visible policing.

#### <u>Tourism</u>

The main issue is road access to Brixham - limited access in and out causes considerable problems and is a deterrent both to tourists and to businesses. New housing construction puts additional pressure on the road network and access is completely blocked when even the smallest accident occurs. Parking in Brixham is an issue with very little on-road parking available. The Central Car Park which yields approximately £400,000 in parking charges annually has had no investment ploughed back into it for years. The Park & Ride is available but some considered it expensive. This is affecting tourism and compares poorly against the accommodation provided to, for example, tour buses in Dartmouth. Coaches should be encouraged to use Oxen Cove. It is essential that the town's facilities/attractions be maintained for tourists, e.g., Shoalstone & Admiral pools, Berry Head, Museum, Battery and Town Hall. Of particular concern is the potential loss of our theatre. Finally, the public toilets are a disgrace and should be completely refurbished/rebuilt.

#### **Business**

Efforts should be made to attract and retain businesses. Maritime business would benefit from a Northern Arm. Fore Street should be revitalised without losing its quaint character.

#### **The Voluntary Sector**

Encourage, support and involve the voluntary sector, e.g. Pride in Brixham, Youth Genesis, Rotary, YES, etc., which is increasingly picking up the load being dropped by councils.

#### The Environment

Green spaces - we need to protect the limited green spaces that we have left, especially between Brixham and Churston. Torbay Council and speculative developers are aggressively pursuing planning permission to build on these spaces which will severely affect both the environment and road access to Brixham.

In conclusion, it was felt that in order for this sort of exercise to be undertaken successfully, that more information is required on the proportion of money raised by Torbay Council that is spent on Brixham annually. Also, greater accountability is required from individual TC departments when spending ratepayers' money. It was suggested that Brixham Town Council could be abolished to save money although others suggested that not only should BTC be retained but that it should take over direct responsibility for Community Spaces/Parks, street-cleaning, refuse-collection and toilets (with a commensurate increase in funding from Torbay Council).
