2) The premises shall have a CCTV system installed, which will operate whenever the premises are open. The system shall have recording facilities and all recordings will be kept for a minimum of 14 days, such recordings will be provided to the police when required.

c) Public safety

1) The premises shall operate a Challenge 25 policy, ID will be requested from anyone who appears under the age of 25. If satisfactory photographic ID in the form of driving licence, passport or approved PASS card is not produced, no sale of alcohol will take place.
