Title: Licensing Act 2003 – An application for a Premises Licence in respect of Torquay United Football Club, Plainmoor, Torquay TQ1 3PS

1. Key points and Summary

- 1.1 To consider and determine an application, in respect of the Premise detailed above, for a new Premises Licence.
- 1.2 The application relates to all the Corporate Priorities within the Community Plan.
- 1.3 The matters raised relate to the Licensing Objectives “The Prevention of Crime and Disorder”, “The Prevention of Public Nuisance” and “The Protection of Children from Harm”.
- 1.4 The matter must be considered on its merits having received details of the issues arising either at a hearing or by written Representation if all parties have agreed that a hearing is not necessary. A decision must be made, having considered the Representations, either:-
 - (a) to grant the licence subject to
 - (i) such conditions as are consistent with the submitted operating Schedule modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and
 - (ii) any condition which must under Section 19, 20 or 21 be included in the licence;(Such conditions may differ in respect of different parts of the Premises and/or different activities).
 - (b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
 - (c) to refuse to specify a person in the licence as the Premises Supervisor;
 - (d) to reject the application.

- 1.5 Reasons for the decision must be given for inclusion in the appropriate Notices required to be served on the Applicant and Interested Party following the determination of the matter.

2. Introduction

- 2.1 An application has been made under Section 17 of the Act for a Premises Licence to permit licensable activities at the Premise detailed above. Details of the relevant pages of the application are shown in Appendix 1.

The application is to apply for a new premises licence to cover No. 10 Restaurant and Bar area, The Popside Football Stand and the football pitch and stands.

The No. 10 Restaurant and Bar and The Popside Football Stand both hold existing Premises Licences, which will be surrendered if this application is successful.

A brief description of the application, as follows:

The Exhibition of films indoors from 11:00hrs until Midnight on Monday to Sunday.

To provide Live and Recorded Music indoors and outdoors from 11:00hrs until Midnight on Monday to Sunday (The premises wish to hold 2 outdoor music events per year with a maximum capacity of 3000).

To provide Late Night Refreshment on and off the premises from 23.00hrs until Midnight on Monday to Sunday.

The Sale of Alcohol on and off the premises from 10:00hrs until Midnight on Monday to Sunday.

For all of the above, with the exception of films, the applicant has applied to extend the hours on Friday and Saturday from 11.00 until 01.00 for pre-arranged functions in the Gulls Nest and No. 10 Restaurant.

To be open to the public from 0800hrs until 0030hrs on Monday to Sunday. On Friday and Saturday until 01.30 for pre-arranged functions only.

A copy of the plan of the Premises is shown as Appendix 2.

- 2.2 The Council as the Licensing Authority is satisfied that the Applicant has met the administrative requirements of Section 17(5) but is unable to issue the Licence, as a relevant Representation has been received from a Responsible Authority and Interested Parties. The Licensing Authority is also satisfied that the Representations have been received within the appropriate time scale, have not been subsequently withdrawn and are not vexatious or frivolous.

We have received two representations from members of the public in relation to the Licensing Objectives: "Prevention of Crime and Disorder", "Prevention of Public Nuisance" and "Protection of Children from Harm". These are shown as Appendix 3.

We have received one representation from Environmental Protection in support of the application in relation to the following Licensing Objectives: "The Prevention of Public Nuisance". This is shown as Appendix 4.

There have been no additional Representations received from any other Responsible Authority or any other Interested Party.

- 2.3 The Authority is required to conduct a hearing by the provisions of Section 18(3) unless all parties agree that this is not necessary.
- 2.4 Appropriate Notices have been issued to all parties, as required by the Licensing Act 2003 (Hearing Regulations) 2005, including, where appropriate, details of the Representation and the procedure to be followed at the hearing.
- 2.5 If the application is refused, in whole or in part, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 1 of Schedule 5, to the Applicant.
- 2.6 If the application is granted, a Right of Appeal to the Magistrates' Court is granted by Section 181 of the Act and, by Paragraph 2(1) of Schedule 5 to :-
 - (a) The holder of the licence against any decision
 - (i) to impose conditions on the licence, or
 - (ii) to take any step to exclude a licensable activity or refuse to specify a person as Premises Supervisor.
 - (b) Any person who made a relevant Representation who desires to contend
 - (i) that the licence ought not to have been granted, or
 - (ii) that, on granting the licence, the Licensing Authority ought to have imposed different or additional conditions, or taken any step to exclude a licensable activity or refuse to specify person as Premises Supervisor.
- 2.7 Following such Appeal, the Magistrates' Court may:-
 - (a) dismiss the appeal,
 - (b) substitute for the decision appealed against any other decision which could have been made by the Licensing Authority, or
 - (c) remit the case to the Licensing Authority to dispose of it in accordance with the direction of the Court,and may make such order as to costs as it thinks fit.
