**The Terrace Bar, 12/14 The Terrace, Torquay, Devon, TQ1 1BN**

I refer to Sergeant Norsworthy's application for a Review of the Premises Licence in respect of the above named premises, which was submitted on 20 June 2018. Premises Licence number PL0433 refers.

I now wish to provide you with the following additional information in relation to this premises, as follows:

At 1509 hrs on Friday 27 July 2018 I received an email from Ms of MRS Communications, indicating that there had been a new tenant on the site since May who had not set up an account with them, and therefore she requested that the Torbay Council CCTV Control Room immediately disables the radio.

I can advise you that the Premises Licence for the Terrace Bar contains the following condition:

*Premises shall join and maintain membership of the Nitenet Radio Communications Scheme.*

In relation to this email I have not taken any action due to the following reasons:

- 1) I do not have any contact details for Mr Moore and even if I had contacted him I have little confidence that he will resolve this matter as he has not taken any

positive action to address matters that I have previously brought to his attention. In addition on 2 July 2018 Mr Lawrence advised me that he had spoken to Mr Moore concerning the proposed transfer of the licence, suggesting Mr Moore contacts a solicitor to assist him. To date no application has been submitted and I have not received any contact from a solicitor regarding this premises.

- 2) Mr Lawrence remains the sole director the company that holds the premises licence and he is still the DPS. Despite having been told by myself and Mrs Guy that he is still legally responsible for the premises he does not appear to have taken any steps to resolve this situation, such as ensuring that the premises are closed until the applications have been submitted, withdrawing his authority to sell alcohol at the premises or ensuring that the premises are run in an appropriate manner by staff acting on his authority.

The premises are currently operating in breach of Section 136 of the Licensing Act 2003. I have considered requesting a police officer to issue a Closure Notice under Section 19 of the Criminal Justice Act 2001 however as the Review hearing is to take place this week, I decided to bring this matter to your attention in order for you to take any action you deem appropriate at that hearing.

At 1801 hrs on Saturday 4 August 2018 police received a report that a male had punched a female at the premises and this female was bleeding from her eye. The caller did not say whether this incident occurred inside or outside the premises, or in fact whether any party was linked to the Terrace Bar. The caller indicated that the offender was a white male, topless, brown hair, covered in tattoos and he was still outside the bar but the female had moved to a position near Banx Bar further down the road. Two police units attended and one spoke to a member of staff at the Terrace Bar who indicated that they have CCTV footage but they cannot access it. The female was ~~subsequently spoken to by police and she did not want to pursue a complaint of assault.~~


For your information the Premises Licence contains a condition that the premises must have CCTV and the police should have access to recordings at any reasonable time. Mr Moore was unable to work the CCTV system when myself and Sgt Norsworthy attended the premises on 19 June 2018. However myself and Sgt Norsworthy were able to use the system to a satisfactory level within a very short space of time. It is therefore a concern that since 19 June 2018 Mr Moore and/or Mr Lawrence do not appear to have taken any steps to address this matter.
