#### Re: Publication of Torquay, Paignton and Brixham Neighbourhood Plans.

Thank you for re-consulting me on the above neighbourhood plans.

The Police are delighted and welcome the level of reference to the subject matter of designing out crime, fear of crime, antisocial behaviour (ASB) and conflict in each neighbourhood plan (NHP), a copy of each reference as detailed below:-

## **Brixham Peninsula Neighbourhood Plan Policy Document states:**

**Policy - BH5.5** - The design of new development and altered buildings or areas in the following categories should adequately take into account the safety and security of the users of the facilities and that of neighbouring residents:-

- Major housing schemes of 10 or more homes
- · Major commercial office, industrial, retail or leisure schemes
- New neighbourhood or district community facilities
- Shop Front improvements
- . Proposals which include significant areas of open space/landscaping as part of a development, including linkage footpaths
- · Proposals incorporating significant off street car parking provisions
- · Improvements such as cycle lanes and new or improved footpaths
- All developments involving Class A3, A4 and A5 food and drink uses
- New or redeveloped schools/education premises
- · Where intended occupants are particularly vulnerable and require higher standards of security to ensure their personal safety e.g. care homes and drug rehabilitation centres.

The above, in the main, refers to the attached agreed Designing out Crime Officers (DOCO) protocol with the planning authority.

Reference is also made in the plan which states:-

"Designing out crime" has been a function of the planning process since The Crime and Disorder Act 1998 established that the responsibility of reducing crime does not fall solely on the police. That concept extends to designing out opportunities for crime, fear of crime, antisocial and unacceptable behaviour and conflict in the built environment.

## Paignton Submitted Plan - Annexe 2 states:-

- Access and movement: Places with well-defined and well used routes, with spaces and entrances that provide for convenient movement without compromising security
- Structure: Places that are structured so that different uses do not cause conflict
- Surveillance: Places where all publicly accessible spaces are overlooked
- Ownership: Places that promote a sense of ownership, respect, territorial responsibility and community
- Physical protection: Places that include necessary, well-designed security features
- **Activity** Places where the level of human activity is appropriate to the location and creates a reduced risk of crime, and a sense of safety at all times.
- **Management and maintenance** Places that are designed with management and maintenance in mind to discourage crime.

The above, in the main, reflect the attributes of Crime Prevention through Environmental Design (CPtED), which the DOCO refers to when assessing the layout and design for new development, as per protocol.

## Torquay Neighbourhood Plan - Submitted Plan states:-

Design to reduce risk and fear of crime - To ensure developments support safe communities, the Plan fully supports the 'Secured by Design' initiative by the Police Designing Out Crime Officer's' protocol with Torbay Council

**PLANNING POLICY H2** Designing out crime - Any new residential development shall be of a design that minimises opportunities for crime, fear of crime and antisocial behaviour proportionate to the scale of the development.

#### And

Design to minimise the risk and fear of crime - To ensure the safety and resilience of new commercial, business and public space developments, the Plan fully supports the 'Secured by Design' initiative by the Police Designing Out Crime Officer protocol with Torbay Council.

**PLANNING POLICY J9** Prevention of crime through design - Any new development of commercial, business or public space shall be of a design that minimises opportunities for crime, fear of crime and antisocial behaviour proportionate to the scale of the development.

It also includes reference under Community Aspiration for:-

Barton & Watcombe Community Partnership – All future development must promotes community safety, and particularly reduces antisocial behaviour, the fear of crime and conflict within the built environment in the area and Hele and Lower Barton Community Partnership – Ensure future development of the area promotes community safety, and particularly reduces antisocial behaviour, the fear of crime and conflict within the built environment.

To assist, Secured by Design (SBD) is a crime prevention initiative owned by the Mayor's Office for Policing and Crime (MOPAC) on behalf of the UK police services. SBD aims to reduce crime, the fear of crime and opportunities for antisocial and unacceptable behaviour and conflict within developments by applying the attributes of Crime Prevention through Environmental Design (CPtED), in conjunction with appropriate physical security measures.

As can be seen, the level of detail and policy with regard to the subject matter of designing out crime etc. differ greatly in each plan, even though the DOCO's previous representations were fairly generic. It is therefore respectfully requested that consideration be given to a more joint approach in terms of the level of detail and policy for each plan, in order to provide a consistent method of reference and to potentially simplify matters for the decision making process when determining future planning applications.

The above is mentioned in the hope of being helpful rather than objective as the Police would prefer the existing level of detail to remain rather than be diluted or removed.

Following those consultations the Plans were reviewed and modified where the forums felt it was appropriate to do so. This the final chance to have your say before the Plans undergo an independent Examination and therefore all pertinent points should be made now.

It would be helpful, if you choose to make a representation, to include your details and any particular position held (landowner, business, organisation, neighbourhood forum member, resident etc). If you wish to be notified of the Examination Hearing (if the Examiner(s) considers one should be held), please include this in your response. All representations are likely to be made public (as is the case for those who make representations on planning applications, with signatures and some personal details redacted).
