It has come to the Local Planning Authority's (LPA) attention that there is an error within the Regulation 16 consultation response (from the LPA) regarding the Regulation 15 submitted Torquay Neighbourhood Plan - <u>http://www.torbay.gov.uk/media/11026/tnptorbaycouncil.pdf</u> - so I am contacting you to bring this to your attention and for your consideration.

Within the representation, objections were submitted regarding the proposed designation of Local Green Space through 'Planning Policy E4: Local Green Spaces' at TLGSS13 (Riviera Way Woodland) on the basis of 'a Local Green Space would potentially constrain the flexibility of possible future development to deliver a proposed Edginswell Station (if required).' The objection should have correctly related to TLGSS6 (Green Space at Newton Road) rather than TLGSS13 and the LPA would like to draw your attention to this. For the avoidance of doubt, the LPA does not object to the designation of Local Green Space at TLGSS13.

For clarification, I have included an annotated figure below, taken from Sheet 4 of the Torquay Neighbourhood Plan Policies Maps (Regulation 15 Submission Version) which shows the location of TLGSS6 compared to TLGSS13.
