# 1. Executive Summary

In the last seven years Torbay Council has made budget reductions of £69 million. Further reductions of £9.6 million must be made for 2018/19 in order to produce a balanced budget.

Despite our achievements in delivering balanced budgets to date, continuing austerity means that the identification of further efficiencies, savings and income generation becomes ever harder. We face an immense challenge in preparing and achieving a robust budget year-on-year which will provide the statutory services of the Council, as well as discretionary services which are valued by our communities.

Over the course of the year the Council's Transformation Programme has been supporting the delivery of a number of projects which have either increased income to the Council, reduced the Council's costs or created services which are more resilient.

The work of the Transformation Programme will continue to achieve further savings and income within 2018/19 and beyond, however demand for children's and adult social care is increasing and the Government is continuing to reduce the amount of funding it provides to local government.

Therefore, to maintain a balanced budget, it was proposed that there would be some changes to services. Information regarding the proposals is at [www.torbay.gov.uk/fit-for-the-future/](http://www.torbay.gov.uk/fit-for-the-future/).

Public consultation on the proposals started on 23<sup>rd</sup> October 2017 and closed on 8<sup>th</sup> December 2017. The proposals were communicated to the Torbay community via a press release to local newspapers (Herald Express & Western Morning News), local radio and posts made on Twitter and Facebook. The proposals were detailed on the Torbay Council website. A budget event was held for the public and people were able to send representations via email and post.

A questionnaire was prepared which highlighted the main proposals being put forward in order to contribute to a balanced budget for 2018/19. It was available online and as a paper survey which was distributed via Torbay Libraries, The Paignton Library and Information Centre and Harbour Offices.

There has been a good response to the budget consultation with a total of 383 completed surveys. There were also 22 written representations received from individuals and organisations in response to the budget proposals. These have been collated, anonymised where necessary and forwarded to senior Torbay Council officers, Councillors and the Elected Mayor.

The budget event was held on 16<sup>th</sup> November 2017, at which the Elected Mayor and Officers were able to discuss the budget proposals with the public and key stakeholders. The event was held at the Riviera International Conference Centre and was attended by 16 people.

At the event, attendees were shown the targeted actions from the Council's Corporate Plan and the proposed distribution of gross revenue expenditure for 2018/19. They were then asked to allocate a percentage of revenue spending to each of the targeted actions themselves, based on what was important to them and their community. Results from this exercise and recorded comments from the event are included in this report.

In accordance with the Constitution, the Elected Mayor's savings proposals were sent to all members of the Overview and Scrutiny Board for consideration. The Board established a Priorities and Resources Review Panel which then considered a number of the specific proposals and received representations from a range of organisations and individuals. The report from that review has been forwarded to the Elected Mayor for consideration.

## 2. Headline Results

The majority of respondents identified themselves as Torbay residents (321). Of these respondents who completed their postcode, 48.3% were from Torquay, 23.2% from the Paignton, and 12.3% from the Brixham area.

In the majority of cases, people replying to the questions were in favour of the proposals put forward for these services. There were seven proposals where the results show that the majority of respondents were in support of the proposal - these are as follows:

- To reduce the Substance Misuse Service contract.
- To create additional income generation from beach huts, including fees paid in specific locations and numbers of beach huts.
- To reduce the Elected Mayor's Event budget.
- To change the way funding is made available to Swim Torquay at Plainmoor Community Swimming Pool and Admiral Swimming Centre in Brixham, by providing a reserve fund that can be drawn on by both organisations.
- To use Capital Structural Maintenance funding to carry out some of the larger reactive works required on the highway.
- To increase Council Tax by 1.99%.
- To add the Adult Social Care Precept of 3% to Council Tax.

Respondents also responded more positively than not, when asked the questions below:

- Would they be prepared to pay more Council Tax in addition to the proposed 4.99%?
- Whether they would support the closure of some public toilet facilities, so the Council could concentrate its resources and funding on upgrading the facilities which are used the most.
- Would they support charging a fee for some public toilet facilities to refurbish and improve the standard and quality?
- How much would they be prepared to pay to use some facilities?

There were three proposals where the results show that the majority of people did not support the proposal – they are:

- To reduce the funding given to youth service providers.
- To reduce the funding for Economic Regeneration.
- To remove the grant funding to Torquay and Brixham Museums.

Most respondents were from Torbay (83.8%) and more specifically mostly from Torquay at 48.3%, with 23.2% from Paignton and 12.3% from Brixham.

Responders were almost evenly split responses from women and men with 45.4% and 49.1% respectively.

The largest age group of respondents was 65-74 at 27.9%.

For each of the Elected Mayor's proposals for changes to services, respondents were asked to comment if they felt the proposal would impact on them. Many chose to add a comment though they had indicated that the proposal wouldn't impact them. All comments have been grouped into themes with examples shown alongside each proposal. Some comments span a range of themes. The comments have been divided between those who supported a proposal and those that did not. There were 925 comments in total, including those in response to Q15, all of which have been forwarded to senior Torbay Council officers, Councillors and the Elected Mayor.

### 3. Summary of results

## Children's Services

#### Q1) Youth Grants

**To reduce the funding given to youth service providers.**

This proposal is expected to save £30,000 in 2018/19 and will mean that the council will not provide grants to locality based youth service providers.

*These providers deliver activities and services for young people. They will have the opportunity to raise funds through the Torbay Lottery. The proposed budget next year for the Youth Trust would be £307,000 with the provision for youth grants being £0.*

Alternate funding / provider	<p><i>"Move Children's Services to Plymouth. Will be run better."</i></p> <p><i>"Young people-- and their service providers should, in normal circumstances, be the most able in Society, to support their own most advantageous fund- raising for their own desired purposes. Diverted funding could then be available for "The most vulnerable in society"."</i></p>
Other	<p><i>"I have a child who would benefit from youth service providers but we feel currently there is plenty of provision"</i></p> <p><i>"Possibly lead to young people spending more time on the streets"</i></p> <p><i>"Less Council tax"</i></p>

There were 60 comments from people who did not support this proposal. A selection of comments which demonstrate the range of themes are shown below.

Children are the future / An investment	<p><i>"Youth grants assist those ages but also self-direct our next generation. This has a cost no price but must be constant."</i></p> <p><i>"We should looking to "our future" children and helping them not taking away from them."</i></p>
Increase in problems / Make things worse	<p><i>"In general terms. In that the lack of youth services could lead to more youth gangs, hanging around, anti-social behaviour, etc."</i></p> <p><i>"I help run a group at Parkfield. The YS help many people, some of whom may turn to crime or suffer other harm. The cost of grants is probably lower than the cost of dealing with these problems."</i></p> <p><i>"The year on year cuts in youth services have already contributed to social problems in Torbay. Don't make it worse."</i></p>
Other	<p><i>"Not directly but we have a large population of very young parents etc....they need guidance and don't necessarily receive it from their own parents."</i></p> <p><i>"I have children involved in local groups."</i></p>
Effect on the community	<p><i>"The youth services require funding to support disadvantaged young people. This is important for the community mix of the bay."</i></p> <p><i>"This will have an impact on every Torbay resident do not cut this funding."</i></p>

## Public Health

### Q2) Adult Substance Misuse Services

**To reduce the Substance Misuse Service contract.**

This proposal is to reduce the budget by £62,000 in 2018/19 and £100,000 in 2019/20.

*These services provide treatment for people who use drugs and alcohol problematically and provide pharmacy based services e.g. needle exchange and supervised consumption of controlled medication. The proposed budget for next year would be £2,475,000.*

Another Way	<p><i>"Better education is required not more money being thrown at this problem. That should originate in Schools."</i></p> <p><i>"More "Druggies" on the street &amp; beggars. Jail them and get them off the street."</i></p>
Too much is spent on this	<p><i>"This seems a very high figure - almost £2.5m to treat drug users in Torbay? Why is there a budget at all?"</i></p> <p><i>"Why should we fund this when I have to live with uneven pavements, weeds growing up my walls and anti-social behaviour."</i></p>
Other	<p><i>"Many families we work with will need the support offered by these services. However I feel it does leave them with something."</i></p> <p><i>"Less Council tax"</i></p>
Will impact all of us	<p><i>"We are all impacted by drug users and their impact on society."</i></p>

There were 70 comments from people who did not support this proposal. A selection of comments which demonstrate the range of themes are shown below.

Theme	Examples of comments
More ASB / Drug use / Homelessness	<p><i>"Homeless people often have misuse difficulties. I feel this would make the problem worse and in turn affect people in Paignton. I live in an area where homeless people meet up. If people who have a home have substance abuse problems, there is a risk to them becoming homeless if reduced help is available."</i></p> <p><i>"It will mean more addicts and misusers using in public places. Discarded needles littering public areas and more of a chance of youngsters becoming users themselves."</i></p> <p><i>"Drugs and alcohol addiction are serious problem in Torbay. More unchecked and unassisted usage means much higher crime rates."</i></p>
An existing problem for Torbay	<p><i>"I feel that there is a very high proportion of substance abuse in Torbay and that cutting the grant will lead to increased misuse if addicts are unable to receive the right level of treatment"</i></p> <p><i>"People need support to stop using! The problem in Torbay is clear to see on the streets. Reducing the budget will only increase the problem."</i></p> <p><i>"The area has an increasing problem with drugs addicts, a short walk through Torquay town centre will show how bad this problem is. If anything services need to be increased. I don't feel safe in some parts of town, do not use certain car parks because of the antisocial behaviour. Cutting this funding is a ridiculous idea."</i></p>

Theme	Examples of comments
Effects community / Tourism	<p><i>"Support the provision as it would impact on the whole community if cuts are made to service."</i></p> <p><i>"This would have a direct impact on people being in my community being able to access safe treatment. Any reduction in needle exchange services, safe dispensing of methadone and availability of treatment for addictions has an impact on the safety and wellbeing of the whole Community."</i></p> <p><i>"The drug problem in Torquay is horrendous, the ever dwindling amount of holiday makers often make comment about how rampant and obvious it is, a reduction can only see an increase in an already bad situation."</i></p>
Other	<p><i>"Put the money you save in to. Our hospital"</i></p> <p><i>"Without seeing evidence that this scheme has had good results in the past, it is difficult to say but it seems a very large budget. I would support a larger reduction than £100,000 if there are no clear indications of this being a successful programme to date."</i></p> <p><i>"Addictions are diseases"</i></p>
Personal experience	<p><i>"As an Alcoholic/Drug addict, I do need rehab from time to time, or just Bury me at your expense!"</i></p> <p><i>"I work with people who rely exclusively on these services to help them deal with substance misuse issues. What does this reduction mean for the services?"</i></p>
They need more help not less	<p><i>"These people need help, not left floundering in public places."</i></p> <p><i>"I would say this issue would need more money not less- from observations of town centre and activity within drug and alcohol services."</i></p>

## Business Services

### Q3) Beach Team

**To create additional income generation from beach huts, including fees paid in specific locations and numbers of beach huts.**

This proposal is expected to generate income of £31,000 in 2018/19 and £20,000 in 2019/20.

*The Beaches Service would generate a surplus of £181,000 next year.*

<b>Knock on effect</b>	<p><i>"Increasing revenue from tourists will support other services that are necessary to ensure we care for the most vulnerable of our fellow residents."</i></p> <p><i>"An increased cost for beach huts may mean the take-up is reduced and they will become even shoddier in some places."</i></p>
<b>Ok to pay more</b>	<p><i>"If people can afford the luxury of a beach hut it is only right they should contribute in some way towards the economy of the town."</i></p> <p><i>"The beach huts are luxury items and so happy to pay more"</i></p>
<b>Revenue management</b>	<p><i>"If it generates a surplus then this should have a positive impact on all Torbay residents, as long as the surplus is distributed with the best interests of Torbay residents at heart."</i></p> <p><i>"As long as this is managed correctly through beach hut owners and their official committee members to ensure the extra income collected is put towards beach hut and beach management for the enjoyment of all."</i></p>
<b>Other</b>	<p><i>"Well done - something that will not affect the vulnerable or poor."</i></p>

There were 13 comments from people who did not support this proposal. A selection of comments which demonstrate the range of themes are shown below.

Theme	Examples of comments
<b>Costs enough / too much already</b>	<p><i>"I enjoy having a beach hut at Goodrington and do not want to have increased costs."</i></p> <p><i>"These huts are often beyond the income capabilities of most local residents which is a shame...."</i></p>
<b>Other</b>	<p><i>"There are no services or security provided to Beach Hut owners on many of the beaches especially Corbyn Head"</i></p> <p><i>"No more beach huts please. They are generally an eyesore and spoil the beauty of the bay. We have more than enough already...."</i></p>

## Q4) Economic Regeneration

To reduce the funding for Economic Regeneration.

This proposal is expected to save £50,000 in 2018/19.

*The proposed budget for next year would be £299,000.*

<b>Other funding</b>	<i>"We need more innovative solutions. These will not come from the Council, but need to be stimulated to come from the private sector"</i>
<b>Considered spending</b>	<i>"I live in Torbay so everything that effects this location effects everybody living in it. Regeneration needs to take place but if it happens slower and more focussed, then better improvements could take place."</i>
<b>Other</b>	<i>"What do we actually get for £299,000 per year? I don't see any economic regeneration in Brixham."  "Unsure if it will have an impact as I don't know enough about this subject."</i>
<b>Support the cut</b>	<i>"Economic regeneration affects us all and it is vital that Torbay continues to grow, however, we need to make savings so I agree to this cut."</i>

There were 83 comments from people who did not support this proposal. A selection of comments which demonstrate the range of themes are shown below.

Theme	Examples of comments
<p><b>Improve appearance</b></p>	<p><i>“As Torquinian born, just look at the place. No pride, no gleaming paint, no soul! Too many empty shops, reduce the rents/rates. Do something positive.”</i></p> <p><i>“Torbay’s high streets are already looking worn and tired with litter and mess all over. The last thing we need is less funding for regeneration, spending on this should be a priority.”</i></p> <p><i>“The bay needs regeneration, over the last few years it has started to look very tired, visitor numbers are down, we need to invest in plans &amp; schemes to allow the area to thrive again.”</i></p>
<p><b>Jobs / Economy / Business</b></p>	<p><i>“The further Economic Regeneration will affect anyone who wishes to live and work in Torbay. It is essential that investment is made to ensure that future economy of each of the towns in Torbay are invested in to ensure it remains an attractive place for new businesses.”</i></p> <p><i>“Torbay is in much need of economic regeneration, without it businesses will flounder which will decrease the council income from business rates and impact on us all.”</i></p> <p><i>“The area is going down the drain, needs as much money to be input for regeneration, to bring in the jobs that are going to be needed for all the new houses being built without it jobs will be poorly paid and will have to leave the area to get better paying work.”</i></p>
<p><b>Town Centres/Tourism</b></p>	<p><i>“Economic regeneration is a key target in getting the Bay to be attractive to business and tourism. There are too many areas in the Bay which urgently need to be developed”</i></p> <p><i>“More empty shops - less attractive for visitors, thus losing tourist income.”</i></p> <p><i>“Our High Street in Brixham is in a very sorry state and has been for some time. Every pound lost in an Economic Regeneration programme makes it that much harder to revitalise it and drive the standards back up for both the locals and our visitors.”</i></p>
<p><b>Impacts on everyone</b></p>	<p><i>“Anything that will reduce the regeneration of this deprived area of the UK will impact on its residents.”</i></p> <p><i>“This will impact on everyone in the bay. Our town is a run embarrassment that needs investment if we are to survive as a top holiday destination.”</i></p> <p><i>“Lower economic growth in what is already an economically deprived area will impact everyone! Economically and socially.”</i></p>
<p><b>Future decline</b></p>	<p><i>“Paignton is run down and unless there is investment in the town centre it will become one of those economically poor seaside towns that fail and tourists will not be attracted to. Much of the development is out of the town centre and therefore people aren’t attracted in. Crossways and Victoria Square in particular need economic regeneration.”</i></p> <p><i>“Regeneration is the key to income. If you build it, then they will come. Failure to invest is a really short sighted policy”</i></p>

Theme	Examples of comments
More investment needed	<i>"Torbay need economic regeneration badly. I see the towns deteriorating rapidly and regeneration needs MORE funding not less. Torbay especially Torquay and Paignton are not a nice places to live anymore. If things don't change and regeneration slumps which is already visible to everybody these towns will lose their residents and visitors which is already happening. STOP putting money into ridiculous ventures that don't work. Fast Ferry, Balloon, Torbay Palm etc. etc. you know what they are and invest in our town centres. Abbey Sands Development is the way forward. Torwood Street and The Pavilion development need to go ahead immediately so cutting this budget will have a detrimental effect"</i>
Other	<i>"Crazy short-termism"</i>  <i>"The local economy needs diversification"</i>  <i>"Not clear what this actually means but economic regeneration is surely about improving current situation. It's a relatively small budget as it is."</i>

## Community Services

### Q5) Events Development

**To reduce the Elected Mayor's Event budget.**

This proposal is expected to save £15,000 in 2018/19 and £15,000 in 2019/20.

*The funding has historically been used to support new events in Torbay and part fund the Air Show, Tall Ships, Hockey and Bowls Festivals etc. The proposed budget for next year would be £30,000.*

Theme	Examples of comments
<b>Non-Essential</b>	<p><i>"May reduce the number and scale of events, but would help reduce costs from a non-essential service."</i></p> <p><i>"This would seem to be a necessary saving, although the bay should encourage new events wherever possible."</i></p> <p><i>"What's the point of spending money on vanity projects at the expense of local people. Scrap this budget immediately."</i></p>
<b>Other</b>	<p><i>"Air show makes a loss and not too sure who gains from these events."</i></p> <p><i>"£30K should be sufficient and force the Council to be more prudent with their advertising budgets. However, I don't think such a small amount is that much of a problem in the grant scheme of things. However, an extra £5 on someone's individual Council Tax bill each month could determine whether some people can afford to switch the heating on this Winter, so it's good to put things in perspective."</i></p>
<b>Self / Private / Funding from elsewhere</b>	<p><i>"Private businesses should support events more."</i></p> <p><i>"These events should be self-financed or not be undertaken. Why should the community charge pay for these luxuries?"</i></p> <p><i>"We will all be impacted if the funding is cut for events but hopefully funds can be raised from elsewhere as it is hugely important to have events to draw people into Paignton. However this is a very small amount of money and could be raised elsewhere"</i></p>
<b>Make them better / more efficient</b>	<p><i>"The air show can make money through sponsorship (look at the air tattoo model) with more attractions on the ground, not funfair."</i></p> <p><i>"Attend the above events- but they need to be delivered more effectively and efficiently."</i></p>

There were 36 comments from people who did not support this proposal. A selection of comments which demonstrate the range of themes are shown below.

Theme	Examples of comments
<b>Valuable for attracting tourists / income</b>	<p><i>"Even less to attract visitor or things for the locals to enjoy"</i></p> <p><i>"It would reduce tourism and local expenditure. As a lifelong resident of Torbay I have seen the decline in tourism and its negative impact upon the bay. It means less shops, more unemployment, more benefit uptake"</i></p> <p><i>"This figure is a pittance. and all the place offers is tourism, so why shoot yourself in the foot?"</i></p>
<b>Good for locals / community</b>	<p><i>"I think The Grinagog festival was a really positive event in Torquay last year involving lots of community groups. It would be a shame if this could not continue"</i></p> <p><i>"Because a good way of giving something back to the locals"</i></p>
<b>Other</b>	<p><i>"Plenty of people enjoy these things"</i></p>

## Q6) Museums

To remove the grant funding to Torquay and Brixham Museums.

This proposal is expected to save £28,000 in 2018/19 and £27,000 in 2019/20.

*The proposed budget for next year would be £27,000.*

Other sources of funding	<i>"Brixham museum will have to charge for entry. It is free at the moment but it is a luxury we can pay for."</i> <i>"Visit the museums, but do not feel they need grant support. Alternative national arts and culture funding should be considered."</i>
Other	<i>"We go to the museum, but there's not a lot there. Perhaps a merge of both museums into one would be an option. Though it would be very sad to see them go."</i> <i>"While the museums are important there are other greater needs"</i>

There were 115 comments from people who did not support this proposal. A selection of comments which demonstrate the range of themes are shown below.

Theme	Examples of comments
Heritage / Culture	<i>"The Museum has nationally important collections concerning the Torbay area and its heritage. These cuts will have a negative impact on the stated aim of 'ensuring Torbay remains an attractive place to visit'. And they will significantly lessen the likelihood of the Museum attracting grant funding from external sources, not only for its exhibited artefacts but also its archival collections. These cuts threaten local heritage. The sense of the past and one's roots are vital for psychological well-being, and a sense of meaning. Their steady erosion is contributing to the huge increase in mental ill-health and breakdown in our Society today, and in cutting one service you are unleashing a flood of need that can only be met by local authorities - in other words you will find you are cutting off your nose to spite your face."</i>

Theme	Examples of comments
	<p><i>“The museum houses some nationally important items and archives. Brixham Museum offers similar historical context and is a good wet-weather attraction - something different from pirates and chips. Without such civilised and stimulating resources we are just a run-down seaside resort that has seen better days.”</i></p> <p><i>“.....The museums do have nationally important collections and they do attract visitors (like me) from other areas. If this was address and proper safeguarding checks were enforced these people would have a better chance of recovery and turning their lives around and people would feel safer when on foot in town, which in turn would encourage consumers. ## 5. Event Feedback

### Elected Mayor's Budget Event 2018/19 Budget Allocation Exercise

Sixteen people took part in the Budget distribution exercise at the Elected Mayor's Budget event on 16<sup>th</sup> November 2017. They were asked to allocate a percentage of Council revenue spending to each of the Targeted Actions of the Corporate Plan. Participants were given the figures for distribution of gross expenditure which is proposed for 2018/19. These figures assume a 4.99% increase in Council Tax from the proposal to increase by 1.99% and the addition of the Adult Social Care precept of 3%.

One participant chose to distribute a total budget which added up to less than 100%.

Six participants chose to distribute a total budget which added up to 100%.

Nine participants chose to distribute a total budget which added up to more than 100%.

#### Protecting all children and giving them the best start in life

##### **Proposed percentage of gross expenditure for 2018/19: 28%**

Of the 16 participants, five chose to maintain the figure of 28% proposed for this targeted action. This equates to 31.3% of participants.

Four (25%) increased the percentage allocation. One participant increased it to 40% of the revenue spending, the biggest increase from the group.
