## **Inglewood Outline Planning Application - Submission Roadmap**

The purpose of this document is to provide an overview of the document package that has been submitted in support of an application for outline planning permission on the site referred to as Inglewood, Brixham Road, Paignton.

As would be expected of a major planning application which constitutes EIA development, a large amount of technical and design work has been undertaken in support of the application. In addition, due to the location of the site, there are a number of known sensitivities that have required detailed assessment and consideration of how mitigation could work in the final scheme.

The tables below serve two specific functions: the first sets out the key documents which have been submitted and overviews the issues covered; the second considers particular key matters that will be considered during determination of the application and outlines the specific documents where detail can be found.
