

# ROAD TRAFFIC REGULATION ACT 1984

## SECTION 9

### BOROUGH OF TORBAY (School Road - Brixham)

#### (Prohibition of Driving except Authorised vehicles (School street)) EXPERIMENTAL ORDER 2023

Torbay Council in exercise of its powers under section 9 (and any other enabling powers) of the Road Traffic Regulation Act 1984 and of all the other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act make the following Order:

1. This order shall come into operation on the 29<sup>th</sup> March 2023
2. In this Order:-

A reference to an article or schedule refers to the corresponding article or schedule in this order unless stated and the following expressions have meanings hereby respectively assigned to them:-

  - (i) "pedal cycle" means a pedal bicycle or pedal tricycle not being in either case a motor vehicle.
  - (ii) "steward" means any duly authorised person (school staff, council officer or uniformed Police Constable)
3. Save as provided in Article 4 of this Order no person shall, except upon the direction of a duly authorised member of school staff (Furzeham Primary school), Police Constable in uniform or duly authorised Council Officer cause or permit any vehicle or motorcycle to-
  - (a) Proceed in the length of road specified in Schedule 1 within the times and days specified.
  - (b) Enter the road in contravention of the order in Schedule 1
4. Nothing in Article 3 shall apply to prevent any person causing any vehicle to proceed in the length of roads specified if the vehicle is being used :-
  - (a) For pedal cycles.
  - (b) For fire brigade, ambulance or police purposes
  - (c) In the service of a Local Authority in pursuance of statutory powers or duties
  - (d) In connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstructions to

traffic, maintenance, improvement or reconstruction, or in connection with statutory undertaker plant or equipment.

(e) For residential access to properties on School Road solely accessible from this road.

(f) For access to residential properties or the care home as agreed with the steward on site at the time.

5. This order may be cited as the BOROUGH OF TORBAY (School Road - Brixham) (Prohibition of Driving except Authorised vehicles (School street)) EXPERIMENTAL ORDER 2023

Mondays to Fridays in Term Time 8.30am - 9.15am and 3.00pm – 3.30pm**
