Thanks for your recent email letting us know about the future plans in Torbay. I am happy to confirm Always Be Cycling's support for Torbay Council's LSTF Revenue bid for 2015/16 to the Department for Transport.

We would gladly contribute to this initiative in the form of several practical do-it-ourselves bike mechanic courses for absolute beginners upwards. We would welcome the opportunity for our instructors to work alongside the project delivery team and Torbay Council as an essential link between the core initiatives to promote and encourage more cycling throughout the project.

This work will expand upon the success of the community-level workshops we have been facilitating in South Devon, Torbay and Teignbridge since 2010. To date we have trained approximately 540 people through 90 workshops and several public events.

Our work aims to demystify cycle mechanics and disseminate commonly owned skills and knowledges through local communities and neighbourhoods. Participants learn how to perform routine maintenance and repair procedure from simple "roadside repairs" to more technical workshop maintenance techniques. This has proved key in building confidence in many cyclists to cycle more and more often. Our workshops provide open access to specialist and otherwise expensive tools and assisted many, especially those on low-incomes, to overcome one of the major barriers to cycling: the cost of professional repair and maintenance. From our experience and feedback given to us by past participants, these workshops have enabled many people to start cycling on a regular basis instead of using their cars.

Torbay 2015/16 LSTF Bid

Dear Sally,

Devon County Council is pleased to support Torbay's bid for LSTF revenue funding. The bid will strongly complement the joint work that both authorities are doing together building on the joint Local Transport Plan effective to 2026. Many residents in Torbay and the surrounding Teignbridge and South Hams areas cross the border between the authorities on a daily basis and rely on a seamless journey experience. Tourists and visitors to the area will also benefit from a consistent approach and improvement to networks.

We are particularly working together on the bus real time information system, Devon [rail] Metro and on strategies for the A380 and A385 corridors to Newton Abbot and Totnes respectively. This approach is essential to accommodate future growth plans across the area.

Access improvements to Torbay hospital are welcomed given that the hospital serves a large part of South Devon as well as Torbay. This will complement the Devon Metro and A380 corridor strategies.

Multi-modal smartcards will complement the joint bus real time information system and offer opportunities for cross border journeys to destinations such as Totnes and Newton Abbot, complementing similar work on new products in the Devon area.

Many school children from Devon attend school in Torbay so improved access to these facilities will be of particular benefit.

The authorities are working together on cross border cycle connections, particularly the A380 Kingskerswell corridor to take advantage of the opportunities created by the South Devon Link Road. The emphasis on cycle training is therefore welcome.
