Rachel Geary presented on some of the good news stories throughout 2024 and thanked all partners for their ongoing action across Torbay.

7. Climate Resilience Update

Dave Stewart, Flood Risk Manager for Torbay Council and Mehdi Khoury from the University of Exeter presented on a new opportunity to develop a serious, community focussed, climate resilience game. The aim of the game is to help communities understand complex cascading impacts that arise from a changing climate and what they can do to better protect their communities.

The TCP were happy to support development of the game. Mehdi will set up a meeting for those interested in 2025. **Action: Medhi/ Dave to set up meeting**

Melanie Boarder stated that the Geopark would be very interested, and the game may be of interest to all Geoparks.

Emily Reed said that the regional Climate Impact Group (CIG) would also be interested. **Action: Emily to engage with the CIG.**

Due to time, Item 4 was not discussed. The TCP were asked to note the progress as outlined in the report.

Item 5. 2025 Forward Plan

Rachel Geary facilitated a set of discussions aimed at getting the TCP to prioritise areas for the forthcoming meetings in 2025 to focus on.

Chris Gunson summarised recent work happening. Including:

- Energy Audit completed and shutters being installed
- Tailblazers are creating a walled garden and raised beds for local growing schemes
- Aspiration to be a Net Zero Hub

- Cycle repair shop
- Forest School is operational
- · Renovating the House and making it watertight
- Exeter Community Energy are moving in and will run their Pulse Hub from the House.

8. Roundtable updates / AOB

Exeter Community won 2 awards at the National Community Energy Awards. They continue to deliver support in Torbay. Their community grant fund is now open.

Bethan Huntley attended South Devon College's Freshers Week.

Rachel Geary is exploring a series of engagement sessions for 2025

Gary Calland(GC) is installing ground source heat pumps and will be planting 30,000 tress in 2025. David Edmondson expressed an interest in the Place Directorate of the Council volunteering to help plant these trees. **Action: DE and GC to discuss this.**

Steve Nash is really happy to be part of the TCP. Recently installed 5 Seagrass interpretation boards across Torbay.

Keving Dixon inspired the group with an idea to promote the New Union Square redevelopment as a radically improved, high-quality, European-style, high density, geopark themed space.

Councillor Fox update the TCP on the working being carried out to develop a new Torbay Local Plan. Meeting new housing targets and balancing environmental issues will be challenging. More to follow in 2025
