Torbay's Local Offer site continues to grow. Organisations recently adding information include Community Nursing, Health Visiting, CAMHS, Children's Learning Disability Team and Ethnic Minority Achievement Service.

#### Keeping the Local Offer under review

Local authorities must engage young people directly in developing and reviewing the Local Offer and should consider setting up a forum, or a range of forums, to do so. Local authorities should make every effort to engage a cross-section of young people with a range of SEN and disabilities, in a variety of settings and circumstances and at different ages within the 16-25 age range. Local authorities should make every effort to establish the issues on which young people most want to be engaged. They should also consider using a variety of methods to engage young people. These could include surveys and social media or young people's forums, and making existing consultation groups, such as a local youth council, accessible to young people with SEN or disabilities. Young people should also have opportunities to be engaged independently of their parents -SEND Code of Practice (4.11)

To strengthen this approach in Torbay, we are building on the initial multi agency and Parent Participation Forum group work, with the actions below:

a) Gathering ongoing feedback from the Local Offer contact forms.

b) 6 months development survey for young people, parents and professionals

c) Setting up user groups to provide guidance and make decisions on the direction and format of the local offer

d) Links to Healthwatch 'Rate & Review' included on every page of the Local Offer

#### **User groups**

We want to build links with parents and young people's groups, members of the SEND team and the Family Information Service, to try and make sure that the Local Offer meets the needs of Torbay families. #### How will the feedback be used?

Common themes gathered from these different routes will be raised at the SEND Operational Leads group which meets every half term. responses will be made available on the Local Offer itself, and summarised within the SEND newsletters.

## **Torbay SEN: Figures**

Since September 2014 the SEN team has been working on the task of converting the 900 statements of SEN to Education, Health and Care plans (EHCPs). The team has until April 2018 to complete all of the conversions.

#### **Conversions from Statements to EHCPs**

- 298 Our target number of conversations for this school year
- 100 statements have been converted to EHCPs since September 2014
- 14 weeks the amount of time to convert to an EHCP following an annual review

Alongside the conversion process, the SEN team is responsible for reviewing new requests for statutory assessments and if approved, completing the assessment process and issuing an Education Health and Care plan.

#### New requests for statutory assessment

(Figures acurate as of March 25th)

- 96 requests for statutory assessment have been received since September 2014.
- 12 requests for assessments agreed and EHCPs issued
- 64 requests for assessments agreed and EHCPs in progress
- 3 requests for assessments agreed but family left the area
- **5** requests for assessment turned down
- 12 decisions pending on whether to proceed with assessment
- 20 weeks the statutory period to complete a request for assessment and issue an EHCP

#### **SEND Operational Leads**

The SEND Operational Leads group has been set up to bring together partners from health, clinical commissioning, children's & adults' social care and education to ensure that the statutory duties outlined in the SEND Code of Practice are in place and work effectively to the benefit of children/young people with SEND.

The primary areas of focus are as follows:-

- Developing systems which focus on the child/young person and promote effective joint working
- Building links that will improve transitions from children's to adult's services
- Improving information sharing between individuals, agencies and families
- Identifying gaps in service provision for children/young people and their families
- Contributing to the development of personal budgets for Education, Health and Care plans
- Raising awareness of the impact of the SEND reforms amongst each agency and identify training requirements
- Sharing information relating to changes in legislation and putting actions in place to ensure duties are met
- Performing the function of a Project Board for all SEND work

The group meets every 6 weeks and reports into the Health & Wellbeing Board.

## **Mental Capacity Act Training**

The right of young people to make a decision is subject to their capacity to do so as set out in the Mental Capacity Act 2005. The underlying principle of the Act is to ensure that those who lack capacity are empowered to make as many decisions for themselves as possible and that any decision made or action taken on their behalf is done so in their best interests. Decisions about mental capacity are made on an individual basis, and may vary according to the nature of the decision. Someone who may lack capacity to make a decision in one area of their life may be able to do so in another -SEND Code of Practice (8.19). A course is planned for May 20th which is aimed at professionals who will/may take part in the EHC assessment and planning process. The aim of the session is to ensure professionals have an understanding of the statutory duties and their responsibilities, to allow them to support families effectively.

The course will include:

- An overview of the Mental Capacity Act 2005
- Statutory Key Principles
- Assessment of capacity
- Best Interest decision making
- Independent Mental Capacity Advocates
- Implications for professional practice

## Personal Budgets pilot

The SEND team is currently working with partners to develop options for services that may be accessed using a personal budget.

The team are seeking out individual families to explore the option of accessing the element 3 'top up' funding as a personal budget and to discuss with their child's schools any possibilities for the school or college releasing funding to also be used as a personal budget, to meet the needs of the child / young person.

The objectives of this approach are as follows:

- Create guidance as to how a personal budget could be used to meet the needs of a child / young person with an Education, Health and Care Plan.
- Identify services to achieve outcomes differently in line with parents' / young person's wishes
- Create case study examples of how personal budgets have been used successfully to meet a young person's agreed outcomes and to share this as good practice.
- Make specific recommendations for improvements to the EHCP process

Since starting the pilot on 29th Jan, the team has started to work with 3 families to explore the options open to them. Early indications are that Personal Budgets could be used in some circumstances to support the transition between primary to secondary school for children.

## **Information sharing**

The SEND Code of Practice says that Local Authorities and their partners must work together to develop systems for the effect sharing of information which addresses confidentiality, consent and security.

An information sharing agreement based on work by Plymouth City Council has been drafted to reinforce existing practices, with the following aims:

- Sharing information which supports the provision of better services to our service users and communities, and improves the design of a service.
- Ensuring that information is shared safely and securely.
- Ensuring that in sharing information:
  - There is a clearly defined requirement,
  - It accords with the Data Protection Act 1998 and other applicable legislation and is otherwise lawful,
  - Only appropriate information is shared,
  - It is in the interests of service users and communities.
- Putting in place governance that ensures that managers and staff are aware of their responsibilities and recognise the need to work with partners.

#### **Patient Knows Best pilot**

PKB is an electronic patient controlled record, used in health to help patients better manage their care. It allows the user to work online with the people involved in providing their support. The patient can decide who can access their information and gives them the option of communicating directly with anyone who they have included in their group. Anyone with an email address can have an account and the site can be accessed using devices such as iphones and ipads.

A pilot is being planned to see if this system could be adapted to support the information sharing that is fundamental to the Education, Health and Care plan assessment. For further information regarding PKB please visit *www.patientsknowbest.co.uk* 

## **Transitions work**

Staff from Adult Services, the Children's Disability Team, Special Educational Needs and the Integrated Youth Support Services are creating a guide which will set out how the move to adult services can be made more supportive for the families and the professionals involved. The areas that will be covered are:-

- Understanding who has the right to make decisions
- Creating realistic expectations for families
- Giving more clarity about budgets to meet needs
- Defining what information is needed and when
- Ensuring information that is shared is used
- Mapping and sharing a pathway with families and professionals

The group will work with the Parent Participation forum to ensure that any new pathway takes into account the views of parents and young people.
