I have been informed that there is a proposal to build 70 homes on this site.

I strongly object to such an ill conceived plan.

**Traffic Issues**

Moor Lane is already a well used access route and suffers from traffic congestion. The development of Mayfield School and the other schools in the immediate vicinity have already caused a significant impact on the area and any further increase in traffic would hardly be advisable. The only real solution to the problem is to ban parking on Moor Lane, Steps Lane and Brunel Avenue. Ensure that all employees and visitors to the local schools are able to park onsite. The local council could insist that the developer makes a large financial contribution to ensure that they are able to. Why you allowed Mayfield school 's visitors and employees to use Steps Lane as their work place car park seems very unjust to me as a local resident. One incident involving an inconsiderate employee blocking Steps Lane two days in a row springs to mind.

**Impact on the landscape**

Obviously detrimental impact on the landscape. People do not retire to Torquay to look at the volume of houses !

**Recreational amenity**

I have brought up my family here. Walked my dog there. Played with my children when they were young. It would be very sad to see the last bit of open space be lost to the developer for ever.

In my experience it is much harder to preserve and improve the facilities that we have rather than sell them off and cash them in.

We as a nation let alone a local community we have lost our way !

The words are written as a 58 year old male who has had a long working life involved in business. Torbay Local Plan - Re policies *SS11 Housing* and *SDT4 Babbacombe & St. Marychurch*. - Steps Cross Playing Field

We wish to vigorously object to the proposals to build 70 dwellings on Steps Cross Playing Field, Watcombe, Torquay. We have three key reasons.

Impact on the landscape – We are concerned that this is a very open location where there is limited opportunity for screening these dwellings. The field is on the edge of Torquay and will only increase the urban creep of Torquay into the Countryside. It will have a major negative impact at the location on the landscape.

Severe impact on traffic in the neighbourhood. – The area is a quiet residential neighbourhood that suffers from traffic problems caused by the Three schools located on Moor Lane. There are major problems in this community at the time of schools opening and closing. We have liaised with the schools to tackle some of the problems but we continue to receive concerns from local residents about the impact the schools have on local highways. Such a development will only make this problem worse.

Los of recreational amenity. – There is much informal use of this green space by the local community. Dog walkers and children use the green space heavily. We are surprised that this site has been proposed by the Council as it features as a sporting resource for improvement in the sports and playing pitch strategy that was only signed of by the council in recent weeks. As ward Councillors we are aware the both the Babbacombe Corinthians and Watcombe Wanders football clubs have been promised this facility to be improved for their clubs use. We feel the Council is not serious about housing allocations at this location as it is one of the few locations where football facilities can be improved in Torbay.

We have just been handed a copy of the letter addressed to Residents in the Moor Lane area - we wish to record our profound objection to the proposal to allocate land for development at Steps Cross Playing Fields, Moor Lane, our objections are as follows;

1. The exit of Moor Lane onto the A379 highway is dangerous for many reasons - there are several schools in the area and the highway is already busy, more traffic turning onto the highway would make things even more dangerous for children and other pedestrians.

I must raise a number of objections to the proposed development of the Steps Cross playing field. We may or may not need more housing in the bay, that is a matter of opinion. What is a certainty is that the loss of Steps cross playing fields as a local recreational facility would be catastrophic for the immediate area. There is also the lack of supporting infrastructure, specifically roads. The coast road to Shaldon is uncomfortably busy at times and the milber road is totally inadequate for the volume of traffic it is having to carry. From the area in question the bypass is of no significant benefit as Moore Lane and Barchington Road would effectively become a rat run despite the dangerous traffic calming on Moor Lane. If the traffic calming were to be removed in total the situation re a rat run with or without additional housing would be infinitely worse and the Mayfield School and Steps Cross primary/infants school position re child safety would be infinitely worse. There is also the lack of suitable parking, without causing significant obstruction to the flow of traffic, when there are activities on the playing fields or at delivery and pickup times for the schools. The only way this proposed development should be allowed to go ahead is if the coast road to Shaldon were to be improved very significantly. 

The impact of this development on the local landscape would be horrific, and it would be criminal to lose this vital recreational area which is used regularly by a good proportion of the local population for playing sports and walking dogs. If this field were to be lost the only recreational fields nearby are on the other side of a very busy and dangerous main road, which would put lives at risk.

One of my strongest objections is because of the impact that such a development would have on the already nightmarish traffic situation in the neighbourhood. As local residents, Torquay born and bred, we are absolutely shocked and saddened that our Council would even consider building 70 houses on our local playing field. We have so many objections but list the following:

- The loss of such a pleasant green field within the Watcombe district
- Older people derive a lot of pleasure from having this facility and enjoy sitting on the seats to admire the view and have the opportunity to engage in conversation with other local residents.
- Loss of provision for children to play. So many children enjoy football and other ball games with their friends or parents here.
- Loss of the swings, slide etc for younger children - there are no other parks nearby
- Local residents enjoy this safe open space for dog walking, which has the doggy bins provided. Where would they go? If dogs were walked on other areas without bins - the mess arising does not bear thinking about.
- Already have 3 schools in the district, Combe Pafford, Watcombe and Mayfield - these already cause a problem to local residents with the volume of traffic and parking problems - even more cars would exacerbate the problem and would the children from these houses have enough spaces provided at these schools - which are already heavily subscribed.
- Moor Lane is already a "rat run" and yet more cars would be entering the road from this field. 70 houses would probably mean 140 cars.
- We already have cars running across the pavements to miss oncoming cars. The bollard on the grass verge has been destroyed by a car running across the grass and has not been replaced.
- If you speak to people in the area, they can confirm we have seen lots of "near misses" - people driving at 50mp to get to the other end, before oncoming cars! Another unbelievable mess.
- With plans to put double yellow lines on Moor Lane and Steps Lane, we wonder where the cars will be going. Last week there were 50 cars regularly parked along these roads - where do you have plans for them to park.
- If you go ahead with the building of these proposed houses, they will probably have these same cars parking on their streets.
- If the council go forward with these unbelievable proposals, the wishes of all the local residents will have been ignored.
- This is a great community facility loss and in 2015, community is vital and should be nurtured not destroyed - we would have hoped that our council would be there supporting our needs.
- We are lucky to have been told about these proposals, but we have already spoken to several people who have no idea of your plans - if you were to speak to them, they would definitely agree with the above.
- 70 Houses with probably at least 140 residents who will not only require schools, but all the other services, which are already oversubscribed. Our infrastructure is already saturated - what plans have you have to alleviate that.

Please also convey our concerns about the future plans for double yellow lines in Moor Lane and Steps Lane. Consideration should be given to providing more parking space at the schools. This is a very child and OAP centred community and poor parking can cause inevitable dangers - especially at the crossroads - there are accidents waiting to happen and your council should be aware and giving the whole process serious thought. We do hope that you will read and take our concerns into account and we trust there will be a positive outcome for all the local residents.

I wish to record my objection to the proposal listed in the Schedule of Proposed Main Modifications to the Local Plan relating to the development of Steps Cross Playing Fields.

My concerns are based on the impact the construction of 70 properties on this valuable green space will have on the local landscape, environment and traffic density.

The proposal is undoubtedly counter to current planning policies, created to protect the landscape and environment of the playing fields and other named Urban Landscape Protection Areas (ULPAs) within Torbay.

The March 2013 Review of Urban Landscape Protection Areas in Torbay established that 'The space [Steps Cross Playing Fields] is important in providing a green break in an otherwise built up area'.

**Policy C5, covering ULPAs**, states that:

'Development within Urban Landscape Protection Areas (ULPAs), as shown on the Policies Map, will only be permitted where:

1. it does not undermine the value of the ULPA as an open or landscaped feature within the urban area; and
2. it makes a positive contribution to the urban environment and enhances the landscape character of the ULPA.'

It is clearly the case that the construction of 70 houses on the playing fields would contravene these requirements.

Other policies reinforce the value of maintaining our green areas and developing brownfield and town centre sites. **Policy SDT4 for Babbacombe and St Marychurch**, states that 'Green infrastructure will provide improved access from urban to coastline and countryside areas as well as areas for recreation...' and at 5.1.3.2 'Major residential developments will be limited to suitable brownfield sites that may arise through the Plan period, or are brought forward through the neighbourhood planning process.' This is supported by **Policy SS11 on Housing**, which sets out that the 'Housing provision will focus upon a sustainable pattern of distribution throughout the Bay, with an emphasis upon the regeneration of brownfield sites and town centre sites, and development of urban sites.'

- the traffic in this area is already horrendous since the modification of Steps Cross and Combe Pafford schools. During school drop of times there is too much traffic for the road, and getting out on to the main Teignmouth / Torquay road is awful. Just driving down the road from the Teignmouth road to the bottom of Padacre Road is awful, due to the traffic calming and the car parking. Increasing the vehicles in this area will just make things worse. Even outside of the school times it is not good, and the traffic queues up passed the school.

With reference to the latest version of the Torbay Local Plan, **I wish to strongly object** to the proposal to allocate the land at Steps Cross playing field for housing development. I refer to policies SS11 Housing and SDT4 Babbacombe & St Marychurch.

The reasons for my objection are as follows:

**Impact on the Landscape:** this land borders the main A379 road from Teignmouth to Torquay: as such, it forms part of an 'green entry corridor' to Torquay that is seen by many tourists entering the town. As such, its loss would adversely impact the current landscape, which in turn forms a buffer with the housing estate inland. As a director of the Brunel in Torbay Trust in the late 1980s / early 1990s, I assisted Torbay Council's various successful attempts (at their request) to preclude development in this area for precisely this reason, so it is clearly something that Torbay Council felt at that time to be a very important issue. The listed parkland at Brunel Woods is in very close proximity to this site and the proposed high-density housing development would consequently have an adverse impact on the overall landscape, which has been deemed by a number of authorities to be of great importance.

**Loss of a Recreational Amenity:** the playing field at Steps Cross is an important area of open land, the only one that is available to residents in the adjoining Watcombe Park area without their needing to travel considerably further to the king George V playing fields and also having to cross the busy A379 road. It is used by all groups in the community on a continuous basis; I regularly see, for instance, groups of children playing together and using their bicycles, dog walkers (many of whom are elderly and consequently are unable to use the rougher and more hilly alternatives in the area), model aircraft and helicopter enthusiasts, and individuals who simply enjoy sitting on the benches around the border.

**Loss of a Wildlife Habitat:** as well as the obvious detrimental impact of a loss of an undeveloped area to wildlife, the playing field's south-western facing border is lined by two rows of beech trees, which are mature but still young enough to remain in place for many years to come. Such trees provide a haven for all manner of wildlife, which would naturally be affected by the potential loss of these trees.

**Impact on Traffic in the immediate Neighbourhood:** The three schools that are sited very close (one adjoining, one next to it, and the third directly opposite) to these playing fields create an inordinately large amount of vehicle traffic on the adjoining road (Moor Lane), which is already considered by local residents to present a hazard to both children entering and leaving those schools, plus those using the road. On any school day, the entire adjoining length of Moor Lane is lined on both sides by the parked cars of those of who work at the schools and parents delivering and collecting their children, to the extent that traffic can only pass in one direction at a time (a situation not helped by the three traffic-calming chicanes). At the beginning and end of the school day the situation is infinitely worse; long delays occur, tempers become frayed, and on frequent occasions there have been impacts between vehicles. Most local residents now try to avoid using this road on a school day at these times, but many non-local drivers wish to use the road as a convenient way of travelling between between the A379 and the St Marychurch Road through Barton, which in turns provides access to the Willows shopping area, Torbay Hospital and the ring road to Paignton. A proposal such as this one would add very considerably to the traffic density on Moor Lane, most particularly at its busiest times, and will I feel prove to add to what is already a potentially dangerous situation.

I wish to object to the proposal to include Steps Cross playing field in the Local Plan as a site for 70 new homes. My objections are:

1. Steps Cross playing field is an important amenity to residents of Torbay. It is used by a large number of local residents for exercise and enjoyment. A considerable investment has been made recently by the Council in new changing rooms. To reach the KGV playing fields pedestrians must cross the busy A379.
2. Moor Lane, the proposed access for the development, is already severely overloaded in terms of traffic and parked vehicles. The close proximity of three schools ensures very heavy traffic at certain times of day. The lack of on-site parking at Mayfield School results in an excess of on-street parking reducing the highway to one lane for a considerable distance. The road also forms the main route from the A379 to The Willows, again increasing the flow of traffic.
3. This is the entrance to Torquay and Torbay from the Exeter/Teignmouth direction. Cramming 70 dwellings onto this site would destroy the open, green, and welcoming route which is currently in place all the way to St Marychurch. Torbay is a tourist destination and building here would damage the beauty of the town.
4. The playing field is an important local open space and asset. If lost it can never be reclaimed. If it is judged that it is not required for the local residents (which would be a big mistake) then it should be utilised as green space for the local schools (not forgetting that half of the original Steps Cross School (now Mayfield School) playing fields were sold off for housing by DCC some years ago), with access for local residents outside of school hours.



We would like to raise our objections to the proposed development of the Steps Cross Playing Field's, Moor Lane, Torquay. When we bought our property in Brunel Avenue one of the attractions was the quiet area & access to open space. Our objections are based around the following concerns:

- \* Severe Impact on Traffic Flow – Moor Lane has increasingly become a “rat run” over the past few years, measures taken to calm traffic have in fact made it worse. We have noticed a considerable difference since September, when council transport policies forstedamented students changed; there are now more parents dropping their children to school. There are three ever growing schools on Moor Lane; traffic at peak times is awful. The construction of 70 new dwellings on the site, if you take that most households now have two cars, means an increase of 140 cars using Moor Lane. It's an accident waiting to happen!

- Parking – this has become an increasing problem on Moor Lane & the surrounding area. If plans go ahead to yellow line Moor Lane properties in the surrounding roads including any new development will be horrendous.

Moor Lane, Steps Lane and Brunel Avenue are like an NCP car park and trying to negotiate those roads is almost impossible for ordinary cars let alone lorries, and emergency service vehicles. Cars park right on the corner of Steps Lane/Brunel Avenue and trying to get from Brunel into Steps Lane it is a complete blind spot.

How will all the extra traffic from 70 new homes be accommodated and where will the access be onto Moor Lane or Teignmouth Road? 

The proposed planning for homes to be built on the playing field at Steps Cross is I feel a wrong usage for this area.

My reasons are in line with the three reasons outlined in the letter from our councillors and highlighted by our MP Mr Adrian Sanders in his latest communication. These being;

- \*Severe impact on traffic in the neighbourhood. [This being the most important factor]
- \*Loss of recreational amenity.
- \*Impact on the landscape.

I would add to this the danger to the children in the local schools particularly when the mini buses, taxis and private vehicles bring the pupils in the morning and around 3pm when they all return home.

Traffic would face difficulty in getting on to the main Torquay to Teignmouth road with Torquay bound vehicles being forced to back up whilst motorists attempted to turn in to Moor Lane. The bends on the road in that area are already dangerous.

Staff cars parked in the location are already a massive problem during school time and this will be extended further into the Watcombe Park Estate when the planned alterations to reduce parking areas are implemented. These cars are frequently driven too fast up Brunel Avenue and into Froude Avenue by the staff members on leaving or going to work.

Local residents were advised that the reason for a relatively small parking area when Mayfield School was built was to encourage staff to car share. This obviously does not work. We encounter cars parked dangerously at the junction of Brunel Avenue and Steps Lane, whilst local residents cannot get their cars in and out least of all park their own cars on the road.

The recreational area is under used and I suspect that alternative uses are in the minds of the planners. In view of the traffic hazards already in existence I would suggest that provision of a parking area for the use of the schools [and this could be used by the primary school in Moor Lane also] would be a far better use of the area.

Dear Sir/Madam I wish to raise my objection to the above proposal to allocate the green fields site at Steps Cross playing field, Moor Lane Torquay to allow the building of homes on this valuable recreational facility.

My reasons are as follows:

There is already an issue with car parking in the area. Three large & ever expanding schools are on neighbouring sites. two of which are for children with learning difficulties or health problems which means that there are many more 1 to 1 teacher/pupil ratios, which obviously means that more room is needed for parking. The side roads are already clogged with cars & coupled with the poor road planning in the area (the speed reducing chicanes do not work, in fact they make the area more dangerous). More Houses will require more parking, in some cases, if not most there is a potential for at least 2 cars per family/household.

The schools are fed by a constant flow of disabled transport/taxis, which puts a lot more traffic in the area at busy work times, coupled with the fact that they have to come back at end of school earlier to get parked, let alone finding spaces for the parents. This is a lovely enclosed park which people can enjoy, dog walkers use it regularly (of which I am one), the swings are still there but after a number of years of poor maintenance & funding the council has gradually let the previously enclosed secure childrens area & play facility become run down. I wonder if this is all part of their agenda? Where else locally is there a park for the young children to play locally without crossing what is the very busy Teignmouth Road to get to King George IV playing fields? The football goals are regularly used by young children & parents & whilst there might not be organised matches on site, it does allow for parents to interact with the children- sadly there isn't enough time for this now. This is too valuable an asset to lose.

We do not have the room within the schools to take that many new pupils. Watcombe School cannot expand any further unless their playing field is taken away. Contrary to Government policy on encouraging sport in schools.

The Council has already sold land behind Mayfield School to housing when with a little more vision they should have realised the local issue with regards to parking.

The new development will no doubt include a mix of Social Housing. Whilst I recognise that there is a need for this type of Housing, who controls the residents- there is no local Police presence, I think in the 20 years I have lived here, I have only seen 2 Police Officers on 'the beat'. This is a lovely part of Torquay, well looked after & I do not believe that this will add to the area.







Having 2 disabled schools, traffic is already pushed to a maximum, with parents and carers dropping off and picking up children, and causes a bottleneck at the main junction. They would ruin the natural landscape currently enjoyed by homeowners, not to mention the loss of recreational amenities for many people.

I request the above is taken into consideration when making a decision.

**Traffic Impact**

Moor Lane is already subject to traffic calming due to the access requirement of the three schools and nursery unit which severely impacts local traffic at least twice a day. Moor Lane also exits on to A379 ,Teignmouth Road, the junction with Moor Lane, which is also used heavily, at peak times especially. The access to a housing development from either Moor Lane or the A379 would cause further major traffic issues, ie accidents or severe congestion.

I would like to formally register my opposition to the proposed allocation of land for development at Steps Cross Playing Fields, Moor Lane, Torquay.

The field is a low-height facility, used by many, but does not impact negatively on the general landscape. In fact, it does the opposite- it adds to the overall charm and beauty of the area. From a distance it is often only noticed by the treeline, as it looks like one complete area of green taking in the fields on the other side of Teignmouth Road. A development of houses would be at least as high as the trees, if not higher.

There are already traffic difficulties on Moor Lane, partly due to the co-location of three schools in a residential area. Parking for those staff is obviously totally inadequate as they clog the road, Monday to Friday, 8am to 4.30pm. This also adds congestion near the "traffic- calming" sites. Perhaps this narrow road should have double yellow lines, as it links various parts of the town? Adding more traffic (properties) would seem counter intuitive!

I guess we are talking about 70 properties of no architectural value whatsoever, but all of which would pay council tax, so this is probably the prime motivator.

I do not accept the current view of housing needs as there is no reliable evidence for this. Council or Housing Authority lists are not reliable as they are not updated, not accurate therefore or verifiable. A potential listing could have found housing the next day, names could be duplicated on neighbouring authority lists. How much demand is for second homes? How would you know if it was for second home use? What stops "affordable" houses being sold as a second home?

The field is used by many including children using the poorly maintained swings etc area, footballers, dog walkers, families enjoying the open space and greenery, infirm residents who can only walk a short distance to enjoy the outdoors.

May I suggest you try to use, again, the unused floors above all the shops in Union Street, plus the old laundry site in the town centre - maybe you could use the green spaces around millionaire's row instead? That would bring in some council tax!
